After detailed discussion of query response in 289st SEIAA meeting dtd. 04.02.2016 and recommendation of 263rd SEAC meeting dtd. 11.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from State Highway as a "no mining zone". The demarcation should be done by the Revenue and Forest Officials in the presence of Mining Officer, Mandla.
- (iv) No crusher shall be allowed within the lease area and should be 500 m. from the road.
- (v) The entire area shall be fenced first before starting the mining activity and three rows of plantation should be done towards the road and forest side.




