- (1) The case was discussed in 12th SEAC - II meeting dtd 10.03.2016 and it was recorded that

"The case was earlier presented by PP and their consultant in the 11th SEAC-II meeting dated 09/03/2016 wherein it was observed that as per the Google image based on the co-ordinate provided by the PP that more than 50% of the mining lease area is still in water and mid stream mining is not allowed. PP was asked to provide the basis of reserve estimation of 40,000 cum/year when approximately 50% of the mining lease area is submerged in the water along with the last 05 years details of sand evacuation and also the copy of recent order passed by the Hon'ble NGT which is related to this site. PP asked that they may be given a day time for providing necessary details. Committee asked PP to come with the above details either tomorrow (i.e. on 10/03/2015) or any other subsequent meetings of SEAC with desired details.

PP alongwith their consultant came for the presentation and submitted the desired information before the committee vide their letter dated 10/03/2016. PP submitted that they have reassessed the sand reserve and as per revised assessment the sand reserve comes to 29,767 cum/year.

On the basis of above committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':

- Production of Sand as per mine plan with quantity not exceeding 29,767 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 50 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapra) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining."

(2) It was noted that the inter-state boundary, National Park/Sanctuary are not located within 10 Km. radius. Hence, the **General Condition is not attracted.**

(3) PP has submitted the replenishment plan duly approved by the Regional Head, Directorate of Geology & Mining, Regional Office, Jabalpur (vide letter dtd 17.02.2016).

(4) The production of sand for the last five years submitted by OIC, M.P. State Mining Corporation, Jabalpur is as under :-

The present production envisaged is 29767 cum/year from an area of 8.41 ha., whereas during the last year the annual production was 33163 cum/year, it could be safely inferred from the above table that the rate of annual replenishment would be enough to sustain a production of 29767 cum/year from 8.41 ha.
