### A. POLICY DECISION WITH REFERENCE TO THE MOEF & CC OM 15.03.2016

MoEF & CC Govt. of India has issued instructions to respective SEIAAs that cases which have been recommended by SEAC should be processed at SEIAA level for purposes of granting ECs. Those cases which are pending at SEAC level and the committee has not made any recommendation should be transferred to respective DEIAAs. As per the policy decision the following cases are hereby transferred to the respective DEIAAs.



After detailed discussion and perusal of query response in 283<sup>th</sup> SEIAA meeting dtd. 22.01.2016 and recommendation in 255<sup>th</sup> SEAC meeting dtd. 02.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per approved mining plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 250m. from the forest boundary as a "no mining zone" The site demarcation should be done in the presence of Mining Officer, Panna, forest and revenue officials.
- (iv) The entire lease area will be fenced and PP will create a green buffer between the forest boundary and lease boundary, Mining Officer Panna should ensure that PP should not infringe into no mining zone.

(v) The transport route should be decided in consultation with the forest officials.

(vi) No dumping will be allowed towards the forest boundary.


After detailed discussion and perusal of query response in 292<sup>th</sup> SEIAA meeting dtd. 10.02.2016 and recommendation in 267<sup>th</sup> SEAC meeting dtd. 15.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.


- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per approved mining plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from the Pakka Structure near the Highway and 100m. from the National Highway as a "no mining zone". The site demarcation should be done in the presence of Mining Officer, Betul, National Highway and revenue officials.
- (iv) The entire lease area will be fenced and PP will create a green buffer between the National Highway and lease boundary. Mining Officer Betul should ensure that PP should not infringe into no mining zone.
- (v) The entire lease area will be fenced before commencing the mining operation.
- (vi) No crusher will be allowed within 500m. from the National Highway.

Hence, Prior Environmental Clearance is granted for **Stone Quarry (Opencast Semi Mechanized Method)** in an area of 1.70 ha. for production capacity of 12,500 cum/year at Village-Malegaon, Tehsil-Multai, District-Betul (MP) for the lease period to Smt. - (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per approved mining plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from the National Highway as a "no mining zone". The site demarcation should be done in the presence of Mining Officer, Sehore, National Highway and revenue officials.
- (iv) The entire lease area will be fenced and PP will create a green buffer between the National Highway and lease boundary, Mining Officer Sehore should ensure that PP should not infringe into no mining zone.
- (v) The entire lease area will be fenced before commencing the mining operation.
- (vi) No crusher will be allowed within 500m. from the National Highway.


PP has submitted a request for withdrawing his application which is under process in SEAC. The letter may be forwarded to SEAC for consideration. Copy to PP.



After detailed discussion and perusal of query response in 302<sup>th</sup> SEIAA meeting dtd. 10.03.2016 and recommendation in 263<sup>th</sup> SEAC meeting dtd. 11.01.2016, PP has submitted a letter on 22.03.2016 that he needs more time to submit the requisite information. SEIAA has decided to grant him extension upto 25.04.2016 to submit information.
