
- (i) An affidavit regarding construction activities not commenced on the project site.
- (ii) PP should submit documents regarding company registration.
- (iii) Layout showing shifting of playground area.
- (iv) Layout showing connectivity of the municipal sewer line from the project area including details of trunk line exists in the sewerage network.
- (v) PP should submit details of parking area including residential and commercial separately.
- (vi) Landscape plan with number of trees and name of the species to be planted including commercial area.
- (vii) Details of CSR activities including budgetary provision for the same.
- (viii) Connectivity of the nearest fire station from the project site.


In response to above, query reply submitted by PP vide letter dated 07.04.2016 received in SEIAA on 07.04.2016 was examined in depth and it is noted that :-


- (i) PP has submitted an affidavit regarding construction activities not commenced on the project site.
- (ii) PP has submitted Certificate of Incorporation dated 13.11.2000. As per the certificate the name of Company is "Jitesh Estate Pvt. Ltd."
- (iii) PP has submitted lay out plan for play ground.
- (iv) PP has submitted layout showing connectivity of the municipal sewer line from the project area including details of trunk line exists in the sewerage network.
- (v) PP has increased car parking space from 395 ECS to 732 ECS including stilt and open area.
- (vi) PP has proposed 304 nos. of trees including commercial area i.e. 3840.45 sq.m. area (15% of land area).
- (vii) PP has submitted total project is worked out as Rs. 70 crore. 2% of the total project cost as CSR initiative comes around Rs. 1.4 crore. Under CSR activities PP has proposed sanitation complex for villagers, medical aid to charitable hospital / organization, construction of charitable school within the premises, provisions of ramps, toilets and other facilities for handicapped residents.
- (viii) PP has submitted the nearest fire station will be fire station of BHEL, Govindpura which is 8 km away from the site.

It is decided to accept the recommendations of 260th SEAC meeting dtd 07.01.2016 **with 13 special conditions and accord Prior Environmental Clearance** for proposed Vishnu Heights at Part of Khasra no. of 24/1/3,14/3 and 14/5/1 Village – Bawdia kalan/Ahmadpur, Tehsil – Huzur, Distt. – Bhopal (M.P.) Total Land Area – 2.634 ha, Total Built Up Area – 79595.35 sq.m. by Ku. Bharti Parwani and Jitesh Parwani, Jitesh Estate Pvt. Limited Ltd., 141, Mezzanine Floor, City Trade Centre, Malviya Nagar, Bhopal (M.P.)-462003 **subject to following specific conditions imposed by SEIAA :-**

- (1) The entire demand of water should be met through Municipal Corporation; Bhopal there should be no extraction of ground water.



- (2) PP should ensure linkage with municipal sewer line for disposal of waste water.
 - (3) Municipal Solid Waste:
 - (a) Provide compactors for MSW
 - (b) Ensure three bin systems for segregated collection of waste.
 - (c) Ensure linkage with Municipal Corporation for final disposal of MSW.
 - (4) PP should ensure road width at least 30 m; Front MOS 15 m and side / rear MOS 7.50 m. road width; MOS and Open spaces as per MPBVR 2012 rule 42 (2) for building height upto 45m.
 - (5) For firefighting:
 - (a) PP should ensure connectivity to the fire station from the project site.
 - (b) As per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Bhopal) incorporating all the fire fighting measures recommended in National Building Code Part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.
 - (6) PP should ensure the rain water harvesting. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.
 - (7) PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures, and other energy efficient equipments.
 - (8) PP should ensure to provide car parking as proposed.
 - (9) CSR activities :-
 - (a) PP has proposed to carryout activities under CSR worth Rs. 1.4 crore. For identification and execution of works, PP should consult the Commissioner, Nagar Nigam, Bhopal. After identification of activities, PP should submit a list in SEIAA.
 - (10) Green belt :-
 - (a) PP should ensure plantation to the 3840.45 (15%) as per the proposed landscape plan. Plantation should be done in two rows all along the periphery of the project area including Avenue plantation along the roads, trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc. along with ornamental varieties.
 - (b) Every effort should be made to protect the existing trees on the plot.
2. **Case No. 719/2012**, Prior Environmental Clearance for **Marble Mine** (Opencast Mechanised Method) in an area of 2.06 ha. for production capacity of 45000 MTPA at Khasra No. 228 at Village-Chhapra, Tehsil-Bahoriband, Distt- Katni (MP) by M/s Bahubali Marbles C/o Shri Yashwant Jain, 1280, Home Science College Road, Nepier Town, Jabalpur.


- (1) The case was recommended in 06th SEAC -II meeting dtd. 18.02.2016 with 10 special conditions.



- (2) The case was then discussed in 304th SEIAA meeting dtd 16.03.2016 and thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (3) It was noted that the criteria of inter-state boundary is not applicable as mining site falls in Bahoriband Tehsil of District - Katni, National Park/Sanctuary is not located within 10 km radius. Hence, the General Condition is not attracted.
- (4) Mining plan is approved by the Regional Head, Directorate of Geology & Mining, Regional Office, Jabalpur (vide letter no. letter 547/खनि./न.क्र/13-14 dtd 19.03.2014).
- (5) The proposed plantation program was examined and it was found that 1200 trees per year shall be planted in an area of 0.85 ha during the lease period.
- (6) It was noted that the public hearing was carried out on 07.08.2015 at Mine Parisar.
- (7) PP has committed that dump shall be properly fenced and benched till it's utilized for backfilling purposes. It is also committed that overburden management shall be strictly complied as per the approved mining plan.
- (8) PP has committed that apart from the proposed plantation programme a total of 700 plants shall be planted on either side of the approach road (upto the length of 350 m).
- (9) PP has informed during presentation that the total estimated water requirement for the dust suppression, mining through wire saw and green belt development is 23 KLD. PP committed that the accumulated water shall be used for the said purposes. It is also informed that almost 200KLD accumulated water has been given to the farmers every year on their request.
- (10) PP further informed that they have proposed water retaining structure measuring 30x20x10 m at their own land adjacent to the ML area and committed that the excess water from the pit shall be taken to the proposed water structure.
- (11) After detailed discussions and perusal of recommendations of 06th SEAC -II meeting dtd. 18.02.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project **subject to the following specific conditions:**
 - I. Before commencing any mining activity chainlink fencing of the entire area shall be carried out.
 - II. PP shall construct an all weather road alongwith other mine owners of the area to reduce the dust emission.
 - III. Garland drains shall be developed in accordance with suggestions given in EIA.
 - IV. No overburden shall be dumped in the forest area.
 - V. Transportation of material shall not be carried out through forest area.
 - VI. Demarcation of forest boundary from the ML area shall be carried out in consultation with forest officials.

- VII. Since the depth is more than 6m from the ground level, Mine Safety Rules shall be invoked in this case. PP should obtain NOC from Director, Mine Safety before commencing the mining activity.
- VIII. Mine water shall be properly analysed before discharging it into the fields.
- IX. Before renewal of air and water consent, air and water quality analysis shall be carried out by MPPCB. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- X. The commitments made by PP should be implemented in content and spirit.
- XI. PP shall carry out the above committed work with intent & spirit.
- XII. Under CSR activity in addition to the proposed activities following activities should be added.
 - a) A village shall be adopted by all nearby mine owners with special focus on girl child education in consultation with Collector, Katni.
 - b) Skill upgradation programme for the villagers of nearby villages.
 - c) Sanitation activities including construction of individual toilets for local residents in consultation with village Panchayat.
 - d) Drinking water facilities for villagers of nearby villages.
 - e) Installation of rainwater harvesting structure.
- XIII. The appropriate budget provision shall be made for the CSR activities.

Hence, Prior Environmental Clearance is granted for **Marble Mine** (Opencast Mechanised Method) in an area of 2.06 ha. for production capacity of 45000 MTPA at Khasra No. 228 at Village-Chhapra, Tehsil-Bahoriband, Distt- Katni (MP), **for the lease period** to M/s Bahubali Marbles C/o Shri Yashwant Jain, 1280, Home Science College Road, Nepier Town, Jabalpur.

- (4) Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (5) It was noted that the inter-state boundary is at 53.00 km from ML area, National Park/Sanctuary is not located within 10 km radius. Hence, the General Condition is not attracted.
- (6) Mining plan is approved by the Regional Head, Directorate of Geology & Mining, Regional Office, Rewa (vide letter no. letter 545/मा.प्ला./न.क्र/15 dtd 14.05.2015).



- (7) The proposed plantation program was examined and it was found that **5137** saplings shall be planted in an area **5.896 ha** during the lease period.
- (8) It was noted that the water requirement is 20 KLD (14 KLD - Dust Suppression + 03 KLD - Green Belt + 03 KLD - Drinking), which shall be met by mine pit water, settling tank & handpump.
- (9) It was noted that the Public Hearing was held on 29.06.2013 at Govt. Primary School, Pakhda, Tehsil- Sinhawal, Distt. – Sidhi (M.P.).
- (10) After detailed discussions and perusal of recommendations of 167th SEAC meeting dtd. 10.01.2015, presentation made by the PP in SEIAA & SEAC, it **was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
 - I. Before commencing any mining activity fencing of the entire area shall be carried out. The PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt.
 - II. No crusher shall be installed at mining site.
 - III. Approach road to the ML area shall be repaired before commencing mining activity and the same shall be maintained by the PP.
 - IV. PP shall deposit the amount as per the approved government rate to CEO, Zila Panchayat, Sidhi and DFO, Sidhi through Demand Draft for plantation (as per Collector, Sidhi letter dtd 12.09.2011) apart from the proposed plantation programme.
 - V. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
 - VI. Under CSR activity in addition to the proposed activities following activities should be added.
 - a) Skill upgradation programme for the villagers of nearby villages.
 - b) Girl child education in nearby villages.
 - c) Sanitation activities including construction of individual toilets for local residents in consultation with village Panchayat.
 - d) Installation of rainwater harvesting structure.
 - VII. The appropriate budget provision shall be made for the CSR activities.






