Jain, Sr. Vice President (P&D). M/s Khaitan Chemicals & Fertilizers Ltd. 301-308, Apollo Arcade, 3rd Floor, ½ Old Palasia Indore (M.P) – 452018.

This case was discussed in 195th SEIAA meeting dtd 20.04.2015 and it was delisted for want of information (EIA). PP vide letter 13.04.2016 has submitted the desired information (EIA) and therefore the case is hereby relisted and may be sent to SEAC for appraisal.

7. **Case No. 1150/2013**, Prior Environmental Clearance for **Marble Mine** (Open Cast Mechanized Method) in an area 2.21 ha. for proposed production capacity of 12000 cum/year at Khasra no. 123 & 124 at Village - Amoch, Tehsil – Bahoriband, Dist - Katni by M/s Kesarinandan Marbles Pvt. Ltd., 207-208, Neelkanth Apartments, Bhavani Singh, Road, Jaipur (Rajasthan) (M.P.).

- (1) The case was recommended in 13th SEAC-II meeting dtd 21.03.2016 for grant of prior EC with 12 special conditions.
- (2) The case was then discussed in 310th SEIAA meeting dtd 30.03.2016 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (3) It was noted that the criteria of inter-state boundary is not applicable as mining site falls in Bahoriband Tehsil of District - Katni, National Park/Sanctuary is not located within 10 km radius. Hence, the **General Condition is not attracted**.
- (4) Mining plan is approved by the Director, Geology and Mining (vide letter no. 5889 dtd. 20.04.12).
- (5) The proposed plantation program was examined and it was found that **720 trees** shall be planted in an area **0.72 ha** during the lease period.
- (6) It was noted that the Public Hearing was held on 18.12.2015 at mine site, Village - Amoch, Tehsil – Bahoriband, Dist - Katni (MP) under the Chairmanship of ADM, Katni. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.
- (7) It was noted that life of mine is 09 years (as per mine plan).
- (8) After detailed discussions and perusal of recommendations of 13th SEAC -II meeting dtd 21.03.2016, presentation made by the PP in SEIAA & SEAC, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
 - I. No transportation shall be carried out through forest area and DFO should monitor the transportation activities on regular basis.
 - II. Overburden shall not be dumped outside the mining lease area and private land of PP adjacent to the lease area. A retaining wall should be constructed all around the dumping area to avoid slippage of dump material.
 - III. Dumping shall be done in a scientific manner with proper watch and ward arrangements and lighting facilities for preventing accidents.



- IV. Before commencing any mining activity, a buffer zone shall be demarcated in the periphery of mining lease area and fencing of the entire area (including overburden dumps) shall be carried out. There should be no opening towards forest area.
- V. Mining Officer, Forest and Revenue Officials of district Katni shall regularly inspect the mining site and ensure that dumping should not be done on forest land.
- VI. Garland drain alongwith settling tank shall be constructed all around the mine and maintain it in a proper manner.
- VII. PP shall ensure that the water table shall not be disturbed due to the mining activities.
- VIII. PP shall ensure the regular monitoring of water before discharging it into the fields.
- IX. The commitment made by the PP regarding CSR activities and afforestation plan should be implemented in content and spirit.
- X. Labour register shall be maintained with proper working hours as per the labour law and displayed it on the notice board mentioning the actual name of the worker. Collector, Katni should ensure that District Labour Officer visit the site regularly and check whether the mine owner properly following the labour laws.
- XI. Under CSR activity in addition to the proposed activities following activities should be added.
 - a) Regular Health check-up of labourers and their family members.
 - b) Skill upgradation programme for the villagers of nearby villages.
 - c) Sanitation activities including construction of individual toilets in consultation with village Panchayat.
 - d) Installation of rainwater harvesting structure.
- XII. The appropriate budget provision shall be made for the CSR activities. PP should coordinate with the District Administration for identifying and implementation of CSR activities.


- (1) The case was discussed and it was found that the PP has applied in **Form-I** for Prior Environmental Clearance for expansion of production capacity of Limestone from 5,000 cum/year to 5,00,000 M.T/year (Open cast mechanized

mining method) in an area of 5.00 ha. at **Survey No. 142/2**, at Village Kandaka, Tehsil Jawad, Distt. Neemuch, M. P.

- (2) SEAC-II in its **09th meeting dtd. 24.02.2016** recommended the case for grant of prior EC with 12 special conditions.
- (3) Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (4) It was noted that as per DFO, Neemuch letter vide No. 7248 dtd. 26.12.2015 the National Park/Sanctuary are not located within 10 Km., radius and(as per Tehsildar Office, Jawad, District Neemuch letter No. 248 dtd. 16.02.2016) the inter-state boundary at 6.5 km. radius from the mining site. Hence, the **General Conditions are not attracted**.
- (5) The proposed plantation program was examined and it was found that 1650 tress would be planted in an area of 1.65 ha. at the end of lease period.
- (6) It was noted that the water requirement is 15 KLD (5 KLD for Dust Suppression+ 3 KLD for Green Belt +1 KLD for Domestic purpose + 6 for KLD Allied mining activities), which shall be met from hand pump & tube well.
- (7) It was noted that the Public Hearing was held on 05.11.2015 at Mining Parisar, under the Chairmanship of Additional District Magistrate, Neemuch.
- (8) After detailed discussions and perusal of recommendations of SEAC-II in its **09th meeting dtd. 24.02.2016**, presentation made by the PP in SEIAA & SEAC, it **was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
 - i. No transportation through the village, they will use the bypass road of the village.
 - ii. Complete lease area to be fenced.
 - iii. Controlled blasting to be done in only day time by pre intimation to the nearby villagers.
 - iv. Plantation to be done in 7.5 on periphery in 3 rows just after completion of fencing.
 - v. Top soil shall be reserved for use in plantation.
 - vi. For consolidation of dumps retaining wall and toe wall should be properly constructed.
 - vii. A separate establishment with proper facility of toilet, drinking water, First –aid, rest room etc. to be provided within lease area for ladies, children, visitors, doctors, etc.
 - viii. PP shall under take CSR activities in consultation with the District Administration. The identification of activities and its implementation shall be monitored by the District Administration. A complete village will have to be adopted by PP and provide demand driven activities like water supply, sanitation, up-gradation of internal village roads etc.
 - ix. No crusher unit within the mining lease area.
 - x. To avoid dust emissions, continuous water spray on the transportation route to be undertaken by the PP.
