1. **Case No. 153/2008**, Prior Environmental Clearances for **laterite, yellow ochride, manganese, red oxide, red ochride & fire clay mining** in an area 48.562 ha at **Village Jhinna Teh- Dhimmerkhera, Distt- Katni M.P.** by M/s Shukdeo Prasad Goenka C/o Goenka Bhawan, Station Road, Katni M.P.

The case was intially discussed in 24th, 30th, 36th & 47th SEAC meetings and it was recommended as under :

PP has submitted the requisite reply with supporting documents. Hence Committee has recommended the case for grant of prior EC with following special conditions:

- Green area shall be developed in at least 33% of the total mining area during the lease period as per the proposal submitted.
- PP shall explore the possibility of using solar energy where ever possible.
- Commitments towards CSR have to be followed strictly. o Regular health checkup record of the mine workers has to be maintained at site.
- PP has to strictly follow the directions / guidelines issued by MoEF, CPCB and other Govt. Agencies from time to time.

Further the case was discussed in 40th, 41st, 44th, 58th, 62nd, 73rd, 98th, 113th, 157th, 179th SEIAA meetings. In the last SEIAA meeting it was recorded as under :-

After discussions and perusal of the query response of 157th SEIAA meeting dated 26.08.2014 it was noted that Additional Collector, Office of the Collector and District Magistrate, Katni vide No. 13004/S.W./2014 dtd. 19.12.2014 has informed that the SLP was filed in the Hon'ble Supreme Court which has been returned for review at Hon'ble High Court, Jabalpur. Further it was also mentioned in his letter that Forest Department (vide No. 6497 dtd. 10.12.2014) has informed that review petition is being submitted by Forest Department at Hon'ble High Court, Jabalpur.

*In context of above it was decided that till such date the decision is given by the Hon'ble High Court the case is delisted. **The PP and all concerned should be informed accordingly.***

Collector, Katni has reported in the letter dated 31.03.2016 as under :

"उपरोक्त विषयान्तर्गत संदर्भित पत्र के अनुक्रम में लेख है कि पट्टाधारी मेसर्स सुखदेव प्रसाद गोयनका स्टेशन रोड कटनी को उक्त खनिपट्टा कार्यालयीन अभिलेख अनुसार अवधि दिनांक 21.02.1994 से 20.02.2014 तक थी। पट्टाधारी द्वारा खनिपट्टा नवकरण आवेदन पत्र दिनांक 16.08.2005 को प्रस्तुत किया गया है। खान एवं खनिज (विकास तथा विनियमन) अधिनियम 1957 संशोधन अध्यादेश 2015 के अधीन अधिनियम की धारा 8 ए (6) के अनुसार खनिपट्टा की अवधि 50 हो चुकी है। खनिपट्टों की समयवृद्धि पूरक अनुबंध किये जाने हेतु म.प्र. शासन खनिज साधन विभाग भोपाल के ज्ञापन क्रमांक एफ 19-5/2015/12-2 भोपाल दिनांक 12.03.2015 के द्वारा निर्देश प्राप्त हुए हैं, तदनुसार विषयांकित खनिपट्टा में समयवृद्धि पूरक अनुबंध की कार्यवाही प्रचलन में है।

उपरोक्त स्वीकृति खनिपट्टा ग्राम जिन्ना के न्यायालयीन प्रकरण रिक्वू पिटिशन क्रमांक 257/2015 म.प्र. शासन एवं अन्य विरुद्ध मेसर्स सुखदेव प्रसाद गोयनका उक्त प्रकरण वन विभाग से संबंधित होने के कारण उक्त संबंध में वन संरक्षक सामान्य वन मण्डल कटनी जानकारी चाही गयी। जिसमें वन संरक्षक द्वारा पत्र दिनांक 07.11.2015 द्वारा माननीय सर्वोच्च न्यायालय दिल्ली में विशेष अनुमति याचिका (एस.एल.पी.) प्रस्तुत करने हेतु प्रकरण प्रभारी अधिकारी (ओ.आई.सी.) नियुक्ति संबंधी जानकारी प्रेषित की गई।

उक्त प्रकरण में माननीय उच्च न्यायालय (युगलपीठ) जबलपुर द्वारा दिनांक 15.09.2015 को सुनवाई करते हुए याचिका में दिये गये आदेशानुसार याचिका को अमान्य कर दी गई है। आदेश निम्नानुसार है :-

"Apart from the fact that the documents Annexure D-2 is not applicable in the facts and circumstances of the present case, Overwhelming evidence available on record has been considered by courts below to record a finding that the land is not a forest land, it was never a forest area, had never been transferred to forest department and therefore, The suit is decreed. The evidence that had come on record and the concurrent findings recorded are to the effect that there is no proof about transfer of land to the forest department or there being any materials to show the land as forest land, on these consideration, the suit has been decreed this this is a specific finding of fact based on due appreciation of evidence that come on record and there is no error apparent on the face record warranting reconsideration. The ground raised in these application are not such on the basis of which a review is permissible.

Accordingly, both ther review application are dismissed."


From the letter it appears that the mining lease agreement has not been executed as yet. Secondly against the order of the Hon'ble High Court Jabalpur dtd. 15.09.2015 DFO, Katni has proposed for a SLP and it is in active consideration with the Forest Department. Based on the letter of the Collector, Katni, PP may be asked to produce the mining lease agreement document. Further Chief Conservator Forest, Jabalpur should be asked the latest position on filing of SLP. Copy to PP.


2. **Case No.4410/15** Prior Environment Clearance for **Sand Quarry** (opencast manual method) in an area of 18.770 ha. for production capacity of 50000 cum/year (as per **SEAC recommendation**) at Khasra no.-855, Village-Babupur, Tehsil-Dabra, District-Gwalior (MP) by Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.).

After perusal of the query response in 311th SEIAA meeting dtd. 31.03.2016 and recommendations of 14th SEAC-II meeting dtd. 22.03.2016, it was reported that :-

"...As above, the case was presented by the PP and their consultant wherein it was observed that as per the Google image of dated 05/10/2015 & 26/12/2015 based on the co-ordinates provided by the PP only 15% area seems to be minable. PP submitted that the present image is off October, 2015 and December, 2015 and water level recedes gradually in the subsequent months and area become minable for the desired quantity of sand i.e. 75,080 cum/year. The committee decided that as the mining area is 18.770 ha and if 15% area is minable as per the Google image, the effective minable area comes to 2.81 ha. As per the mining plan, the proposed depth is 2.00 meters and PP has also proposed in the mine plan that if "MPSEIAA reduce in production of sand mining activity sub lessee will be restricted for that quantity". committee decided to reduce the quantity considering the submergence of lease area in water to 50,000 cum/year.


The submission made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':


- Production of Sand as per mine plan with quantity not exceeding 50,000 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 100 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining."

OIC of M.P. State Mining Corporation presented the quantities of sand excavated from the present site from Jan. 2011 to Dec. 2015 and it was revealed that the production capacity ranges from 24000 to 50000 cum/year. From the photographs taken recently also reveals the quantum of material recommended in SEAC meeting i.e. 50000 cum/year.

After detailed discussions on the above recommendations it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- I. PP shall not start mining activity before execution of lease agreement.
- II. The production capacity shall be limited to the quantity proposed by SEAC-II.
- III. The lease area should be properly demarcated in the presence of the Revenue & Mining Officials and proper boundary stones should be established.
- IV. No in-stream mining shall be allowed. The local authorities should ensure that the mining activity is confined only in the dry portion of the river where sand is exposed.
- V. The depth of the pit shall not exceed 2.0 m or normal water level prevalent in the lean season whichever is less.
- VI. The final decision of Hon'ble NGT (CZ) Bhopal and Hon'ble NGT Principal Bench, New Delhi in OA No. 49/2015 (Amarkant Mishra Vs State of MP & others), shall be obligatory on the part of PP.
- VII. PP should ensure that no access ramps are made for transportation of sand from the opposite bank of the river.
- VIII. Before commencing the mining activity, site demarcation should be done leaving 100m. from nearest village settlement as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Gwalior.

- IX. No transportation should be carried out through the village. A transportation plan in consultation with the local gram panchayat should be prepared to bypass the passage through the village.
- X. The entire lease area should be properly fenced and boundary stones marked at the site.
- XI. PP should ensure that the flow of river should not be affected due the access ramps.
- XII. PP will ensure three row plantation towards the village settlement side in the entire length of suitable species three year old to conserve and retain the banks.

Hence, Prior Environmental Clearance is granted **Sand Quarry** (opencast manual method) in an area of 18.770 ha. for production capacity of 50000 cum/year (**as per SEAC recommendation**) at Khasra no.-855, Village-Babupur, Tehsil-Dabra, District-Gwalior (MP) **for the lease period** to Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.).

3. **Case No.4371/15** Prior Environment Clearance for **Sand Quarry** in an area of 17.456 ha. for production capacity of 87,280 cum/year at Khasra no -821, Village-Basai, Tehsil-Bhitarwar, District-Gwalior (MP) by Shri Kailash Chandra Gupta, M/s Esteem Infrabuild Pvt. Ltd., P-4, Lal Bahadur Nagar, Durgapura, Jaipur (Raj.)

After perusal of the query response in 314th SEIAA meeting dtd. 06.04.2016 and recommendations of 15th SEAC-II meeting dtd. 27.03.2016, it was reported that :-

"The case was presented by the PP and their consultant. During presentation it was observed by the committee that as per the Google image of April, 2014 based on the co-ordinates provided by the PP, the most part of lease area is submerged in water even in the image of April (summer season). During presentation PP also confirm that the entire lease area is submerged in the water which is also evident from the Google image submitted by the PP with presentation. Thus committee after deliberations recommended that since the entire lease area is submerged in water, the environmental clearance for this site can not be considered."


OIC, M.P. State Mining Corporation was invited to explain the production capacity and proposed area under mining as per the mining plan in the light of the above observation of SEAC. He has submitted recent photographs and the production capacity of the last five years. The case is returned to SEAC with the instructions to hear the OIC, M.P. State Mining Corporation and let him explain the ground realities. Copy to PP.

After detailed discussion of query response in 265th SEIAA meeting dtd. 01.12.2015 and recommendation of 195th SEAC meeting dtd. 01.06.2015, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.

- (iii) Before commencing the mining activity, site demarcation should be done leaving 50m. from the Village Road as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Dhar.
- (iv) The entire area shall be fenced and three rows of plantation should be done towards the road side.
- (v) No structure constructed under the water shed programme should be disturbed by mining activity CEO Zila Panchayat, Dhar should monitor and demarcate the structures constructed under the programme.

Hence, Prior Environmental Clearance is granted for **Stone Quarry** (Opencast Semi Mechanized Method) in an area of 2.00 ha. for the production capacity of 5,700 cum/year at Khasra No. 311 at Village-Toki, Tehsil-Manawar, District-Dhar (MP) for the lease period to M/s Toki Mine Stone Quarry Deposit, Smt. Sunita Gangwal W/o Shri Vipin Gangwal, Proprietor, R/o Manawar, District-Dhar (MP)-454446.

5. **Case No. 950/2012** Prior Environmental Clearance for **Stone Deposit** (Opencast/ Semi-Mechanized Method) in an area of 1.20 ha for Production Capacity 5,000 m³/year at Khasra No. 362, 363 & 432 Part at Village – Dader Sihudi, Tehsil - Deemakheda, District- Katni (M.P.) by Shri Pramod Patel C/o Smt. Tara Patel, Village Kewalari Tehsil - Shehora Badatal Shehora Road Jabalpur (M.P.) – 482001


After detailed discussion of query response in 293rd SEIAA meeting dtd. 11.02.2016 and recommendation of 268th SEAC meeting dtd. 16.01.2016, the Approved Mining Plan submitted by the PP was for a period of two years ending 2015. On perusal of the approved mining plan, the production capacity indicated is 8550 cum/year, whereas earlier the EC was issued for a capacity of 5000 cum/year. The case may be returned to SEAC as it is expansion case for re-appraisal. Copy to PP and Mining Officer, Katni.

- (iii) Before commencing the mining activity, site demarcation should be done leaving 50m. from the water body as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Official of NVDA & Mining Officer, Khandwa.
- (iv) The entire area shall be fenced and three rows of plantation should be done towards the road side.
