Now PP has submitted a letter dated 05.04.2016 requesting to re-open the case as now under the new dispensation the Inter-state boundary condition has been deleted for purposes of assessing the General Conditions. 


It appears that by mistake the file has been transferred to DEIAA Bhopal, in that case the file may be called back for a decision at SEIAA level

new notification dtd. 15.01.2016, lease under 5 ha. there are no mines within 500 m. periphery. The case is hereby relisted.

It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- I. PP shall not start mining activity before execution of lease agreement.
- II. The production capacity shall be limited to the quantity as recommended by SEAC.
- III. The lease area should be properly demarcated in the presence of the Revenue & Mining Officials and proper boundary stones should be established.
- IV. No in-stream mining shall be allowed. The local authorities should ensure that the mining activity is confined only in the dry portion of the river where sand is exposed.
- V. The depth of the pit shall not exceed 3.0 m or normal water level prevalent in the lean season whichever is less.
- VI. The final decision of Hon'ble NGT (CZ) Bhopal and Hon'ble NGT Principal Bench, New Delhi in OA No. 49/2015 (Amarkant Mishra Vs State of MP & others), shall be obligatory on the part of PP.
- VII. PP should ensure that no access ramps are made for transportation of sand from the opposite bank of the river.
- VIII. No transportation shall be permitted within the village.
- IX. The transportation route should be decided in consultation with the local Gram Panchayat.
- X. The entire lease area should be properly fenced and boundary stones marked at the site.
- XI. PP will ensure three row plantation towards the village settlement side in the entire length of suitable species three year old to conserve and retain the banks.

- As per the co-ordinates most of the mining area falls within the stream (appears to be a case of mid-stream mining) though the same is not reflected in mining plan.
- Khasra map also reflect that the mining lease area falls within the stream.


The case is therefore not recommended for grant of EC."


Mining Officer, Narsinghpur has submitted a letter dtd. 03.05.2016 in response to the SEIAA's query dtd. 21.04.2016 and therefore the case is relisted. Mining Officer, Narsinghpur has indicated that the entire lease area is under submergence and no sand mining could be done on the site. SEIAA after detail discussion has accepted the recommendation of SEAC that the case should be rejected and closed. Copy to PP and all concerned.

After detailed discussion of query response in 317th SEIAA meeting dtd. 12.04.2016 and recommendation of 16th SEAC-II meeting dtd. 03.04.2016, from the google map it was observed that presently by construction of a dam, the sand available is seen as scanty. PP was called for clarification and with complete coordinates. It is seen that recently a power plant has come-up at the site. PP in his presentation copy has filed the google map imagery of 2001 when the power plant and the dam had not existed. The case file may be returned to SEAC for re-appraisal after ascertaining complete site details. Copy to PP.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows :-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases


In this particular case, the EC was issued to Mr. Lalit Sehgal vide L.No. 459 dtd. 05.04.2016 for an area of 23.123 ha. at Village Deori, Tehsil-Maihar, Distt-Satna. PP has submitted a letter on 14.04.2016 that the lease has been transferred to M/s K.J.S. Cement Ltd. On perusal of the documents of transferability, PP has submitted the NOC of M/s K.J.S. Cement Ltd., sanction order of Mineral Resources Department, GoMP regarding transfer of lease in favor of M/s K.J.S. Cement Ltd. for the remaining lease period on the same terms and conditions as imposed on the previous lessee i.e. Mr. Lalit Sehgal, the documents of formal transfer of lease to M/s K.J.S. Cement Ltd. duly executed by Collector, Satna.


After detailed discussions on the MoEF&CC Notification regarding transferability it has been decided to transfer the EC issued on 05.04.2016 in favor of Mr. Lalit Sehgal to M/s K.J.S. Cement Ltd. on the same specific and standard conditions for the remaining lease period. Copy to PP and all concerned.






