

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from pakka road as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Jabalpur
- (iv) The entire area shall be fenced and three rows of plantation should be done towards the road side

Also the information provided by the DFO covers only 5 km. distance from the National Park/Sanctuary/Eco Sensitive Zone and not the 10 km. distance as indicated in the general conditions. 


