





10. **Case No. 1866/2014** Prior Environmental Clearance for Padrehi Bauxite, Laterite & Fire Clay deposit (Open cast other than fully mechanized) in an area of 10.88 ha. for production capacity-34,304 TPA, at Khasra no.-299, Vill.-Padrehi, Th.-Bahoriband, District-Katni (M.P.) by Shri Rajendra Prasad Gupta S/o Shri Shyam Sunder Gupta, Bhatta Mohalla, P.O. & District-Katni (M.P.)-483501.

PP has submitted the query response raised in 329th SEIAA meeting dtd. 07.05.2016 and recommended in 13th SEAC-II meeting dtd. 21.03.2016.

- (1) This is a project pertaining to mining of Limestone in MLA of 10.88 ha The activity is mentioned at S.N. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250m from the forest boundary, the interstate boundary is not applicable as mining site falls in Bahoriband Tehsil of District -Katni, thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease from 25.06.2015 to 24.06.2065 with production of 30,034 Tonnes per annum.
- (2) It was reported by the PP that the lease area was granted to Shri Rajendra Prasad Gupta for 50 years upto 25.06.2065. This is a case of new mining lease. No lease area is located within 500m radius. The scheme of mining with progressive mine closure plan has been approved by IBM, Jabalpur.
- (3) SEAC in its 13th SEAC -II meeting dtd 21.03.2016 has recommended the case with 13 special conditions for issuance of EC.

- i. PP shall submit mining lease grant order.
- ii. PP shall submit the source and observations made regarding ground water table.
- iii. PP shall submit plantation scheme in an area of 5.33 ha non mineable area.
- iv. PP should give commitment regarding preparing a pond in the lease area where water will be stored for use in plantation.
- v. PP should give commitment regarding no mining within 50 m. from the nalla.
- vi. PP shall submit afforestation plan by Village road and only karanj, mango, neem, peepal, mahua, kachnar trees should be planted.
- vii. PP should give commitment regarding maintenance and preparation of road from mine site to PWD road.
- viii. PP should give undertaking for water shed management in sloping site of the hillock.
- ix. The top soil for plantation will be brought with the consent of panchayat from deepening of ponds in the area.
- x. PP should give commitment regarding Sanitation activities including construction of individual toilets for local residents in consultation with village Panchayat.

- ii. Source and observations made regarding ground water table. It is mentioned in the submission that the table was found to be varying from 25m to 30m below general ground water level. This was based on the observations from nearby wells.
- iii. Plantation scheme in an area of 5.33 ha non mineable area. As per the scheme it is proposed to develop around 2000 tree saplings per ha. A total of 10700 plants shall be planted in 5.33 ha in first five years. The plant species will be decided with consultation of experts from Department of Forest and co-operation of local community.
- iv. Undertaking regarding preparing a pond in the lease area where water will be stored for use in plantation. It has committed that "A pond in the northern sloping side of the lease area at the lowest level will be constructed where water will be stored for use in plantation purpose".
- v. Undertaking regarding no mining within 50 m. from the nalla.
- vi. Afforestation plan by Village road. It is mentioned in the plan that the length of the village road is about 1.50 km upto state highway junction at Kuwan village. It is proposed to plant two rows of trees by the side of the road at regular interval of 3 m on an average. A total of 2000 trees will be planted in the length of 1.50 km of Karaj, Mango, Neem, Peepal, Mahua and Kachnar.
- vii. Undertaking regarding maintenance and preparation of road from mine site to PWD road. It is also mentioned in the undertaking that the road will be black topped.
- viii. Undertaking for water shed management in sloping site of the hillock at own cost.
- ix. Undertaking for bringing the top soil for plantation with the consent of panchayat from deepening of ponds in the area.






