

1. **Case No. – 658 / 2011** - Prior Environmental Clearance for Pyrophyllite & Diaspore mine (Khera - II) (Open Cast Semi Mechanized Method) in an area of 7.04 ha for enhancement of production capacity Pyrophyllite – from 2000 MTPA to 6000MTPA & Diaspore – from 100 MTPA to 300 MTPA at Khasra no. 1354/1, 1201 at Village – Khera ,Tehsil- Jatara , Distt.- Tikamgarh (M.P.) by Shri P. C. Jain, M/s Eastern Minerals, Reg. Off. – 35, Vivekanand Marg, Cantonments, Jhansi (U.P.) 284001


- (1) The case was discussed and it was found that the PP has applied in Form-I for Prior Environmental Clearance for expansion of production capacity of Pyrophyllite from 2000 MTPA to 6000MTPA and Diaspore from from 100 MTPA to 300 MTPA (Open cast other than fully mechanized) in an area of 7.04 ha. at Khasra no. 1354/1, 1201 at Village – Khera ,Tehsil- Jatara , Distt.- Tikamgarh (M.P.)

It was noted that the Prior EC was issued by MoEF, Gol vide letter No. J-11015/86/2006-IA.II(M) dated 14.08.2007.

- (2) After detailed discussion of query response of 148th SEIAA meeting dtd. 20.09.2013, 161st SEIAA meeting dtd. 16.09.2014 and 173th SEIAA meeting dtd. 09.01.2015, 333th SEIAA meeting dtd. 13.05.2016 and recommendations of 137th SEAC meeting dtd. 24.07.2013 & 33rd SEAC- II meeting dtd. 24.06.2016, for grant of prior EC with 14 special conditions

- (3) Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (4) It was noted that as per Conservator Forest, Tikamgarh letter vide No. 3462 dtd. 20.08.2013 the National Park/Sanctuary are not located within 10 Km., radius and(as per Collector Office, Mining Division letter No. 947 dtd. 08.09.2012) the inter-state boundary is also not within 10 km. radius from the mining site. Hence, the General Conditions are not attracted.
- (5) The proposed plantation program was examined and it was found that 3000 trees would be planted in an area of 2.32 ha. at the end of lease period.
- (6) It was noted that the water requirement is 8.0 KLD (5 KLD for Dust Suppression+ 1.5 KLD for Green Belt + 1.5 for KLD Domestic), which shall be met from existing mine pit and ground water.
- (7) It was noted that the Public Hearing was held on 26.09.2012 at Gram Panchayat Bhawan, Khera, under the Chairmanship of Additional Collector, Tikamgarh. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.
- (8) After detailed discussions and perusal of recommendations of 137th SEAC meeting dtd. 24.07.2013 & 33rd SEAC- II meeting dtd. 24.06.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
 - i. The issue of blasting was highlighted during public hearing. Therefore, only Muffle blasting is to be done as and when required during day time only after pre-intimation to the nearby villagers.
 - ii. Depth and size of existing garland drains are to be increased. It should be 1.5m x 1.5m with settling tank of proper capacity and adequate size.
 - iii. A 7.5 Meter board strip shall be maintained as buffer zone within the lease area all along the ML boundary.
 - iv. For consolidation of dumps retaining wall and toe wall should be properly constructed on eastern side to protect human settlement.
 - v. No existing tree will be cut.
 - vi. No excavated material should be dumped on eastern side.
 - vii. The entire area shall be fenced and three rows of plantation should be done towards eastern human habitation side. Beside this, plantation should also be done in both side of road
 - viii. It will be responsibility of PP, no stone material after blasting fly across the mined area.
 - ix. Budget provision of Rs. 5.00 Lakh should be made in CSR for construction of 200 m Concrete Road from mining site to Main Road.
 - x. Temporary Shed should be developed in rest room area of mining site for 40 persons.

- xi. Before commencing the mining activity, site demarcation should be done leaving 100 m. from east side, leave aside the human habitation as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence Mining Officer, Tikamgarh.



B. GENERAL INSTRUCTION TO BE FOLLOWED BY SEIAA & SEAC.

On the invitation of the MoEF & CC, Chairman and Member, MP SEIAA attended orientation workshop on 29.06.2016 at New Delhi. During deliberation, following issues were discussed and Joint Secretary MoEF instructed to follow the points detailed below :-

- (A) All cases pertaining to 8(a) & 8(b) category where PP has violated, no EC shall be granted till final Notification is issued by MoEF & CC in this regard, in furtherance to the Draft Notification issued on 10.05.2016. PP in cases where violation has occurred, shall not commence any construction activity at the site.
- (B) All cases where ToR have been proposed & finalized by SEAC should be approved by SEIAA.
- (C) All cases registered in SEIAA should be disposed off within 100 days.

C. CORRIGENDUM


1.
