- B. It was reported by the PP that the lease area was granted to Shri Obedullah Kha. This is a case of existing mining lease. - (4) The case was then discussed in 351st SEIAA meeting dtd 06.07.2016 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) The proposed plantation program was examined and it was found that 4950 trees shall be planted covering an area of 2.475 ha under plantation on boundary and 38683 plants shall be planted in 19.319 backfilled area.
- (6) It was noted that the water requirement is 35 KLD (19.0 KLD Dust Supression + 6.0 KLD Green Belt + 10.0 KLD Drinking/Domestic purpose), which shall be met by Bore Well & Mine Sump.
- (7) It was noted that the Public Hearing was held on 05.05.2016 at mine site, at Village - Aber, Tehsil - Rampur Baghelan, Dist. - Satna (M.P.). The issues raised during public hearing are as follows:-
 - Employment opportunity to local villagers.
 - b. Mining should be done as per the mining plan.
 - c. Plantation should be done alongside the road.
 - d. Proper water sprinkling be done on the roads use for mining purposes.
- (8) After detailed discussions and perusal of recommendations of 34th SEAC -II meeting dtd 25.06.2016, presentation made by the PP in SEIAA & SEAC, it was decided that to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-
 - Before commencing any mining activity fencing of the entire area shall be carried out.
 - II. The approach road of 1.5 km upto Satna –Semariya junction shall be tarred by the PP and also maintained by PP on regular basis. PP has committed to invest Rs. 10.00 lakh under this head.

- III. Garland drain alongwith settling tanks shall be constructed all around the mine. PP shall also ensure the proper cleaning and maintenance of garland drain and settling tank.
- IV. No cutting of existing trees in the mining lease.
- V. The plantation of Neem, Kachnar, Mango, Mahua, Peepal, Karanj, Aonla, Khamer, Imli etc. shall be carried out in the green belt and proposed plantation area.
- VI. Sludge shall be removed physically and dumped at overburden side.
- VII. PP shall ensure that the water table should not be intersected during the mining operations.
- VIII. Regular water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorised laboratory in consultation with Regional Officer, MPPCB.
 - IX. PP shall ensure to construct the shelter for the labours, proper health check-up of workers and payment wages to the workers as per labour laws.
 - X. Proper infrastructure with toilet facility shall be developed for the labourers. The budget provision of Rs 10.00 lakhs shall be made separately for the activities related to the labourers.
