*"The case was again scheduled for the presentation today but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier PP was also absent in the 28th SEAC-II meeting, 31st SEAC II & 36 SEAC II meeting. Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project."*

As per the above observation, it has been decided to delist the case which can be liable for re-listing when PP shows his inclination to be present in SEAC. Copy to PP & all concerned.


After detail discussion and recommendations of the 40<sup>th</sup> SEAC-II meeting dtd. 25.07.2016, it was reported that :-


*"SEIAA on dated 20/06/2016 sent back the file to SEAC for clarification on quantity which was placed before the committee. The committee observed that the quantity recommended in the 209th SEAC meeting dated 24/07/2015 was 6250 cum/year wherein actually it was a proposal for expansion from 6250 cum/year to 19,950 cum/year as per the form-1 submitted by the PP and the mine plan is also approved for 19,950 cum/year. It was also observed by the committee that PP has made the presentation for the production capacity of 19,950 cum/year and may be due to typographical error production quantity was mentioned as 6250 cum/year. The committee after deliberations recommends that the production quantity should be read as 19,950 cum/year for stone and other conditions will remain same as per the recommendations of 209th SEAC meeting dated 24/07/2015."*


**B. POLICY DECISION IN RESPECT OF NGT DIRECTIVES (OA 20/2015, Order No. 27 dtd. 26.07.2016)**

Hon'ble NGT (CZ) has directed SEIAA to take note of the following instructions in convey the same to all the District Authorities :-

*"In some of the cases that were brought to our notice the environmental clearances were orders placed before us, we find that under standard condition whereas a condition imposed was that no heavy vehicles shall be allowed to enter the river bed and the transportation of the sand from the excavation pits of the leased area to the loading point shall be thorough trollies (tractor trollies) and not by heavy vehicles. What is needed to be ensured by the District Administration and the Mining Department is that in accordance with the aforesaid condition imposed by SEIAA only such registered tractor trollies which are having the necessary registration and permission for the aforesaid purpose under the Motor Vehicle Act and also insurance coverage for the same shall alone*


