- (5) It was noted that as per Conservator Forest, Chhatarpur letter vide No. 413 dtd. 17.02.2012 the National Park/Sanctuary are not located within 10 Km., radius and(as per Tehsildar Office, Tehsil Baxwaha, District Chhatarpur letter No. 362 dtd. 13.09.2014) the inter-state boundary is also not within 10 km. radius from the mining site. Hence, the General Conditions are not attracted.
- (6) The proposed plantation program was examined and it was found that 25085 tress would be planted in an area of 17.4 ha. at the end of lease period.
- (7) It was noted that the water requirement is 96 KLD (54.0 KLD for Dust Suppression+ 18.0 KLD for Green Belt + 4.0 for KLD Domestic + 20.0 KLD for Crushing Purpose), which shall be met from existing mine pit , Settling tank, Bore well and Hand Pump.
- (8) It was noted that the Public Hearing was held on 07.11.2015 at Gram Panchayat Bhawan, Baxwaha, under the Chairmanship of Upper Collector, Chhatarpur. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.
- (9) After detailed discussions and perusal of recommendations of 38th meeting dtd. 13.07.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
 - A 7.5 Meter board strip shall be maintained as buffer zone within the lease area all along the adjoining mining.
 - (ii). All pits will be merged together to create reservoir.
 - (iii). Mining should not be carried out on stabilized old dumps.
 - (iv). PP should ensure the organized benching for open cast mining.
 - (v). Location of crusher should be away from Pakka Road if installed in future.
 - (vi). Pucca Road is about 20 meters away from the ML area thus a setback of 10 meters be left from the ML area excluding the 17.50 meters area is no mining zone.
 - (vii). PP will monitor water level and quality of ground water of the dug wells and tube wells existing in the surrounding area with the consultation of CGWB.
 - (viii). Adequate number of settling tanks should be constructed on mining lease for storage of water.
 - (ix). Check dams should be constructed on nallah flowing in nearby area of mining lease to trap the soil.
 - (x). PP should initiate the plantation in the beginning of mining operation.
 - (xi). PP shall consult the local panchayat / Skill Development Department and frame activities to be undertaken in CSR like vocational & technical training for local youth & womens.

(xii). A separate establishment with proper facilities such as toilet, drinking water , First –aid, rest room etc. to be provided within lease area for ladies, children, visitors, doctors, etc.

13. Case No. 3876/2015 Prior Environmental Clearance for Stone Quarry in an area of 1.435 ha. (20,000 cum/year) at Khasra No.-3579/7, 3577, Vill.-Billaua, Tehsil-Dabra, District-Gwalior (MP). By Shri Sushil Kumar Jain S/o Shri B.K. Jain, M/s Stuti Stone Crushing Co. R/o J-82, Kalka Jee, Delhi-474001.

After detailed discussion it has been decided to consider this case along with other mining cluster of Billaua as and when the cases are forwarded/recommended by SEAC.

14. Case No. 5253/2016 Prior Environmental Clearance for Stone Quarry (Opencast Semi-mechanized Method) in an area of 14.15 ha. for production capacity of 1,00,000 cum/year at Khasra no.- 56 & 104, Village-Birpur Kundleshwar, Tehsil - & District - Khandwa (MP) by Shri Ashutosh Bansal, Owner, R/o Ramkrishnaganj, Khandwa, (MP) – 474003.

After detailed discussion and recommendation of 45th SEAC-II meeting dtd. 09.08.2016, it was decided to obtain NOC from DFO, Khandwa of the forest boundary from the mining lease area. Copy to PP.

15. Case No. 4231/2015 Prior Environmental Clearance for Dolomite Mine in an area 6.07 ha (Expansion 13,000 TPA to 18655 TPA) at Khasra No. 191 Vill. Magarhata, Teshil – Barwara, Distt. Katni (M.P.) by Shri Surendra Kumar Agrawal R/o 1, Civil Line, Katni (M.P.) 483501

The case was discussed and recommended in 45th SEAC-II meeting dtd. 09.08.2016 it was recorded that :-

".....PP was also informed to submit above information vide letter no 773 dated 25/04/2016 stating to submit information within 30 days. PP so far has not submitted the desired information and the case was placed before the committee. The committee observed that PP has neither submitted the desired information nor has requested for providing additional time to submit desired information and thus decided that this case may be recommended for delisting to SEIAA as per MoEF&CC OM No. F-11013/5/2009-IA-II (Part) dated 30/10/2012 as PP has not submitted the desired information."

As per the above observation and perusal of the documents, the case is hereby delisted which shall be liable for relisting once the PP shows his inclination to present the case before SEAC. Copy to PP and all concerned.
