

## Minutes of the 385<sup>th</sup> Meeting of SEIAA dated. 16.11.2016

The 385<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 16.11.2016 at the Authority's Office in Environmental Planning and Co-Ordination Organization (EPCO), Paryavaran Parisar, Bhopal. ### A. Policy Decision :

SEAC in most of the cases are giving recommendations based on the instruction issued by SEIAA that the cases should be appraised on priority and as per the lease documents available as submitted by PP. These instructions were issued at the time of notification issued by MoEF&CC dtd. 01.07.2016 for transfer of cases to DEIAA. From now onwards SEAC is hereby directed to follow the set procedure of appraising the cases carefully after complete information is available as guided by MoEF&CC Notifications. NOC from the Mining Officer should be obtained for number of mines within 500 m. periphery with complete details like name of the lessee, date of granting lease, lease area and its Khasra number, whether EC issued to the other mines in the periphery and its date and operational status of the mines.



Kishan Widhani, Project Engineer, Madhya Pradesh Police Housing Corporation Ltd, D-30, HIG Colony, AB Road, Indore – (M.P.) 452001 Env. Consultant. – Greencindia Consulting Pvt. Ltd. Ghaziabad(U.P.)

- (1) The proposed project is Construction of Multi-Storey Residential Complex for Police Personnel at 15th Battalion, Khasra No. 128, 135 & 136 village Gadar Khedi, Tehsil & District Indore M.P. The project includes 10 Constable blocks (G+14) with 1180 units, 04 Non Gazette Officer Block with 472 units, Community Center (G+4) etc.
- (2) As per the T & CP Indore (vide letter no.5729 dtd 14.07.2016), out of the 12.922 ha total land area only 6.128 ha is allocated for the proposed project. The total built up area proposed by PP is 1,43,602.78 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.mt. & 1,50,000 sq mt. and plot area is less than 50 ha.
- (3) The case was discussed in SEAC meetings 281<sup>st</sup> dated 01/09/2016, 283<sup>rd</sup> dtd. 27.10.2016 and is recommended for grant of prior EC subject to 15 special conditions.
- (4) The case was also discussed in 384<sup>th</sup> SEIAA meeting dtd. 11.11.2016, and decided to call PP for presentation.
- (5) After deliberation the case was discussed in depth and it is noted that :-
  - (i). PP has submitted notarized copy of Khasra Panchsala 2014-15. As per the Khasra Panchsala the land is the name of 15th Battalion Police Personnel Force Indore
  - (ii). The total water requirement is 769.8 KLD. The fresh water requirement is 549.9 KLD & recycled water is 219.9 KLD. The source of water supply is Municipal Corporation, Indore. **PP has submitted letter (dtd. 09.02.2016) from Municipal Corporation, Indore for supply of water.**
  - (iii). The total waste water generation is 600.4 KLD. PP has provided Sewage Treatment Plant of 720.6 KLD. PP has proposed MBBR technology for waste water treatment. The total treated waste water is 480.3 KLD (Flushing- 173.5 KLD+ Gardening – 41.5 KLD+ Misc - 4.9KLD) and remaining 260.4KLD is proposed to be disposed off in the municipal sewer line. **PP has submitted letter (dtd. 15.02.2016) from Commissioner, Municipal Corporation, Indore for disposal of extra treated waste water.**
  - (iv). Approximately 3809.3 kg/day Solid waste shall be generated including Horticulture Waste and Street Sweeping. The generated biodegradable and non biodegradable waste will be collected separately. Closed room with concrete surface will be constructed for solid waste storage. The bio degradable waste will be subjected to Organic Waste Convertor and the compost produced will be used as manure for landscaping and non-

biodegradable waste will be deposited at a landfill site of Municipal Corporation. STP sludge (3 KLD) will be filter-pressed and the de-watered sludge proposed to be disposed off with the MSW. **PP has submitted letter (dtd. 27.01.2016) from Municipal Corporation, Indore for disposal of solid waste.**

- (v). PP has proposed to provide Wet riser Fire Hydrant System, automatic sprinkler system, Fire water reserve (under-ground storage tanks) as well as fire water pumps to take auto start in case of pressure drop in hydrant system, the Fire pumps shall be as one Diesel driven pump and Two electrically driven pumps with one jockey pump, manual fire alarm system etc. as per NBC 2005 . PP has also submitted the fire fighting plan duly incorporating the circulation space all around the proposed construction for the fire tenders.
- (vi). PP has proposed the maximum height of the building as 45 m. PP has provided Road width 30m; Front MOS 18 m and side / rear MOS 9.0 m. As per MP Bhumi Vikas Niyam 2012 rule 42 (2) road width 30 m; Front MOS 18 m and side / rear MOS 9.0m for building height upto 45 m. PP has submitted the NOC of the Civil Aviation Department for high rise building.
- (vii). PP has submitted roof top rain water harvesting system for ground water recharging and has proposed 06.no of recharging pits.
- (viii). The total power requirement is 8750 KVA. The source of electricity is Madhya Pradesh Kshetra Vidyut Vitran Company Limited. PP has also proposed 4 no DG set of capacity 4\*650 = 2600 KVA (for common areas and essential services only). For energy conservation measures PP has proposed the buildings will be designed to ensure that natural ventilation, Solar Lighting for street and other common places and reflecting Paints for roof tops.
- (ix). PP has proposed to provide 1051 ECS (Open- 1037 ECS, Stilt – 14 ECS).It was observed that PP has proposed maximum no. of car parking in open area instead of stilt and basement.
- (x). PP has proposed an area of 8295 sq. m (13.5%) to be developed as green area by planting 600 no. of trees and species of Saltree, Kachnar, Kadam, Neem, Gulmohar etc.
- (xi). It is observed that there are 119 numbers of existing trees in the project area. PP has submitted a tree conservation plan, in which he proposes to cut 55 trees and retain 64 trees. PP also propose to plant 1200

additional trees in lieu of the trees cut for the proposed development of the project.


(xii). PP has submitted the use of the existing 3 play grounds within their campus for use of the children and the families to be accommodated in the proposed buildings.

(xiii). PP has committed to increase the internal road widths from 6m to 7.5m.

The submissions made by the PP were found to be satisfactory and acceptable hence It is decided to accept the recommendations of 283<sup>rd</sup> SEAC meeting dtd. 27.10.2016 with 15 special conditions and accord Prior Environmental Clearance for proposed Residential Project "Multi-Storey Residential Complex for Police Personnel" at 15th Battalion, Khasra No. – 128, 135, 136, Village – Gadar Kdedi, Tehsil & Distt. - Indore, (M.P.) Total Plot Area – 6.22 ha. (62230.03 sq.m), Total Built-up area – 1,43,602.78 sqm .by Mr. Kishan Widhani, Project Engineer, Madhya Pradesh Police Housing Corporation Ltd, D-30, HIG Colony, AB Road, Indore (MP) - 452001, **subject to following specific conditions imposed by SEIAA:-**

- (1) The entire demand of water should be met through Municipal Corporation, Indore there should be no extraction of ground water.
- (2) The inlet and outlet point of natural drain system should be maintained with adequate size of channel for ensuring unrestricted flow of water.
- (3) **Disposal of waste water.**
  - (a) PP should ensure linkage with municipal sewer line for disposal of waste water as committed the letter dtd. 15.02.16.
  - (b) The treated wastewater of 480.3KLD shall be recycled and reused for flushing (173.5 KLD) and gardening (41.5 KLD) Miscellaneous (4.9KLD) to reduce the demand of fresh water.
  - (c) Ensure regular operation and maintenance of the STP.
  - (d) The Project Proponent shall explore the possibilities of reusing the treated wastewater from nearby projects during rainy season.
- (4) The final disposal point for storm water will be municipal storm drain if storm water network is present. If storm water network is absent, the storm water surface runoff should be disposed off in proper way. The budget should be including in EMP plan for storm water management.
- (5) **Solid Waste Management:**
  - (a) Provide compactors for MSW.
  - (b) Separate wet and dry bins must be provided at the ground level for facilitating segregation of waste.
  - (c) The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry inert solid waste should be








disposed off to the approved sites for land filling after recovering recyclable material.

- (6) PP should ensure road width, front MOS and side / rear as per MPBVR 2012 and increase the internal road widths from 6m to 7.5m as proposed.
- (7) For firefighting:-
  - (a) PP should ensure connectivity to the fire station from the project site.
  - (b) As per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Municipal Corporation, Indore) incorporating all the fire fighting measures recommended in National Building Code Part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Municipal Council only after ensuring that all fire fighting measures are physically in place.
- (8) For Rain Water Harvesting, and Ground water recharge:-
  - (a) PP should ensure the rain water harvesting with 06 nos of recharging pits and these pits should be connected laterally to consume the surplus runoff. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.
  - (b) Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease. The bore well for rainwater recharging should be kept at least 4 mts. above the highest ground water table.
  - (c) The unpaved area shall be more than or equal to 20% of the recreational open spaces.
- (9) PP should ensure to provide car parking as proposed ECS (Open- 1037 ECS, Stilt – 14 ECS).
- (10) For Energy Conservation PP should Ensure :-
  - (a) Use of LED lights in the common areas, landscape areas, and boundary compound walls etc.
  - (b) Solar lights provide for common amenities like Street lighting & Garden lighting.
  - (c) For power back up ensure to provide 04 no. DG set capacity of 4\*650 = 2600 KVA (for common areas and essential services only)
  - (d) PP should also ensure to adopt energy conservation measure as per the latest State Govt. Policy for generating roof top solar energy and make use of the subsidies to be granted as per the policy. Any surplus generation from solar energy should be ploughed back in the grid to generate additional revenues for the proposed RWA.
- (11) **Air Quality and Noise:-**
  - (a) Dust, smoke & debris prevention measures such as wheel washing, screens, barricading & debris chute shall be installed at the site during

construction including plastic/tarpaulin sheet covers for trucks bringing in sand & material at the site.

- (b) The exhaust pipe of the DG set if installed must be minimum of 10mtr away from the building or in case it is less than 10m away, the exhaust pipe shall be taken up to 6m above the building.

### (12) Green belt :-

- (a) PP should ensure plantation by planting 1200 nos of trees in two rows in periphery, along the road, around open space area, parking area and other amenities. Trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar, Saptparni etc. should be planted.
- (b) Every effort should be made to protect the existing trees Pipal, Neem and Imli on the plot.
- (c) PP should obtain permission from concerned authority to cut the trees and plant additional trees as compensatory.
- (d) Explore the possibility to retain more than 64 numbers of trees.
- (e) The green belt of the adequate width and density preferably with local species along the periphery of the plot shall be raised so as to provide protection against particulates and noise.
- (13) In the case of future expansion in the scope or any changes(s) in the scope of the project shall again require Prior Environmental Clearance as per EIA notification, 2006.
- (14) The project authorities shall earmark adequate funds to implement the conditions stipulated by SEIAA/SEAC along with the implementation schedule for all the conditions stipulated herein. The funds so provided shall not be diverted for any other purpose.

Mining Officer, Datia should submit the detail of mines in 500 m. periphery showing status of mines like date of sanction, whether operative or not, EC granted or under appraisal etc. Mining Officer, Datia should be asked to submit this information latest by 15.12.2016. Copy to PP.

3. **Case No.-5377/2016:** Prior Environment Clearance for River Sand in an area of 7.060 ha. for production capacity of 23,400 cum per annum at Khasra no.578, 599, 741, 787 at Village- Khera Shyampura-3, Tehsil - Bhind, Dist. Bhind (MP) by M/s Shri Individual, Shri Brajendra Singh Tomar, 101, 102, Adityapuram, Bhind Road, Grid Maharajapura, A.F., Dist. Gwalior, (MP).

The case was recommened in 54<sup>th</sup> SEAC-II meeting dtd. 14.10.2016 and it was recorded that :-

*".....The case was presented by the PP and their consultant wherein during scrutiny of documents it was observed by the committee that sanctioned mining leases is in 04 parts and is not contiguous in nature and also not in accordance with the MP MMR, 1996 rule 04 (3). The committee also observed that single mine plan is prepared for the above leases. Earlier in cases of similar nature (please refer the minutes of 231st SEAC meeting dated 27/10/2015 and subsequent decision taken by SEIAA in its 327th meeting dated 05/05/2016) SEIAA has decided to close the case. The committee decided to forward this case to SEIAA for further considerations and necessary action."*

5. **Case No. - 4002/15:** Prior Environment Clearance for Sand Quarry in an area of 15.800 ha. for production capacity of 1,58,000 cum/year at Khasra No.-825, Vill.-Khamroli, Tehsil-Sewada, District-Datia (MP) by Shri Vaibhav Singh Yadav, M/s Shri Murli Construction R/o 27, Jyoti Nagar, Thatipur, District-Gwalior (MP)-474003.

The case was recommended in 54<sup>th</sup> SEAC-II meeting dtd. 14.10.2016 and it was recorded that :-

*".....The case was presented by the PP and their consultant in the 52nd SEAC meeting dated 12/10/2016 and during presentation it was observed that as per the Google image of Dec 2015 based on the co-ordinates provided by the PP that approx. 40% of the lease area is submerged in water. Thus remaining 60% area is minable and 94,800 cum/year sand can be evacuated. It was also observed that a bridge like structure was observed which appear to be incomplete. PP submitted that it is a crossway which is kachha in nature. PP & OIC, State Mining Co-operation were present during discussion were asked to submit photographs and certificate of Tehsildar/competent authority for confirmation of their submission for further consideration of this project.*

*PP vide letter dated 14/10/2016 have submitted photographs and certificate issued by the Nayab Tehsildar issued vide letter no. 78/2016 dated 13/10/2016 stating that there is no bridge in the lease. Since there is no bridge in existence in the QL area as per the certificate of Tehsildar the issue regarding existence of bridge in the QL area is resolved. ".....SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP..

The case was presented today by the PP and their consultant and during presentation it was observed that as per the Google image of March 2014, as per the co-ordinates provided by the PP, that there is a road bridge on the southern side of the QL area, thus PP was asked to leave 200 meters from the southern sides of the road bridge as per the sand guidelines of MOEF & CC {Protection of infrastructure-Pont no.-49:-For carrying out mining in proximity to any bridge or embankment, appropriate safety zone (not less than 200 meters) should be worked out on case to case basis, taking into account the structural parameters, location aspects and flow rate, and no mining should be carried out in the safety zone so worked out.}. Leaving 200 meters from the southern side of the road bridge, only 35% of the lease area remains as minable and thus only 82,600 cum/year sand can be evacuated from this QL. The other submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':."

PP has provided additional information regarding number of mines within 500 m. periphery and reported 5 mines with an area of 62.367 ha.

Based on the above recommendation, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC-II :-

- (i). PP shall not start mining activity before execution of lease agreement.

The case was recommended in 54<sup>th</sup> SEAC-II meeting dtd. 14.10.2016 and it was recorded that :-

*".....SEIAA vide letter no. 3902/SEIAA/16 dated 06/10/2016 has sent back the file to SEAC for re-appraisal as "it was observed from the mine plan that this is a case of dolomite and bauxite mining and should have been treated as a major mineral case", and the same was placed before the committee. PP has also submitted a representation vide letter dated 10/10/2016. The committee again referred the mine plan and other documents submitted by the PP and observed that:*

*1. In form-1 (point no. 2.3), PP has applied only for the dolomite mineral for production capacity of 51,503 TPA. Similarly, the PFR is also prepared only for dolomite mineral.*


*2. In mine plan Chapter "RESERVE ASSESSMENT IN GEOLOGY" it is clearly mentioned that only dolomite was found to occur in the lease area and no existence of mineral bauxite has been noticed in the lease area.*


*3. In mine plan Chapter "RESERVE", since 1999-00 only dolomite is excavated from the ML and mineral reserves are also shown for dolomite mineral. No proposal for excavation of bauxite has been shown in the approved mine plan.*


*The committee after deliberations decided that as per mine plan and form-1 submitted by PP, it's a case of dolomite mining and may be transferred to DEIAA through SEIAA as per GOI, MoEF&CC notification dated 15/01/2016 as the lease area is of 03 years and one mine with an area of 1.20 ha is also non-operative since lease 02 years."*

As per the above observation, SEAC has clarified that this is a case of dolomite mining only and no bauxite mining is observed from the mining plan. However to ensure conformity of the minerals whether this is a case of dolomite only or it is combination of dolomite & bauxite, a letter be sent to Director, Geology & Mining, Bhopal. Copy to PP.
