



desired by the committee during the deliberation. Committee decided to recommend the case for delisting as per the minutes of 364th SEIAA meeting dated 02/09/2016 assuming that PP is not interested to continue with the project."

This case was delisted in 342th SEIAA meeting dtd. 21.06.2016 and thereafter relisted in 364th SEIAA meeting dtd. 02.09.2016, wherein the PP was forewarned that in case he doesn't appear before SEAC then the case will be closed. SEAC in its above observation has recommended that due to non appearance by PP the case may be delisted. However the committee feels that PP has been given ample chance to present their case and they seem to be disinterested in pursuing their project and decide to close the case. 
"PP vide their letter dated 23/09/2016 has submitted the desired information containing "Ekal Pramnpatra" and letter from DFO. Concerned Collector, through "Ekal Pramnpatra" vide letter no.557, dated: 31/03/16, has reported that there are no more mines operating or proposed within 500 meters around the said mine.


The case was presented today by the PP and their consultant and during presentation it was observed that the other submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':"

Based on the above recommendation, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC-II :-

- (i). PP shall not start mining activity before execution of lease agreement.
- (ii). The production capacity shall be limited to the quantity as recommended by SEAC-II.
- (iii). No in-stream mining shall be allowed. The Mining Officer, Anuppur should ensure that the mining activity is confined only in the dry portion of the river where sand is exposed.


This case was discussed in 58th SEAC-II meeting dated 10-11-16 and it was recorded that :-

"The case was presented today by the PP and their consultant and during presentation it was observed that as per the Google image of Feb 2016 based on the co-ordinates provided by the PP, only 15 % area is available for sand evacuation rest QL area is submerged in water body. Since QL area is of 23 ha with depth as per mine plan is 2 meter thus the proposed volume of sand can easily be evacuated from the rest part of the lease area which is not submerged in the water. Two bridges are also seen in the Google image which are in northern side but and approx. 300 meters away and thus no area deduction is required. A natural stream is also joining the upper side of the lease at western direction, thus 100 meters of area should be left as no mining area and no sand would be evacuated from this lease area. The other submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':"

Based on the above recommendation, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC-II :-

- (i). PP shall not start mining activity before execution of lease agreement.
- (ii). The production capacity shall be limited to the quantity as recommended by SEAC-II.
- (iii). Safe distance of 300 m. be kept as no mining zone from the existing railway bridge and the area should be properly demarcated in the presence of railway, revenue and mining officials.




5. **Case No. - 3099/15** - Prior Environmental Clearance for Uchan River Sand Quarry (Open cast manual method) in an area of 22.00 ha., for production capacity of 1,00,000 cum/year at Khasra No.-1/1, Vill.-Uchan, Teh.-Handiya, District-Harda (MP) by M.P. State Mining Corporation Ltd., Shri Raj Kumar Nema, OIC, Sub Off., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP)-461001.

This case was discussed in 58th SEAC-II meeting dated 10-11-16 and it was recorded that :-

"Today, case was again placed in agenda and during presentation by PP and their consultant it was observed by the committee that PP has submitted the Collector's letter issued vide letter dated 09/06/2016 wherein it is informed that at present lease is not affected by the submergence of Indra Sagar Dam then partially submerged in water and is on the upstream of the dam. It is further submitted by the collector that due to the flowing water of Narmada River, the lease area is partially submerged in it and this submergence is increased during rainy season. Committee further observed that as per the Google image of Jan.2016 based on the co-ordinates provided by the PP, the availability of the lease area which is not submerged in water is only 30% and rest 70 % of QL area is submerged in water. Committee observed that as per the revised mine plan only 6.00 ha area is required for the evacuation of 1,00,000 cum/year of sand and with the available 30% area i.e. 6.6 ha which is not submerged in water, the proposed volume of sand evacuation is possible. The other submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':"

The replenishment plan submitted by PP has mentioned that annual production capacity of 112000 cum/year shall be easily replenish from the quarry lease area of 22 ha. SEAC in its above observation has pointed out only 30% of quarry lease area is exposed for sand mining and rest 70% is submerged. It appears that PP will resort to in stream mining for achieving the proposed production capacity it has been decided to send the file back to SEAC for reappraisal. They should also call for fresh NOC of the number of mines within 500 m. periphery from the Mining Officer, Harda. Copy to PP.

"The case was presented by the PP and their consultant wherein during presentation it was observed as per the Google image of April 2013 based on the co-ordinates provided by the PP, approximately 50 % of the lease area is submerged in water but only 10,000 cum/year of sand is required which can be easily evacuated from the remaining area. The submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':

From the record available, Mining Officer, Ratlam has submitted the information about the number of mines in 1000 m. periphery. But in the latest notification information is desired within 500 m. periphery. Mining Officer, Ratlam should submit the detail of mines in 500 m. periphery showing status of mines like date of sanction, whether operative or not, EC granted or under appraisal etc. Mining Officer, Ratlam should be asked to submit this information latest by 30.12.2016. Copy to PP.

"The case was presented by the PP and their consultant wherein PP submitted that there is no water body near the lease area and water filled old mined out pit is in existence within the QL area. PP further submitted that they have left 100 meters area from the highway and QL as no mining area as per the requirement of MMR Rule, 1996. The committee after deliberations decided that since PP has left desired distance as per their letter dated 24/08/2016 from the National highway and submitted the revised map, case can be recommended for EC as per the 214th SEAC meeting dated 20/08/2015 with following special conditions in addition to the standard conditions at annexure 'A':

From the google map it appears to be too close to the state highway and therefore in total contravention of the MMR rules 1996 (and its subsequent amendments). Mining Officer, Indore may be asked to demarcate the useable mining area after marking 100 m. from the state highway. Collector, Indore should then review the

"The case was discussed in the 260th SEAC meeting dated 07/01/2016 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':

- Production of Stone as per mine plan with quantity not exceeding 8,550 cum/year.

SEIAA vide letter no. 3434/SEIAA/16 dated 08/09/2016 has sent back the file for clarification as a railway track is in close proximity of the QL and whether it will cause adverse impact which was placed before the committee. The committee observed that earlier SEAC has observed in their minutes of 260th meeting that a railway track is about 250 meters away from the ML area. The committee again refer the Google image based on the co-ordinates provided by the PP and it was observed that the distance from the railway track is >250 meters and as per MMR Rule, 1996, the minimum distance from the railway track should be 100 meters. Since the QL is in close proximity of the railway track, PP should be permitted only for controlled blasting with wet drilling to reduce the impact of vibrations"





"However, later on Mining Officer, Gwalior vide letter dated 02/07/2015 has mentioned the area as 1.582 ha. but all the other certificates/documents attached with the case file exhibit the lease area as 2.00 ha, the Committee after deliberations recommends that since the case lies in the pervue of DEIAA and SEAC has already recommended for its transfer in the 47th SEAC II meeting, the case file, may be transferred to DEIAA with mentioning of above discrepancies for onward verification and necessary considerations at their level".

As per the above observation, it has been decided to close this case in SEIAA and appraise it in DEIAA, Gwalior with the following instructions :-

While appraising, directives given by the Hon'ble NGT from time to time should also be binding on the PP and other agencies/respondents. For commencement of mining activity, decision/directives by the Hon'ble NGT should be honoured.
4. Even if the PP has applied in DEIAA afresh, the comments/conditions specified by SEIAA/SEAC should be accounted for while taking a final decision.
5. Gwalior has been designated by WHO as the most polluted town in the country and therefore any future activity which adds to the critical pollution load should be meticulously appraised considering the scale and concentration of mining

activities like drilling, blasting, collection of material, crushing, hauling and transportation.

6. Although the mining leases granted before 09.09.2013 will be treated as individual cases of B2 category and it will not attract provision relating to cluster situation, however it will be prudent to appraise these cases with environmental related impacts preferably a Comprehensive Environmental Management Plan (of complete region). It should be made mandatory to be a part of the Approved Mine Plan.
7. Normally the PP establish a crusher on the mining lease area, they should follow the norms to be prescribed by MPPCB.
8. While appraising cases of minor minerals, MMR 1959 (amended 2013) should be strictly followed.
9. Mining activities clubbed with industrial activity concentration that to in close proximity of urban agglomeration shall create heavy pollution load which would be detrimental to human health. While appraising this possibility should be remedied by counter measures like thick plantation in and around the mining cluster through CSR funds. The old and abandoned mines should be used for storing water to be used for up-keep of plantation.
10. Care should be taken to keep safe distance of mining activity from the pakka road and plant trees as many as possible on both sides of the pakka road.
11. No mining activity should be permitted in the nalla portion/discharge zone.
12. Proper transport routes should be identified which should not pass through the human habitation areas. Preferably pakka roads be constructed from the CSR funds to transport the material. This would deter air pollution.
13. Proper air and water monitoring should be carried out in the mining zone in consultation with MPPCB.
14. Overburden dumps should be properly stored and stabilized in proper scientific manner.
15. Only controlled blasting should be permitted.
16. Proper arrangement for labour welfare as per the guidelines/norms issued by the Department of Labour should be followed in letter and spirit.

It has also been decided to transfer the case file to DEIAA Gwalior for onward action. Copy to PP and all concerned.






