The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

- 1. Case No. – 6363/2019 Shri Deval Mishra, A-Block, 3/5 Dutt Arcade, Civil Lines, Jabalpur, MP Prior Environment Clearance for Stone Quarry in an area of 8.00 ha. (35,000 cum per annum) (Khasra No. 18 Part), Village - Navegaon, Tehsil - Chhindwara, Dist. Chhindwara (MP).**

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 18 Part), Village - Navegaon, Tehsil - Chhindwara, Dist. Chhindwara (MP) 8.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 137 dated: 24/05/19 has reported that there is one more mine operating or proposed within 500 meters around the said mine with total area of 16.0 ha., including this mine.

The case was scheduled for the presentation 375th SEAC meeting dated 29.06.2019 but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

In this meeting, this case was again scheduled for presentation wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 375th SEAC meeting dated 29.06.2019. Committee decided to call the PP in subsequent meetings giving last chance to present their case and even if PP remains absent the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is case of Crusher Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 378/1), Village - Basahari, Tehsil - Khurai, Dist. Sagar (MP) 3.90 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 379 dated: 20/02/19 has reported that there are 09 more mines operating or proposed within 500 meters around the said mine with total area of 17.20 ha., including this mine.

The case was scheduled in the SEAC 372nd meeting dated 22-05-19 for the presentation but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings.

The case was again scheduled for presentation 383rd SEAC meeting dated 10/07/2019, wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the SEAC 372nd meeting dated 22-05-19. Committee decided to give last chance to PP for making presentation in the subsequent meetings of SEAC after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

In this meeting this case was again scheduled for the presentation but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier PP was also absent in the 383rd SEAC meeting dated 10/07/2019 & SEAC 372nd meeting dated 22-05-19. Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 298 dated: 14/01/19 has reported that there are 07 more mines operating or proposed within 500 meters around the said mine with total area of 20.371 ha., including this mine.

It was informed to the committee that a sub-committee has carried out the site visit of this lease on dated 02/08/2019 and members of sub-committee discussed the site visit report of all the mines carried out on 02/08/2019 & 03/08/2019. Committee after deliberations decided that the discussed site visit report shall be minitised in this meeting and recommendations made by sub-committee shall be stipulated in the TOR of this case as additional TOR. Committee after deliberations decided that being it's a case Stone Quarry with total area of 20.371 ha., and according to the latest O.M F.No. L11011/175/2018/-IA-II (M) dated 12/12/2018 if a cluster or an individual lease exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior environmental clearance and thus committee decided to issue standard TOR prescribed by the MoEF&CC may be issued for conducting the EIA with following additional TORs and as per conditions mentioned in Annexure-D:-

1. Proposed evacuation route with gradient avoiding habitations shall be discussed in the EIA report as site is located on a hillock of 35 to 40 meters high.
2. Difference between top most RL and ground RL shall be provided in the EIA report to assess the actual height of the hill.

3. Actual distance of site from habitations with their protection plan shall be submitted in EIA report.
 4. Proposed depth of mine from ground level and if ground water intersection is envisaged geo-hydrological studies shall be carried out.
 5. Proposal for extensive green belt plan considering the high volume of mining shall be provided in EIA report with inventory of existing green belt.
 6. Proposal for pucca evacuation road (to carry 40 MT truck load) with atleast 7.5 meters width and shoulders of 0.5 meters each on both sides shall be furnished in the EIA report.
 7. Transportation shall be done with 40 MT truck load capacity to minimize the number of trips.
 8. If crusher is proposed on site, same shall be of latest technology such as cone type, equipped with air pollution control devises, water sprinkling arrangements, wind breaking wall etc and the complete details shall be furnished with EIA report.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 2212 dated: 18/03/19 has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was scheduled for the presentation in 380th SEAC meeting dated 05.07.2019 but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. This is case of Flagstone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 17/1 Part), Village - Baheriya, Tehsil - Jabera, Dist. Damoh (MP) 0.49 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 190 dated: 09/03/19 has reported that there is no more mine operating or proposed within 500 meters around the said mine.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed

format duly verified in the Collector Office letter No. 708 dated: 25/04/19 has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was scheduled for the presentation 380th dated 05.07.2019 SEAC meeting but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

In this meeting, this case was again scheduled for presentation wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 380th SEAC meeting dated 05.07.2019. This is case of Crusher Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 92/2 Ka, 92/2 Kha), Village - Bhadkul, Tehsil - Rehti, Dist. Sehore (MP) 2.770 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 104 dated: 10/04/19 has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was scheduled for the presentation 380th SEAC meeting dated 05.07.2019 but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

The case was presented by PP and their consultant, wherein PP submits that Concerned QL area is well connected with approach road (495m long) which meets with village road at north east side. Transportation route will be maintained by lessee at his own cost. During presentation some developmental activities were observed on site as per Google image for which PP submitted that installation for crusher was initiated by them in 2018 but later it was decided to install jaw crusher of 50 TPH and thus the installation was stopped and no mining is carried out by them till that. A natural drain and canal is also passing near the lease from the eastern side & western side and are > 50 meters and >450 meters respectively away from the lease. After presentation, PP was asked to submit following details for further consideration of this case:

1. Copy of lease agreement is to be submitted.
2. OB and waste management plan.
3. Commitment for installation of jaw crusher.
4. Revised water balance chart as discussed during presentation.
5. Revised plantation details w.r.t its number, species as suggested during presentation.
6. Revised EMP by adding cost of water
7. Details of the crusher used.

PP has submitted the response of above quarries same date vide letter dated 10.08.2019, which was placed before the committee and the same found satisfactory. The EMP and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':

1. Production shall be as per mine plan with quantity not exceeding for Stone 40,000 cum/annum.
2. A budgetary provision for Environmental management Plan of Rs. 13.26 Lakh as capital and Rs. 3.09 Lakh/year. Under CER Rs. 0.60 Lakh/ year has proposed.

11. Case No. – 6176/2019 Shri Govind Rai, Tar Ahata, Tehsil & Dist. Hoshangabad, MP Prior Environment Clearance for Stone Quarry in an area of 0.971 ha. (8,000 cum per annum) (Khasra No. 308/1P), Village - Samnapur Kalan, Tehsil - Goharganj, Dist. Raisen (MP).

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 308/1P), Village - Samnapur Kalan, Tehsil -

Goharganj, Dist. Raisen (MP) 0.971 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 220 dated: 12/03/19 has reported that there are 03 more mines operating or proposed within 500 meters around the said mine with total area of 4.852 ha., including this mine.

The case was presented by the PP and their consultant in 372nd SEAC meeting dated 22/05/2019. During presentation as per Google image PP stated that the displayed lease was not the actual lease which belongs to him. Committee observed that there is variation in co-ordinates. Thus PP was asked to submit the corrected coordinates of site duly verified by the competent authority for further consideration of the case.

This case was scheduled for the presentation and discussion as PP has submitted the revised co-ordinates of the lease boundary which were asked by the committee in 372nd SEAC meeting dated 22/05/2019 and the same was placed before committee. The case was presented by PP in the 352nd SEAC meeting dated 18/03/2019 wherein it was observed as per Google image based on the co-ordinates provided by the PP that a water body/water channel seems to be in existence in the allotted area with some trees for which PP summated that this in rainy water accumulated in the low lying area (which was created due to excavation of soil for road construction by unknown operator before the allotment of this plot to them) as the Google image is of September, 2018 and existing trees are shrubs grown up naturally in the rainy season. Committee discussed that there are two issues i.e. existence of water body and trees in the allotted area and after deliberations decided to carryout site inspection by a subcommittee of SEAC for confirmation of above.

Dr. Rameshwar Maheshwari and Dr. Rubina Chaudhary, Member, SEAC M.P., visited the site on 27/07/2019 along with Dr. Abhaya K. Saxena, Senior Scientific Officer, MPPCB, Bhopal. PP alongwith their consultant and Mr. Singh, AKVN were also present during site visit.

OBSERVATION

During site visit it was observed by the committee that the site is located in the industrial area with developed road infrastructure and in the SEZ pharma zone phase II with 24,290 sq. meter area. The site is undulating having level difference as east side is on higher elevation and western side in on lower elevation. Mr. Singh, AKVN official present during site visit informed that earlier stone quarrying were operated on this hilly area which created undulation and pit in the allotted area which certainly requires leveling up to certain extent. During site visit it was observed that babool trees and some shrubs have grown in the lease area which needs to be uprooted. The site is well connected through tar road from all the sides. No construction or other developmental activities were observed at the site during site inspection.

RECOMMENDATIONS

Committee after site inspection recommends that standard TOR prescribed by the MoEF&CC to conduct EIA report may be provided to the PP with inclusion of following additional points:

1. Since there is level difference in the allotted plot, the detailed layout and proposed scheme of development shall be discussed in the EIA report.
2. Protection against runoff shall be detailed out in the EIA report.
3. The inventory of existing trees shall be provided in the EIA report.

4. Mechanism proposed for the recovery of solvent with details of individual solvents shall be detailed out in the EIA report.
5. Mechanism of storing raw materials with their compatibility shall be detailed out in the EIA report.
6. Application of MSIHC Rules in case of all the chemicals used in the plant shall be discussed in the EIA report with their recent MSDS.
7. Auxiliary details such as number of thermic fluid heaters, boilers, chillers etc. should be provided in EIA report.
8. Worst case scenario shall be studied and discussed in the EIA report.

Committee after deliberations decided that above recommendations may be sent to SEIAA and Standard TOR as stipulated by MoEF&CC may be issued with additional TOR points as suggested by committee.

This is case of Stone Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 225/1), Village - Jamodi, Tehsil - Dhar, Dist. Dhar (MP) 1.262 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 1172 dated: 12/06/17 has reported that there is 07 more mine operating or proposed within 500 meters around the said mine with total area of 15.778 ha., including this mine.

BACKGROUND

The case was presented by PP in the 374th SEAC meeting dated 25/05/2019 wherein committee after deliberations decided to carryout site visit where large volume of mining activities are in operation in the vicinity with total area of 15.778 ha., including this mine.

Dr. Rameshwar Maheshwari and Dr. Rubina Chaudhary, Member, SEACM.P., visited the site on 27/07/2019 along with Dr. Abhaya K. Saxena, Senior Scientific Officer, MPPCB, Bhopal. Shri Ramnarayan Mukati, representing PP was also present during site visit.

OBSERVATION

The site is located on the foothill near village Kheda adjacent to the site of Shri Ramnarayan Mukati. The site is also almost flat and connected with the existing haul road of other mines. No mining activities were observed during inspection. The upper layer of the lease contains Murrum followed by basalt. The site is connected with tar and CC road which meets Pithampur IA. The other mines which were operating in the near vicinity and having crushers have provided MS wind breaking walls which needs improvement as there was lots of space between two sheets. PP was asked to convey this observation to nearby mines for efficient control of pollution through their association. During discussion PP informed that crusher is also proposed on this lease and thus was advised to install crusher which has inbuilt mechanism of air pollution control.

The above site inspection report was placed before the committee and sub-committee member appraised the IR to the committee. Committee recommends that above IR may be placed during the appraisal of the EIA of this project.

This is case of Stone Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra No. 1022/1), Village - Kheda, Tehsil - Dhar, Dist. Dhar (MP) 1.254 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 1171 dated: 12/06/17 has reported that there is 07 more mine operating or proposed within 500 meters around the said mine with total area of 15.778 ha., including this mine.

BACKGROUND

The case was presented by PP in the 374th SEAC meeting dated 25/05/2019 wherein committee after deliberations decided to carryout site visit where large volume of mining activities are in operation in the vicinity with total area of 15.778 ha., including this mine.

Dr. Rameshwar Maheshwari and Dr. Rubina Chaudhary, Member, SEACM.P., visited the site on 27/07/2019 along with Dr. Abhaya K. Saxena, Senior Scientific Officer, MPPCB, Bhopal. Shri Ramnarayan Mukati, PP along with his supporting staff was also present during site visit.

OBSERVATION

The site is located on the foothill near village Kheda. The site is almost flat and connected with the existing haul road of other mines. No mining activities were observed during inspection. The outcrop of basalt was visible in some parts of lease. The site is connected with tar and CC road which meets Pithampur IA. The other mines which were operating in the near vicinity and having crushers have provided MS wind breaking walls which needs improvement as there was lots of space between two sheets. PP was asked to convey this observation to nearby mines for efficient control of pollution through their association. During discussion PP informed that crusher is also proposed on this lease and thus was advised to install crusher which has inbuilt mechanism of air pollution control. HT line is also crossing near the lease for which PP submitted that mandatory prohibited area is already deducted by the mining officer at the time of lease allotment.

The above site inspection report was placed before the committee and sub-committee member appraised the IR to the committee. Committee recommends that above IR may be placed during the appraisal of the EIA of this project.

12. To avoid vibration, no overcharging shall be carried out during blasting and muffle blasting shall be adopted. Blasting shall be carried out through certified blaster only and no explosive will be stored at mine site without permission from the competent authority.
13. Mine water should not be discharged from the lease and be used for sprinkling & plantations. For surface runoff and storm water garland drains and settling tanks (SS pattern) of suitable sizes shall be provided.
14. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
15. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.

20. All the mines where production is > 50,000 cum/year, PP shall develop its own website to display various mining related activities proposed in EMP & CER alongwith budgetary allocations. All the six monthly progress report shall also be uploads on this website alongwith MoEF&CC & SEIAA, MP with relevant photographs of various activities such as garland drains, settling tanks, plantation, water sprinkling arrangements, transportation & haul road etc. PP or Mine Manager shall be made responsible for its maintenance & regular updation.
21. All the soil queries, the maximum permitted depth shall not exceed 02 meters below general ground level & other provisions laid down in MoEF&CC OM No. L-11011/47/2011-IA.II(M) dated 24/06/2013.

Annexure- 'B'

Standard conditions applicable for the Sand Mine Quarries*

1. District Authority should annually record the deposition of sand in the lease area (at an interval of 100 meters for leases 10 ha or > 10.00 ha and at an interval of 50 meters for leases < 10 ha.) before monsoon & in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority shall allow lease holder to excavate only the replenished quantity of sand in the subsequent year.
2. The lease boundary should be clearly demarcated at site with the given co-ordinates by pillars. Necessary safety signage & caution boards shall be displayed at mine site.
3. Overhead sprinklers arrangements with solar pumps should be provided for dust suppression at the exit of the lease area and fixed types sprinklers on the evacuation road. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded.
4. The mining activity shall be done manually and as per the land use plan & approved mine plan submitted by PP.
5. No heavy vehicles shall be allowed to enter the river bed and the transportation of the sand from the excavation pits of the leased area to the loading point shall be through trolleys (tractor trolleys) and not by heavy vehicles. Only registered tractor trolleys which are having the necessary registration and permission for the aforesaid purpose under the Motor Vehicle Act and also insurance coverage for the same shall alone be used for said purpose.
6. Transportation of material shall only be done in covered & PUC certified vehicles with required moisture to avoid fugitive emissions. Transportation of minerals shall not be carried out through forest area without permissions from the competent authority.
7. Mineral evacuation road shall be made pucca (WBM/black top) by PP.
8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.

9. No Mining shall be carried out during Monsoon season.
10. The depth of mining shall be restricted to 3m or water level, whichever is less. No in-stream mining is allowed. Established water conveyance channels should not be relocated, straightened, or modified.
11. The mining shall be carried out strictly as per the approved mine plan and in accordance with the Sustainable Sand Mining Management Guidelines, 2016 issued by the MoEF&CC ensuring that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
12. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
13. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
14. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
15. Thick plantation shall be carryout on the banks of the river adjacent to the lease, mineral evacuation road and common area in the village. PP would maintain the plants for five years including casualty replacement. PP should also maintain a log book containing annual details of tree plantation and causality replacement and to take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
16. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat/competent authority.
17. Six monthly occupational health surveys of workers shall be carryout and all the workers shall be provided with necessary PPE's. Annexure- 'C'

Standard conditions applicable for the Sand deposits on Agricultural Land/ Khodu Bharu Type Sand Mine Quarries*

1. Mining should be done only to the extent of reclaiming the agricultural land.
2. Only deposited sand is to be removed and no mining/digging below the ground level is allowed.
3. The mining shall be carried out strictly as per the approved mining plan.
4. The lease boundary should be clearly demarcated at site with the given co-ordinates by pillars and necessary safety signage & caution boards shall be displayed at mine site.
5. Overhead sprinklers arrangements with solar pumps should be provided for dust suppression at the exit gate of the lease area and fixed types sprinklers on the evacuation road. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded.
6. The mining activity shall be done as per approved mine plan and as per the land use plan submitted by PP.
7. Transportation of material shall only be done in covered & PUC certified vehicles with required moisture to avoid fugitive emissions. Transportation of minerals shall not be carried out through forest area without permissions from the competent authority.
8. Mineral evacuation road shall be made pucca (WBM/black top) by PP.
9. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
10. No Mining shall be carried out during Monsoon season.
11. The mining shall be carried out strictly as per the approved mine plan and in accordance with the Sustainable Sand Mining Management Guidelines, 2016 issued by the MoEF&CC.
12. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
13. Thick plantation shall be carryout on the banks of the river adjacent to the lease, mineral evacuation road and common area in the village. PP would maintain the plants for five years including casualty replacement. 19. NOC of Gram Panchayat should be obtained for the water requirement and forest department before uprooting any trees in the lease area.
20. The leases which are falling <250 meters of the forest area and PP has obtained approval for the Divisional Level Commissioner committee, all the conditions stipulated by Divisional Level Commissioner committee shall be fulfilled by the PP.
21. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.
22. If it being a case of Temporary Permit (TP), the validity of EC should be only up to the validity of TP and PP has to ensure the execution of closure plan.

Annexure- 'D'

General conditions applicable for the granting of TOR

1. The date and duration of carrying out the baseline data collection and monitoring shall be informed to the concerned Regional Officer of the M.P Pollution Control Board.
2. During monitoring, photographs shall be taken as a proof of the activity with latitude & longitude, date, time & place and same shall be attached with the EIA report. A drone video showing various sensitivities of the lease and nearby area shall also be shown during EIA presentation.
3. An inventory of various features such as sensitive area, fragile areas, mining / industrial areas, habitation, water-bodies, major roads, etc. shall be prepared and furnished with EIA.
4. An inventory of flora & fauna based on actual ground survey shall be presented.
5. Risk factors with their management plan should be discussed in the EIA report.
6. The EIA report should be prepared by the accredited consultant having no conflict of interest with any committee processing the case.
7. The EIA document shall be printed on both sides, as far as possible.
8. All documents should be properly indexed, page numbered.
9. Period/date of data collection should be clearly indicated.
10. The letter /application for EC should quote the SEIAA case No./year and also attach a copy of the letter prescribing the TOR.
11. The copy of the letter received from the SEAC prescribing TOR for the project should be attached as an annexure to the final EIA/EMP report.
12. The final EIA/EMP report submitted to the SEIAA must incorporate all issues mentioned in TOR and that raised in Public Hearing with the generic structure as detailed out in the EIA report.
13. Grant of TOR does not mean grant of EC.
14. The status of accreditation of the EIA consultant with NABET/QCI shall be specifically mentioned. The consultant shall certify that his accreditation is for the sector for which this EIA is prepared. If consultant has engaged other laboratory for carrying out the task of monitoring and analysis of pollutants, a representative from laboratory shall also be present to answer the site specific queries.
15. On the front page of EIA/EMP reports, the name of the consultant/consultancy firm along with their complete details including their accreditation, if any shall be indicated. The consultant while submitting the EIA/EMP report shall give an undertaking to the effect that the prescribed TORs (TOR proposed by the

- project proponent and additional TOR given by the MOEF & CC) have been complied with and the data submitted is factually correct.
16. While submitting the EIA/EMP reports, the name of the experts associated with involved in the preparation of these reports and the laboratories through which the samples have been got analyzed should be stated in the report. It shall be indicated whether these laboratories are approved under the Environment (Protection) Act, 1986 and also have NABL accreditation.
 17. All the necessary NOC's duly verified by the competent authority should be annexed.
 18. PP has to submit the copy of earlier Consent condition /EC compliance report, whatever applicable along with EIA report.
 19. The EIA report should clearly mention activity wise EMP and CSR cost details and should depict clear breakup of the capital and recurring costs along with the timeline for incurring the capital cost. The basis of allocation of EMP and CSR cost should be detailed in the EIA report to enable the comparison of compliance with the commitment by the monitoring agencies.
 20. A time bound action plan should be provided in the EIA report for fulfillment of the EMP commitments mentioned in the EIA report.
 21. The name and number of posts to be engaged by the PP for implementation and monitoring of environmental parameters should be specified in the EIA report.
 22. EIA report should be strictly as per the TOR, comply with the generic structure as detailed out in the EIA notification, 2006, baseline data is accurate and concerns raised during the public hearing are adequately addressed.
 23. The EIA report should be prepared by the accredited consultant having no conflict of interest with any committee processing the case.
 24. Public Hearing has to be carried out as per the provisions of the EIA Notification, 2006. The issues raised in public hearing shall be properly addressed in the EMP and suitable budgetary allocations shall be made in the EMP and CER based on their nature.
 25. Actual measurement of top soil shall be carried out in the lease area at minimum 05 locations and additionally N, P, K shall be analyzed in all soil samples.

FOR PROJECTS LOCATED IN SCHEDULED (V) TRIBAL AREA , following should be studied and discussed in EIA Report before Public Hearing as per the instruction of SEIAA vide letter No. 1241 dated 30/07/2018.

26. Detailed analysis by a National Institute of repute of all aspects of the health of the residents of the Schedule Tribal block.
27. Detailed analysis of availability and quality of the drinking water resources available in the block.
28. A study by CPCB of the methodology of disposal of industrial waste from the existing industries in the block, whether it is being done in a manner that mitigate all health and environmental risks.
29. The consent of Gram Sabha of the villages in the area where project is proposed shall be obtained.
