- 1. Case No. 4272/2015-** Prior Environmental Clearance for Bauxite, Laterite & Fire Clay Mine (Open cast mechanized method) in an area of 4.01 ha for Total production capacity of 43801 TPA (Bauxite-35588 TPA, Laterite – 5475 TPA & Fire Clay – 2738 TPA) at khasra no 463, 464/2, 501 & 502/1 at Village- Tikariya, Tehsil-Murwara, District-Katni (M.P.) by Shri Moti Lal Bajaj S/o Shri Panna Lal Bajaj, R/o – House No. 1 Vinoba Bhawe Ward Barhi Road, Near Mainadi, District-Katni (M.P.) – 483501.

- (1) This is a project pertaining to mining of Bauxite, Laterite & Fire Clay Mine in MLA of 4.01 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary. It was noted that the interstate boundary is more than 10 Km from mining site falls in Village-Tikariya, Tehsil-Murwara, District-Katni. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine with Total production capacity of 43801 TPA (Bauxite-35588 TPA, Laterite – 5475 TPA & Fire Clay – 2738 TPA) .
- (2) It was reported by the PP that the lease area was granted to Smt.Aruna Devi Bajaj for 20 years (29.09.2009 to 28.09.2029). After the death of Smt.Aruna Devi Bajaj this lease was transferred to Legal heirs (Son) Shri Moti Lal Bajaj S/o Late Shri Panna Lal Bajaj.

- (3) It was noted that 05 mines (66.84 ha.) are located in the periphery of 500 m of proposed mine and this is the lease was sanctioned by M.P. Govt. Mineral Resources Department, Bhopal for 20 years vide Order no 3-33/2008/ 12/2 dated 18/06/2009.
- (4) This is a case of existing mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM, (vide letter No. MP/ Katni/ Bauxite/ M.Sch- 03/ 2014 -15 dated 24.07.2014).
- (5) SEAC in its 63rd SEAC-II meeting dtd. 24.12.2016 has recommended the case with 16 special conditions for issuance of EC.
- (6) The case was then discussed in 402th SEIAA meeting dtd 16.01.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (7) It was noted that the water requirement is 41.165 KLD (10 KLD for Dust Suppression+ 29.50 KLD for Green Belt + 1.665 KLD for Domestic), which shall be met from dug wells & tube wells.
- (8) The proposed plantation program was examined and it was found that 3400 sapling of tree species covering an area of 1.18 ha shall be covered under plantation during the end of lease period.
- (9) PP ensure & demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt in an area of 0.35 ha (1000 sapling). The two row plantation shall be carried out in the greenbelt area in current year before the start of the mining activities.
- (10) PP will ensure to construct a tar road from mining site to the State Highway for the movement of trucks.
- (11) After deliberation the case was discussed in depth and PP was asked to submit the following information :-
 - i. Ground water details with water table of the area from Central Ground Water Board.
 - ii. DGMS approval for registration of this mining case regarding start of mining beyond the limit of 6 m.
 - iii. Ambient Air Quality Monitoring report of mining area by MPPCB
 - iv. Water quality Monitoring done by MPPCB.
 - v. Revised Environmental Management Plan giving details of 5.0 lakhs Rupees for plantation in First Year & CSR in consultation with Gram Sabha.




