1. **Case No. 2939/2015** - Prior Environmental Clearance for **Granite Mine** (Opencast semi mechanized method) in an area of 21.0 ha. for production capacity of Granite – 22140 cum/year, Stone-26291 cum/year at Khasra No. 219 at Village- -Sunar, Tehsil-Datia, District-Datia (MP) by M/s Balaji Granites, Shri Praveen Singh Bundela, Prop.H-12, K.K. Colony, Tehsil & District-Datia (MP) – 473661.

- (1) This is a project pertaining to mining of Granite Mine in MLA of 21.0 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease for 20 years with production capacity of Granite – 22140 cum/year, Stone-26291 cum/year .
- (2) SEAC in its 50th SEAC-II meeting dtd.20.09.2016 has recommended the case with 13 special conditions for issuance of EC.





- (3) The case was discussed in 392nd SEIAA meeting dtd. 06.12.2016 and invite the PP on separate date after fulfilling all the required information as desired by the authority. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail
- (4) The proposed plantation program was examined and it was found that 2100 sapling of tree species covering an area of 7.0 ha shall be planted during the lease period.
- (5) It was noted that the water requirement is 8 m³/day (3m³/day for Dust Suppression+ 3m³/day for Green Belt + 2m³/day for Domestic/Drinking), which shall be met from open wells and tube well.
- (6) Based on the recommendation of 50th SEAC meeting dtd. 20.09.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
 - II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
 - III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
 - IV. PP should construct garland drain 1500 m. long of size 2m x 1.5m alongwith 03 pakka settling tanks (35mx20mx1.5m) of the mining lease boundary. PP shall also ensure the proper cleaning and maintenance of garland drain and settling tank. PP should ensure zero discharge from the mined area.
 - V. PP will ensure construction of gully check and check dam for control of runoff.
 - VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained. Regular depth of ground water table should be monitored by the State Ground Water Survey.
 - VII. Consent of the farmers shall be taken before discharging the mine water into their fields after qualitative assessment by MPPCB.
 - VIII. Construction of 250 m. Pakka Approach road from mine site to Sonagiri station road. No transportation will be allowed through the village Sunar.
 - IX. From the google map the human settlement from the last boundary of the mining lease area is 67 m. PP must ensure to leave 100 m. from the human settlement as a "no mining zone". Demarcation should be done in the presence of the Revenue & Mining Officials.

- X. This is MDR road under maintenance of PWD, PP will ensure proper maintenance of the road in consultation with the Works Department and District Administration. Before entering village Sonagiri, PP has committed to make a bypass road avoiding transportation through the village settlement. PP will make separate financial provisions for the maintenance of the MDR and construction of bypass as part of EMP.
- XI. The entire lease area shall be fenced all around the minable area. A curtain wall of 6 m. height shall be constructed on the north and north west side (300 m. along the village boundary side) to minimize dust pollution.
- XII. A minimum 2100 plants shall be planted preferably having minimum age of three years. During the first year plantation in the no mining zone and buffer zone (7.5 m.) should be taken up. Top soil shall be used during plantation. At the end of the mining lease, plantation should done on the bench of 5-6 m. width.
- XIII. No overburden will be dumped outside the mine lease area dump height will not be more than 5 m.
- XIV. Controlled blasting shall be carried out as permitted by DGMS.
- XV. Proper infrastructure with labour shelter (size 1000 sq.ft), drinking water, toilet and first-aid facilities shall be provided for the labourers.
- XVI. Regular air & water quality monitoring to be carried out by PP in consultation with Regional Officer, MPPCB. Gwalior.
- XVII. Water tankers with fogging arrangement will be used for regular water sprinkling on the haul roads to ensure effective dust suppression
- XVIII. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XIX. PP should ensure under CSR the following activities for which a provision of 5.00 lakhs should be made :-
- a) Provide Benches, Utensils & plate for Mid Day meal and Pictorial material & sports kit for school.
 - b) Facilitate youths & farmers of selected Villagers both on farm and off farm activities based on need, interest and market potential.
 - c) Provide 7 solar LED street light (18 watts) for village.
 - d) Health check up camps and distributions of medicine.

The modification to the above activities can be made with the permission of the district administration.

2. **Case No. 272/2009**, Prior Environmental Clearance for **Deshgaon Basalt metal stone quarry** in area of 18.84 ha for production capacity 19,800 cum per year at village Deshgaon, tehsil Khandwa, district East Nimar, MP by Shri Rakesh Kumar Bansal, Ram Krishna Road, tehsil & district Khandwa, MP.

The case was discussed in 420th seiaa meeting dtd 06.04.2017 and it was recorded that :-

Hon'ble NGT (CZ) Bhopal have directed MP-SEIAA in its order dated 10-03-2017 in OA No. 129/2016 to review the matter in respect of grant of EC dated 05.05.2012.

.....Looking to all these facts and other relevant facts that needs to be considered we direct the SEIAA to review the matter with regard to the grant of EC while doing so, SEIAA shall give a hearing to respondent No. 10. If necessary, SEIAA may have a fresh inspection of the area in case respondent No. 10 so desires.

In the meanwhile, we direct that the respondent No. 10 is restrained from carrying out its operation till the decision is taken by the SEIAA. In the light of the above, we would further request SEIAA to take an early decision in the matter, preferably within four weeks from the receipt of the certified copies. It would be open for the respondent No. 10 to approach SEIAA with a copy of this order and other supporting documents and records of this case.

In response to the above directions of the Hon'ble NGT (CZ) Bhopal it has been decided to inform the PP to attend this office on 23.04.2017 and represent the case alongwith all relevant documents regarding Khasra Panchsala, NOC from DFO regarding the distance of Forest Boundary from the lease area, location of HT line, distance of water retaining structure/water body from the leased area, distance of leased area from the state highway etc. It was also decided to send a copy of the judgment to the Collector, Khandwa and Mining Officer, Khandwa and obtain their comments on the issues raised in the OA No. 129/2016 and the directives of Hon'ble NGT (CZ) Bhopal thereon.

PP has submitted the stay order of the Hon'ble High Court Principal Seat at Jabalpur in Case No. WP-4774-2017 (Shri Rakesh Bansal V/s The State of MP) restraining the petitioner to carry out its operation as per the order of the Hon'ble NGT (CZ) dated 10.03.2017.


"Shri Vivek Dalal, learned counsel for the petitioner. Shri Samdarshi Tiwari, learned Deputy Advocate General for the respondent no.1,3,4,5,7 and 8. Shri Ankit Saxena, learned counsel for the respondent no.10 on caveat. Learned counsel for the petitioner contends that the National Green Tribunal in an Original Application has directed the State Environment Impact Assessment Authority (SEIAA) to review the matter without setting aside the order passed by it, and that too after the expiry of the period of limitation to challenge such order expired. Let notice be served upon respondent no.2,6 and 9 on payment of PF within a week, returnable within one month. In the meantime, the operation of the order of Tribunal dated 10th March,2017 restraining the petitioner to carry out its operation shall remain stayed. C.c.as per rules"



3. **Case No. 1631/2013** Prior Environmental Clearance for **Pyrophyllite & Diaspore Mine** (Opencast Manual /Semi Mechanized Method) in an area of 14.00 ha. for production capacity of 50,715 TPA at Khasra No. 1045 at Village-Bairwar, Tehsil-Jatara, District-Tikamgarh (M.P.) by Shri Narendra Kumar Jain C/o Shri Harish Chandra Jain, HPA, Near River, Main Road, Shahgarh, District-Sagar (MP)-470339

The case was discussed in 300th SEIAA meeting dtd. 29.02.2016 it was recorded that :-

- (1) SEAC in its 241st meeting dtd. 06.11.2015 recommended the case for grant of prior EC with 8 special conditions.





- (2) The case was discussed in 269th SEIAA meeting dtd 06.12.2015 and it was recorded that
- "After detailed discussion and recommendations of 241st SEAC meeting dtd. 06.11.2015, PP should be invited for detailed presentation."
- (3) Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (4) It was noted that National Park/Sanctuary is not located within 10 km radius. Hence, the **General Condition is not attracted.**
- (5) Mining plan is approved by the IBM (vide letter no. MP /Tikam /Pyro. /M.plan/G-11/ 03- 04 dtd. 25.09.2003).
- (6) The proposed plantation program was examined and it was found that **11,100 trees** shall be planted in an area of **7.4 ha** at the end of lease period.
- (7) It was noted that the water requirement is 5 KLD (2 KLD for Dust Suppression+ 2.0 KLD for Green Belt + 1.0 for KLD Drinking), which shall be met from mine pit and Hand pump.
- (8) It was noted that the Public Hearing was held on 27.08.2014 near to Govt. School, Bairwar, Tehsil-Jatara, District- Tikamgarh (M.P.) under the Chairmanship of Upper Collector, Tikamgarh. The issues raised during public hearing were of mixed nature. Some villagers welcomed the proposal and some of them had reservations that the project shall adversely degrade the surrounding environment.
- (9) After detailed discussions and perusal of recommendations of 241st SEAC meeting dtd. 06.11.2015, presentation made by the PP in SEIAA & SEAC, **following specific conditions have been decided:**
- (i) A 100m "no mining zone" to be left from HFL of the nearest water body and the nearest mining lease periphery. Demarcation shall be done by revenue officials in presence of WRD & Mining Officer, Tikamgarh.
 - (ii) An area of 6.6 ha towards South & South East side below ridge upto temple be kept as no mining zone and be thickly afforested. Only 7.4 ha area to be used for mining purpose.
 - (iii) Entire lease area shall be fenced.
 - (iv) No blasting shall be carried out.
 - (v) Renovation of existing temple and development of adjacent school play ground shall be done by PP in consultation with Collector, Tikamgarh.
 - (vi) A wall of 6 feet height shall be constructed towards School side.
 - (vii) No transportation shall be allowed from School Side, Mining Officer, Tikamgarh will monitor the same.
 - (viii) Water quality monitoring of existing nearby tube wells and surface water bodies will be done with consultation of MPPCB. One point for Air & Water monitoring be taken towards school side.
 - (ix) A separate establishment with public facility of toilet, drinking water, First -aid, rest room etc. to be provide within lease area for ladies, children, visitors, doctors, etc. Thick plantation will done near to this establishment.
 - (x) During Loading and unloading of material water spray should be done by appropriate mechanism to minimize dust pollution.

- (xi) Plantation in non- mining area within the lease shall be done before starting of mining activity. These plants should be of 3 years old and species of these plants to be identified with consultation of district administration.
- (xii) No grinding unit shall be established at mining site.
- (xiii) Overburden dumps shall be of small size i.e. upto 3 m height. Grass to be planted on these dumps for stabilization.
- (xiv) Stone retaining wall of more than the height of dump to be constructed all around the overburden dumps.

After perusal of the minutes of 241st SEAC meeting dtd. 06.11.2015 wherein it was recorded that :-

- Clarification on the comments given by the ADM in Public Hearing. It is noted that the temple, hostel and several trees are located on the same khasra along with the proposed lease area; hence in this context PP is required to submit a map of the complete khasra depicting relative locations of all the above features and the relative distance of each of the above features from the project boundary. A note highlighting the safety measures and the eco-friendly practices proposed in the mining operations.
- Expected impacts from the mining activities on various nearby components and the mitigations planned to be furnished separately.
- Lease area approach road net-work with status of the same to be furnished.


Response to the above queries was submitted by the PP and the same was placed before the committee wherein it was observed that public hearing issue has been dealt in EIA. It has been observed that ADM has made adverse comments on the project but considering the technical aspect of the project where mining is manual and without blasting significant impact is not envisaged. It is also submitted that adequate distance shall be made from the temple and other observed features and no mining will be opened towards direction of temple and hostel building. PP has further submitted that mining department has deducted 4.00 ha of area considering the location of temple as the total area of Khasra no. 1045 was of 18.00 ha. The submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions

In context of above it was decided to seek comments of Collector, Tikamgarh on the adverse comments made by ADM, Tikamgarh in proceedings of Public Hearing of the project. Copy to PP.

In response to the above query, Collector, Tikamgarh has submitted comments regarding distances to be left as no mining zone from the Temple and the Hostel. Collector, Tikamgarh has recommended "that out of the total khasra (1045) area 18.718 ha., mining lease area 14.0 ha. was sanctioned to the PP, leaving 4.718 ha. for access to the Mandir : PP has agreed to leave 142 m. from the boundary of the temple and 150 m. from the existing hostel as a "no mining zone" : PP has agreed to do thick plantation in the remaining non minable area. Collector has further recommended that with the above stipulations, there shall be no adverse impact from mining.

Based on the recommendation of 241st SEAC meeting dtd. 06.11.2015, presentation made by the PP in SEIAA & SEAC, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**

- (i) Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- (ii) Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- (iii) PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. The two row plantation shall be carried out in the greenbelt area in current year.

- (iv) A 100m "no mining zone" to be left from HFL of the nearest water body and the nearest mining lease periphery. Demarcation shall be done by revenue officials in presence of WRD & Mining Officer, Tikamgarh.
- (v) PP must ensure to leave 142 m. from the boundary of the temple and 150 m. from the existing hostel as a "no mining zone" only 7.4 ha area to be used for mining purpose and rest remaining non minable area to be thickly planted by local species and plants of three year age. Demarcation should be done by the Revenue officials in the presence of representatives of temple and hostel management and Mining Officer, Tikamgarh.
- (vi) The entire lease area shall be fenced. A curtain wall of 6 feet height shall be constructed all around the minable area.
- (vii) No blasting shall be permitted and only manual mining is allowed.
- (viii) Renovation of existing temple and development of adjacent school play ground shall be done by PP in consultation with Collector, Tikamgarh.
- (ix) Regular air & Water quality monitoring of temple area, hostel and Bairwar Village should be done in consultation with RO, MPPCB..
- (x) A separate establishment with public facility of toilet, drinking water, First – aid, rest room etc. to be provide within lease area for ladies, children, visitors, doctors, etc. Thick plantation will done near to this establishment.
- (xi) During Loading and unloading of mineral, water fogging should be done by appropriate mechanism to minimize dust pollution.
- (xii) Plantation in non- mining area within the lease shall be done before starting of mining activity. These plants should be of 3 years old and local species like Karranj, Neem, Gulmohar, Amaltas, Jamun etc should be planted.
- (xiii) No grinding unit shall be established at mining site.
- (xiv) Overburden dumps shall be of small size i.e. upto 3 m height. Grass to be planted on these dumps for stabilization.
- (xv) Stone retaining wall of more than the height of dump to be constructed all around the overburden dumps.
- (xvi) PP should construct a pakka road on the transportation route from north to south on the western side upto the tri-junction.
- (xvii) PP should construct garland drain all around the periphery of the mineable area of size 2 m x 1.5m alongwith 04 RCC/Masonry settling tanks of appropriate size. PP shall also ensure the proper cleaning and maintenance of garland drain and settling tank. PP should ensure zero discharge from the mined area.
- (xviii) Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.

- (xix) Suitable financial provisions to be made by PP under EMP to cover up the cost of pakka transportation route, construction of garland drain, settling tanks and retaining wall, curtaining all around the mineable area and plantation in 11.0 ha. of non minable area.
- (xx) Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the labourers. A provision should be made to construct a pakka rest shelter of 8m x6m along with toilet and drinking water facility.
- (xxi) PP must ensure under CSR the following activities for which a provision of 6.00 lakhs should be kept :-


The case was discussed in 338th SEIAA meeting dtd. 04.06.2016 and it was recorded that :-




