

Hon'ble NGT (CZ) Bhopal have directed MP-SEIAA in its order dated 10-03-2017 in OA No. 129/2016 to review the matter in respect of grant of EC dated 05.05.2012.

.....Looking to all these facts and other relevant facts that needs to be considered we direct the SEIAA to review the matter with regard to the grant of EC while doing so, SEIAA shall give a hearing to respondent No. 10. If necessary, SEIAA may have a fresh inspection of the area in case respondent No. 10 so desires.

In the meanwhile, we direct that the respondent No. 10 is restrained from carrying out its operation till the decision is taken by the SEIAA. In the light of the above, we would further request SEIAA to take an early decision in the matter, preferably within four weeks from the receipt of the certified copies. It would be open for the respondent No. 10 to approach SEIAA with a copy of this order and other supporting documents and records of this case.

In response to the above directions of the Hon'ble NGT (CZ) Bhopal it has been decided to inform the PP to attend this office on 23.04.2017 and represent the case alongwith all relevant documents regarding Khasra Panchsala, NOC from DFO regarding the distance of Forest Boundary from the lease area, location of HT line, distance of water retaining structure/water body from the leased area, distance of leased area from the state highway etc. It was also decided to send a copy of the judgment to the Collector, Khandwa and Mining Officer, Khandwa and obtain their comments on the issues raised in the OA No. 129/2016 and the directives of Hon'ble NGT (CZ) Bhopal thereon.

Minutes of the 433th Meeting of SEIAA dated. 23.05.2017

PP has submitted the stay order of the Hon'ble High Court Principal Seat at Jabalpur in Case No. WP-4774-2017 (Shri Rakesh Bansal V/s The State of MP) restraining the petitioner to carry out its operation as per the order of the Hon'ble NGT (CZ) dated 10.03.2017.

"Shri Vivek Dalal, learned counsel for the petitioner. Shri Samdarshi Tiwari, learned Deputy Advocate General for the respondent no.1,3,4,5,7 and 8. Shri Ankit Saxena, learned counsel for the respondent no.10 on caveat. Learned counsel for the petitioner contends that the National Green Tribunal in an Original Application has directed the State Environment Impact Assessment Authority (SEIAA) to review the matter without setting aside the order passed by it, and that too after the expiry of the period of limitation to challenge such order expired. Let notice be served upon respondent no.2,6 and 9 on payment of PF within a week, returnable within one month. In the meantime, the operation of the order of Tribunal dated 10th March,2017 restraining the petitioner to carry out its operation shall remain stayed. C.c.as per rules"

After detailed discussion it has been decided to give proper reply as per the directive of the Hon'ble High Court on the next hearing. Till such time the proceedings are being stayed. Copy to PP.

Hon'ble NGT in its order dated 04.05.2017 has quashed the EC issued by SEIAA and dispose of the case in the following manner :-

In similar manner in this case also we are of the view that SEIAA failed to take into account the salient aspects as to whether EC should have been granted taking into account the fact that the leased area encompasses within it, the dam itself and also a portion of its reservoir being the water body in Khasra No. 1190 and the another water body in survey no. 1214.

Consequently the EC granted to the Respondent No. 10 is hereby quashed.

PP then approached the Hon'ble High Court Jabalpur Bench and in case No. WP 7061/2017, Hon'ble HC has issued the following directives :-

In the meantime, operation of the order passed by the National Green Tribunal dated 04.05.2017, shall remain stayed. But, the order of stay will not debar the Committee of Officers constituted by the National Green Tribunal to inspect and submit the report to this Court. Still further, the order of stay will not entitle the petitioner to carry out the mining activity.

Learned counsel for the parties seek some time to mark the area adjoining forest and the water bodies so as to permit the mining activity on the remaining area, if any.

Looking to the complexity of the case, it has been decided to take opinion of SEAC in this matter and possibly a site visit by the members of SEAC to personally inspect the parameters on which the EC has been quashed by the Hon'ble NGT in their order dated 04.05.2017. After the site visit, SEAC should reconsider/review the recommendations made in their meeting dated 07.01.2011 and explicitly appraise and submit their fresh recommendations in the matter latest by 10.06.2017. Since the Hon'ble Courts have shown urgency in the matter, it is therefore desired that Members of SEAC may visit the site at the earliest. Copy to PP.

The case was reviewed in the light of the MoEF&CC OM dated 09.06.2015 issued in further clarification to the gazette notification dated 22.12.2014. The contents of the OM are reproduced as under :-

Vide Gazette Notification No. S.O. 3252 (E) dated 22.12.2014, the Ministry of Environment, Forest and Climate Change has exempted the School, College and Hostel for educational institution from obtaining prior Environment Clearance under the provisions of the EIA Notification, 2006 subject to Sustainable Environmental Management.

The Ministry is in receipt of representation from various educational institutions regarding issuing clarification on status of universities, and other educational institutions. The matter has been further examined in the Ministry and it is clarified that the Notification No. S.O. 3252 (E) dated 22.12.2014 provides exemption to buildings of educational institutions including universities from obtaining prior Environment Clearance under the provisions of the EIA Notification, 2006 subject to sustainable environmental Management. In case of medical universities/institutes the component of Hospitals will continue to require prior Environment Clearance.

Since now the Universities have been debarred from the list of buildings for which EC has to be granted by SEIAA, therefore it has been decided to close this case and inform the PP to follow all environmental guidelines as directed in the said OM. A copy of the OM should also be sent to the PP.




" The case was again scheduled for presentation today and again no one from the PP or their consultant came for the presentation. Thus committee decided that sufficient opportunities have been given to the PP for representing their case but it appears that they are not interested to take-up this project. The case may, therefore be recommended for delisting by SEIAA.."

*As per the above recommendations, SEIAA has decided to **delist the case** and it shall be liable for relisting once the complete information is submitted by PP. **PP and all concerned be informed accordingly.***

The case is reviewed in the light of the MoEF&CC notification dated 14.03.2017 regarding violation cases and its disposal thereof. From the google map it was observed that the PP has already constructed the project and therefore warrant action as a violation case.

The Ministry of Environment, Forest and Climate Change (MoEF&CC) has provided a six months window, as a one-time opportunity to the units, which have not obtained prior environmental clearance to apply for the same. It has been decided taking cognizance of the above notification, PPs who have violated and identified as violator by SEIAA should be informed to apply online afresh in the MoEF&CC. All related record and technical files regarding this violation case should be properly formatted and collated for onward transfer to MoEF&CC. At SEIAA level the case is hereby closed and PP should pursue online submission to MoEF&CC to seek EC as per the details chartered in the notification dated 14.03.2017.


