This case was recommended in 78<sup>th</sup> SEAC-II meeting dated 25-05-17 and it was recorded that :-

..... The case was presented by the PP and their consultant, wherein it was observed that according to the Google image of January, 2017 approximately 60 % of lease area is submerged in water and on the banks of the area good coverage of green (agricultural crop) could be seen. However as per the Production Operational Plan submitted by the PP 5.990 ha area is available for sand evacuation with 02 mts depth and the only 1,19,800 cum/year volume of sand can be evacuated from this lease area as mid stream mining is not allowed. The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':



PP was also informed to submit above information vide letter no 97 dated 03/02/2017 stating to submit the desired information and reminder was also given to the PP vide letter no. 295 dated 08/05/2017. PP so far has not submitted the desired informations and the case was placed before the committee. The committee observed that PP has neither submitted the desired information nor has requested for providing additional time to submit desired information and thus decided that this case may be recommended for delisting to SEIAA as per MoEF&CC OM No. F-11013/5/2009-IA-II (Part) dated 30/10/2012 as PP has not submitted the desired information.

As per the above observation, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned




This case was recommended in 78<sup>th</sup> SEAC-II meeting dated 25-05-17 and it was recorded that :-


..... SEIAA vide letter no. 5316/SEIAA/17 dated 23/02/2017 has forwarded the representation submitted by PP which was placed before the committee. Committee on perusal of the case file and representation submitted by the PP observed that the production capacity has been reduced from 5,09,280 cum/year to 4,40,000 cum/year and observed that the above decision was taken in the 20<sup>th</sup> SEAC II meeting dated 26/04/2016 wherein the committee has justified the reason for deduction in sand volume. Thus committee after deliberations decided to stands by the recommendations made in the 20<sup>th</sup> SEAC II meeting dated 26/04/2016..

As per the above observation, it has been decided that no change in the production capacity shall be required. PP may be informed accordingly.

**Minutes of the 440<sup>th</sup> Meeting of SEIAA dated. 08.06.2017**

- (1) This is a project pertaining to mining of **Laterite, Manganese & Iron Ore** Mine in MLA of 3.60 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. and forest boundary is more than 250 m distance from the ML area, thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease for 20 years (from 28.08.2012 to 28.08.2032) with production capacity expansion from 49375 TPA to 80,000 TPA.
- (2) It was reported by the PP that the lease area was granted to Shri Rajendra Namdev for 20 years 29.08.1992 to 28. 08. 2012 and lease was transferred to M/s Sobha Mineral on 06.10.2003. This is a case of existing mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM (vide letter No. MP/Jabalpur/Late./Mad-M.Sch.-01/09-10 dated 25-08-2009)
- (3) SEAC in its 76<sup>th</sup> SEAC-II meeting dtd. 23.05.2017 has recommended the case with 17 special conditions for issuance of EC.
- (4) The case was then discussed in 439<sup>th</sup> SEIAA meeting dtd. 07.06.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) It was noted that the water requirement is 74 KLD (67 KLD for Dust Suppression+ 05 KLD for Green Belt + 02 KLD for Drinking), which shall be met from mine pit and hand pump.
- (6) The nearest settlement of Dhamki village is about 190 m and water body is about 50 m from mining lease area in northern direction while canal is passing at a distance of 330 m in southern direction.
- (7) There are 6 other operational mines located within 1 km radius of mining lease area as reported by PP.
- (8) The ultimate depth of mining is reported to be 17m below ground level while ground water table varies from 7 m to 22 m in Jabalpur District as per Central Ground Water Survey Report-2015.
- (9) It was noted that the Public Hearing was held on dtd. 01.03.2017 at Mine Parisar, Village- Dhamki, Tehsil-Sihora, Dist-Jabalpur (M.P.) under chairmanship of ADM Jabalpur. The issues raised during the public hearing were mainly related to sanitation, water supply, employment, green belt development and water spraying etc. which were addressed by PP.
- (10) After detailed discussions and perusal of recommendations of 76<sup>th</sup> SEAC - II meeting dtd. 23.05.2017, presentation made by the PP in SEIAA & SEAC, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
  - I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.






**Minutes of the 440<sup>th</sup> Meeting of SEIAA dated. 08.06.2017**

- II. PP shall leave 50 m from the existing water body and shall demarcate a barrier zone of 7.5 m as "no mining zone".
- III. In the periphery of mining lease area and develop a green belt, three row plantations shall be carried out in the greenbelt area in current year with proper watering arrangement.
- IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- V. PP shall ensure to construct and maintain approx. 1580 m pakka approach road upto NH-7 with the help of other mine lease holders and beneficiation plant owners to suppress dust pollution. Plantation will be carried out on both side of approach road.
- VI. PP will not cut any existing tree and will ensure to conserve all 170 trees existing in the lease area. PP will plant 4200 numbers 3 years old tree samplings of suitable indigenous tree species in addition to drum stick species as mentioned in plantation programme of EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit. PP will raise dense vegetation towards northern side of lease area to reduce the environmental impact on water body and habitation of Dhamki village. Top fertile soil will be transported from outside for plantation purpose.
- VII. PP shall remodel the existing garland drain of minimum 2m x 1.5m size with proper de-silting and stone pitching all around the lease area.
- VIII. Ground water table monitoring shall be done for pre monsoon and post monsoon season and record shall be maintained.
- IX. Regular air & water quality monitoring shall be carried out by PP to assess the environmental impact.
- X. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XI. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the labourers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XII. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby area.
- XIII. PP should ensure to submit half yearly compliance report with photographs of plantation.
- XIV. There will not be any discharge of mine waste water outside of lease area and zero discharge will be maintained by PP.
- XV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.




- XVI. Budget provision of Rs. 15.00 lakhs be made under Environmental Management Plan for plantation, dust suppression and pakka road construction.
- XVII. PP must ensure under CSR the following activities for which a provision of 7.00 lakhs should be kept.
- Installation of solar street light at nearby villages viz., Dhamki, Rampur, Labour tola.
  - Conservation of water body and construction of concrete road in Dhamki village.
  - PP will provide handpump as per the demand raised in the public hearing and provide sanitation facilities with water supply at nearby villages.
  - PP shall also provide separate toilet facility for girls and boys with proper arrangement of water (i.e, Water tanks & Pumps) in the school of nearby villages.
  - Need based fund to the development of nearby villages in consultation with the Grampanchayat and District Administration.


