Considering the above statement of the Concerned Mining Officer and photographs, committee after deliberations decided that since the evacuation volume is only 5,000 cum/year and mining officer has verified in writing and through photographs regarding availability of sand, case can be considered for grant of EC. discuss the case and after discussion it was observed that: The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':.
