



Dubash Stone & Lime Company Pvt. Ltd., Shri Sailendra J. Worah, (Director & Owner), Station Road, P.O.Maihar, District-Satna (M.P.)- 485771.

Minutes of the 456th Meeting of SEIAA dated. 16.11.2017

- (1) This is a project pertaining to mining of Limestone & Dolomite Mine in MLA of 4.57 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of 50 years upto 16.02.2027 with production of 1,39,200 TPA.
- (2) It was reported by the PP that the Mining lease was initially granted for 10 years period to Smt. Azra Begam w.e.f. 02.11.1977 to 01.11.1987. The ML area was transferred to Shri J.P. Mishra for period 08.01.1987 to 01.11.1997 and renewed up to 01.11.2017. The ML was again Transferred to Shri Ravi Kumar Kankane and then to the present lessee. The ML area is deemed to have been extended upto 50 years period from date of 1st grant of ML i.e. upto 01.11.2027 under the provisions of The MM (D & R) Amendment Act 2015. As per EIA notification 2006 and its subsequent amendment thereof proposed project fall in category B1. The mining plan has been approved by IBM (vide letter No. – MP/Katni/Limestone/M.Sch.-122/14-15/2901 dated 18.05.2015).
- (3) SEAC in its 79th SEAC-II meeting dtd. 13.06.2017 has recommended the case with 18 special conditions for issuance of EC.
- (4) The case was then discussed in 453rd SEIAA meeting dtd 06.11.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) It was noted that as per DFO, Katni vide endt letter. no. 5422 dtd. 10.09.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (6) It was noted that the water requirement is 15 KLD (8 KLD for Dust Suppression+ 4 KLD for Green Belt + 3 KLD for Domestic), which shall be met from Mine Sump and Ground Water.
- (7) The proposed plantation programme was examined and it was found that 3600 Plants (1600 Plants in the lease area + 2000 Plants along transportation route) sapling of tree species covering an area of 1.53 ha shall be planted during the lease period.
- (8) It was also noted that the Public Hearing was carried out on 30.03.2017 at Mine Parisar Village Bistara, under the Chairmanship of Upper Collector, Katni. The major comments of applicants during public hearing are employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side, regular health check-up of mine workers & water sprinkling to suppress the dust emission.
- (9) **After detailed discussions and perusal of recommendations of 79th SEAC-II meeting dtd. 13.06.2017, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**







Minutes of the 456th Meeting of SEIAA dated. 16.11.2017

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- V. PP will plant 3 years old 1000 trees saplings of suitable indigenous tree species in 0.97 ha barrier zone during first year. Plantation of munga plants replace of eucalyptus on priority shall be ensured by PP.
- VI. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- VII. Before mining operation in barrier zone with adjoining mining lease area PP shall take appropriate permission from DG&MS.
- VIII. No overburden will be dumped outside the mine lease area.
- IX. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- X. PP shall ensure generation of employment opportunities to nearby Village on priority bases.
- XI. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XII. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XIII. PP should also carry out regular sprinkling of water in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XIV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XV. PP shall ensure to construct and maintain Cement Concrete approach road from the mine site. Plantation will be carried out on both sides of the approach road. PP shall also ensure maintenance of existing pakka road in consultation with competent authority.


- XVI. PP shall ensure proper water supply arrangements for plantation especially in summer season.
- XVII. PP shall ensure proper implementation of plantation, dust suppression, construction of CC approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVIII. PP must ensure implementation of the following activities. Separate budget provision should be kept under CSR.
- PP shall also provide separate toilet facility for girls and boys with proper arrangement of water (i.e, Water tanks & Pumps) in the school of village Bistara & Dithwara.
 - Installation of two Hand pump in Village Paredhi.
 - Providing Computer in the Higher Secondary School in Village Kacchgawan along with instructor.
 - Regular Health checkup camp shall be carried out at nearby village Bistara & Jobikalan.
 - Providing solar lamp to villagers in village Bistara & Kacchgawan.
- The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.**
- XIX. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA.


Hence, Prior Environmental Clearance is granted for Bistara Limestone & Dolomite Mine (Open cast other than fully mechanized method) in an area of 4.57 ha for production capacity of 1,39,200 TPA at khasra no 37P, 38P at Village- Bistara, Tehsil-Murwara, District- Katni (M.P.) for the lease period to M/S N.M. Dubash Stone & Lime Company Pvt. Ltd., Shri Sailendra J. Worah, (Director & Owner), Station Road, P.O.Maihar, District-Satna (M.P.)- 485771.

2. **Case No. 3943/2015** Prior Environmental Clearance for Kachhagawan Limestone Mine (Open cast other than fully mechanized method) in an area of 3.456 ha for production capacity of 1,00,000 TPA at khasra no 101 at Village- Kachhagawan, Tehsil-Katni, District-Katni (M.P.) by Shri Shailendra Nagrath, S/o Shri Ram Prakash Nagrath, Civil Line, P.O. & District-Katni (M.P.)- 483501.

- (1) This is a project pertaining to mining of Limestone Mine in MLA of 3.456 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. and forest boundary is more than 250 m distance from the ML area, thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of 50 years upto 16.02.2026 with production of 1,00,000 TPA.

- (2) It was reported by the PP that the Mining lease was initially sanctioned for 20 years period w.e.f. 17.02.1976 to 16.02.1996 and renewed for 20 years period upto 16.02.2016 in the name of Shri R.P. Nagrath. Shri R.P. Nagrath expired and his legal heir/son Shri Shailendra Nagrath is the lessee as per rules. The ML has been extended to 50 years in accordance with the MM (D&R) Amendment Act 2015 up to 16.02.2026. The mining plan has been approved by IBM (vide letter No. – MP/Katni/Limestone/MPLN/ MOD – 28/ 2015-16 / 1018 dated 23.03.2016)
- (3) SEAC in its 79th SEAC-II meeting dtd. 13.06.2017 has recommended the case with 18 special conditions for issuance of EC.
- (4) The case was then discussed in 453rd SEIAA meeting dtd 06.11.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail
- (5) It was noted that as per DFO, Katni vide letter.no. 5027 dtd. 27.08.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (6) It was noted that the water requirement is 15 KLD (8 KLD for Dust Suppression+ 4 KLD for Green Belt + 3 KLD for Domestic), which shall be met from Mine Sump and Ground Water.
- (7) The proposed plantation programme was examined and it was found that an area of 1.146 ha shall be covered under plantation during the lease period.
- (8) It was also noted that the Public Hearing was carried out on 29.12.2016 at Mine Parisar Village Kachhagawan, under the Chairmanship of Upper Collector, Katni. The major comments of applicants during public hearing are employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side, regular health check-up of mine workers & water sprinkling to suppress the dust emission.

After deliberation the case was discussed in depth and PP was asked to submit the mining site photographs with existing status of fencing around mine at the earliest.

3. **Case No. 5160/2016** - Prior Environmental Clearance for **Katangjhari Manganese Ore Mine** (Open cast semi mechanized method) in an area of 3.38 ha for production capacity of 3000 TPA at Khasra no 526,527,545 at Village-Katangjhari, Tehsil-Lalburra, District-Balaghat (M.P.) by M/S J.K. Minerals, Shri Pradyuman kumar J. Trivedi (Partner), R/o - Ward No. 15 Main Road, District-Balaghat (M.P).

- (1) This is a project pertaining to mining of Limestone Mine in MLA of 3.38 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. and forest boundary is more than 250 m distance from the ML area, thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of 50 years upto 29.10.2049 with production of 3000 TPA.

- (2) It was reported by the PP that the Mining lease granted for period of 20 years from 30.10.1999 and extended to 29.10.2049 and the lease area comes under govt. waste and private land. The scheme of mining with progressive mine closure plan has been approved by IBM, Nagpur. via Letter No. – BGT/MN/MPLN- 659/NGP dtd 22.01.2015.
- (3) SEAC in its 79th SEAC-II meeting dtd. 13.06.2017 has recommended the case with 18 special conditions for issuance of EC.
- (4) It was noted that as per DFO, letter no. 12455 dtd. 18.12.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (5) It was noted that the water requirement is 22 KLD (16 KLD for Dust Suppression+ 5 KLD for Green Belt + 1.50 KLD for Domestic), which shall be met from Mine sump and Dug well.
- (6) The proposed plantation programme was examined and it was found that 2705 sapling of tree species covering an area of 1.50 ha shall be planted during the lease period.
- (7) It was noted that the Public Hearing was carried out on 16.02.2017 at Mine Parisar Village Katanghari, under the Chairmanship of ADM, Balaghat. The major comments of applicants during public hearing are employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side, regular health check-up of mine workers & water sprinkling to suppress the dust emission.
- (8) It was also noted that as per Google image the proposed mine site is located at a distance of 100m. (approx.) from nearby Dam.

After deliberation the case was discussed in depth and it was decided that the EE, WRD, Balaghat will certify that there shall be no adverse impact of the mining on the nearby Dam and issue the NOC to PP. A copy of the same will be submitted by PP at SEIAA for grant of Prior EC.

4. **Case No. 5543/2017** Prior Environmental Clearance for **Rangwasa Stone Quarry** (Opencast/Semi Mechanized Method) in an area of 20.00 ha for production capacity 1,00,000 m³/year at Khasra no. 62/1/1 at Village – Rangwasa Tehsil - Depalpur District- Indore (M.P) by M/s Prathvi Infrastructure Pvt. Ltd., Prop. Shri Karan Singh Thakur S/o Shri Narayan Singh Thakur R/o -18, Udyog Nagar, Nemawar Road Indore District - Indore (MP) – 452002.

This case was recommended in 79th SEAC-II meeting dated 13-06-17 and it was recorded that :-

..... The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':.

After detail discussion and review, it was decided that PP should submit details of availability of ground water sources within the lease area in consultation with CGWB and written consent of grampanchayat / local villagers for supply of water to fulfillment of total water requirement in mining operation, dust suppression, plantation and domestic/drinking purposes to SEIAA. 5. **Case No.5577 /2017** - Prior Environmental Clearance for **Sand Quarry** (Open cast manual method) in an area of 6.0 Ha. for production capacity of 85500 cum per annum at Khasra no. 55(part) at Village- Mohana, Tehsil - Ajaygarh, Dist. Panna (MP) by M/s Shakti Traders, Shri Rajendra Kumar Agarwal (Prop.) Near Jalpa Devi Temple Jalpa Ward Katni, MP - 483501.

This case was recommended in 79th SEAC-II meeting dated 13-06-17 and it was recorded that :-

..... The case was presented by the PP and their consultant, wherein it was observed that Case was presented by PP and their consultant. During presentation, it was observed that as per the certificate issued by the DFO vide letter no. 2347 dated 15/05/2015, Panna Tiger Reserve is at a distance of 7.5 kms and Ken Ghariyal Abhayaran is at a distance of 4.5 kms (a Notified PA) Clearance from NBWL is therefore needed. PP has submitted the copy of online application made for wild life clearance with proposal no. FP/MP/MIN/970/2016 and date of submission is 14/11/2016. The EMS and other submissions made by the PP were found to be satisfactory and 35 SECOND STATE EXPERT APPRAISAL COMMITTEE-2 (MINING) MINUTES OF THE 79th MEETING 13/06/17 acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':

After detailed discussions and perusal of recommendations of 79th SEAC-II meeting dated 13-06-17, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-

- (i). The production capacity shall be limited to the quantity approved by SEAC.
- (ii). No in-stream mining shall be allowed.
- (iii). The depth of the pit shall be as per Approved Mining Plan.
- (iv). No in-stream mining shall be allowed. No ramp will be allowed within the river basin to transport sand to the other bank. Transportation will be allowed on the bank side where the mineral is being excavated.
- (v). The final decision of Hon'ble NGT (CZ) Bhopal and Hon'ble NGT Principal Bench, New Delhi in OA No. 49/2015 (Amarkant Mishra Vs State of MP & others), shall be obligatory on the part of PP.
- (vi). A petition (OA 404/2016, MA 758/2016, MA 920/2016 & MA 1099/2016) has been filed before the Hon'ble NGT (Principal Bench) New Delhi where MP-SEIAA is one of the respondent. Any order by the Hon'ble NGT shall be binding to PP.
- (vii). The entire lease area should be properly fenced and boundary stones marked at the site.
- (viii). PP shall ensure repair and maintenance Kaccha Road along with PWD Road from mining site to nearby village road under budget provision EMP Rs. 5.00 lakh.
- (ix). PP must ensure implementation of the following activities as committed before SEAC with separate budget provision should be kept under CSR.
 - a) PP shall provide 02 computers in nearby school with teacher facilities.
 - b) Promotional programme for drip irrigation technology by providing aid to the farmers in nearby villages.

- c) PP shall ensure safe drinking water facility and health checkup camp with medicine in nearby villages.
- d) Need of the old age home will be assessed and financial assistance shall be provided every year to the old age home at Panna.
- e) PP shall construct a community toilet in nearby village.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.

Hence, Prior Environmental Clearance is granted for Sand Quarry (Open cast manual method) in an area of 6.0 Ha. for production capacity of 85500 cum per annum at Khasra no. 55(part) at Village- Mohana, Tehsil - Ajaygarh, Dist. Panna (MP) for the lease period to M/s Shakti Traders, Shri Rajendra Kumar Agarwal (Prop.) Near Jalpa Devi Temple Jalpa Ward Katni, MP – 483501.

6. **Case No. 3969/2015** - Prior Environmental Clearance for **Rajarwara Limestone & Dolomite Mine** (Open cast other than fully mechanized method) in an area of 4.28 ha for production capacity of 57182 TPA at khasra no 70,72,73,74,75,81P & 82P at Village- Rajarwara, Tehsil-Vijayraghgarh, District- Katni (M.P.) by Smt. Sumitra Grover W/o Shri Madan Lal Grover, R/o – Civil Line, P.O & District-Katni (M.P) 483501.

- (1) This is a project pertaining to mining of Limestone & Dolomite Mine in MLA of 4.28 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. and forest boundary is more than 250 m distance from the ML area, thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease with production capacity of 57182 TPA.
- (2) It was reported by the PP that the Mining lease has been sanctioned for 30 years period w.e.f. 01.01.2010 under the Mines and Minerals Development and Regulation) Amendment Act, 2015 and State Government of M.P. has extended the ML area for 50 years period w.e.f. 01.01.2010. The scheme of mining with progressive mine closure plan has been approved by IBM, Nagpur (vide letter No. – MP/Katni/Limestone /M.sch.-02/15-16/3633 on 03.07.2015).
- (3) SEAC in its 80th SEAC-II meeting dtd. 14.06.2017 has recommended the case with 18 special conditions for issuance of EC.
- (4) It was noted that as per DFO, letter no. 5049 dtd. 27.08.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (5) It was noted that the water requirement is 10 KLD (5 KLD for Dust Suppression+ 3 KLD for Green Belt + 2.0 KLD for Domestic), which shall be met from Mine sump and Bore well.

- (1) This is a project pertaining to mining of Granite Deposit Mine in MLA of 8.0 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease for 30 years with production capacity of Granite – 33125 TPA,
- (2) SEAC in its 81th SEAC-II meeting dtd.22.06.2017 has recommended the case with 18 special conditions for issuance of EC.
- (3) The case was then discussed in 454th SEIAA meeting dtd 07.11.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (4) It was noted that as per DFO, Chhatarpur vide letter no. 1785 dtd. 20.06.2017, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (5) The proposed plantation programme was examined and it was found that 9425 sapling of tree species covering an area of 5.85 ha shall be planted during the lease period.
- (6) It was noted that the water requirement is 107 KLD (85.0 KLD for Dust Suppression+ 10.0KLD for Green Belt + 2.0 KLD for Domestic/Drinking + 5.0 KLD for Wire saw + 5.0 KLD for Drilling), which shall be met from Tankers.

- (2) As per the Joint Director, T & CP, Bhopal-Sehore -Raisen (vide letter dtd 16.02.2017) the total land area of the proposed project is 51700.0 sq.m (5.17 ha). The total built up area proposed by PP is 3888.32 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.mt. & 1,50,000 sq mt. and plot area is less than 50 ha.
- (3) The case was discussed in SEAC meetings 294th SEAC meeting dtd. 23.06.2017, 295th SEAC meeting dtd. 06.11.2017 and is recommended for grant of prior EC subject to 28 special conditions.

 - (iii). The total water & fresh water requirement is 319. The source of water supply is Municipal Corporation, Bhopal,. PP has submitted letter (dtd. 20.03.2017) from Municipal Corporation, Bhopal for water supply.
 - (iv). The total waste water generation is 256 KLD which is proposed to use the capacity of existing STP of Nagar Nigam Bhopal for treatment of waste water. PP has submitted letter dtd 22.06.2017 for treatment and disposal of waste water in municipal sewer line.
 - (v). The municipal solid waste generation during the construction phase at Proposed Project site is expected to be 0.514 kg/capita/day .Considering 100 laborers at site the quantity municipal waste generated will be 52 kg/day. It has come to the notice of SEIAA that recently the residents of Meghnagar agitated over the issue of industrial pollution from Meghnagar Industrial area. They were discontented from the industrial effluent converging the water source reserved for the residents of Meghnagar. Since new chemical industries are in the process of being established, it is pertinent to note that no Public Hearing is required in the industrial estates as per the new MoEF, guidelines. Therefore it is imperative to have an in depth and critical examination of the industries located within the industrial area and the industries to be established in the near future. MD, AVN, Bhopal may be directed to have a rapid Environmental Impact Assessment (EIA) conducted for the entire Meghnagar Industrial Area. Copy to be forwarded to SEAC for issue of appropriate ToR in this regard on the request to be submitted by AVN. SEAC on its own should also make a site visit before recommending the cases of Chemical Plants to SEIAA.







Since the QL is 2.77 kms away from the buffer zone of Bandhavgarh Tiger Reserve and Joint Director, Bandhavgarh Tiger Reserve, Umaria have no objection for renewal/sanction of mining lease, committee after deliberations recommends that the condition "The grant of Environmental Clearance should be subject necessary Wild Life Clearance from NBWL to be obtained by PP", imposed in the 71st SEAC meeting dated 10/04/2017 may be delete on the basis of documents submitted by the PP. After detail discussion and it is observed that the EC was issued vide L.No. 994 dtd 26.04.2016 with the condition as follows :-


