In response to above vide letter dtd 22.02.2018 PP has submitted the copy of the consent letter of Gram Panchyat, Dholar and committment regarding revised CSR activities.

Based on the above recommendation, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC:-

- PP shall not start mining activity before execution of lease agreement.
- II. The depth of the pit shall be as per the Approved Mining Plan.

III. The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary.

- VI. PP shall ensure to construct 680 m. approach road as pakka road and maintained the approach road. Plantation will be carried out on both side of approach road.
- VII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- VIII. Under CSR activity PP has committed vide latter dated 22.02.2018 following addition activities should be implemented.

The amendment should be read along with the original EC issued vide letter dtd 25.06.13. All the conditions mentioned in the prior EC (dtd 19.02.15.) shall remain the same. PP and all concerned informed accordingly.
