
1. The Harsud Lift Irrigation Scheme has been conceived to cater irrigation water to about 5648 ha CCA in Harsud, tehsil of Khandwa districts in 16 villages.
2. This is lift Irrigation project with Net CCA of 5648 ha. The water shall be lifted from the Indira Sagar Reservoir and transported to the command area through Pipes using pressurized micro irrigation system therefore, no submergence is proposed in the project. Hence by virtue of the nature of the project and as per MoEF notification SO 3067 (E) dated 01/12/2009, it falls under category- B and pertains to Item No. 1(c) of the EIA Notification & its amendments.
3. Salient features of the project are as follows:







5. The case was discussed in SEAC meetings 292<sup>nd</sup> dated 16.06.2017, 307<sup>th</sup> dated 23.02.2018 & 307<sup>th</sup> dated 23.02.2018 and 309<sup>th</sup> dated 23.03.2018 recommended for grant of prior EC subject to 31 special conditions.
6. As per recommendation of SEAC PP has called for presentation and after deliberation the case was discussed in depth and it is noted that:
- For construction of pump houses, brake pressure tank and distribution chamber of the scheme Govt. Land of 3.25 ha shall be required. The complete pipeline of Rising main, Gravity main as well as distributaries network does not require any permanent land acquisition.
  - The water will be required for irrigation purpose sourced from Indira Sagar Reservoir from the share of Madhya Pradesh i.e 18.25 million acre ft. in terms of NWDT award. The project comprises lifting of 0.39 lps/ha water for irrigation 5648 ha land from Indira Sagar Reservoir for providing water with micro irrigation up to 205 ha chak with residual head of 20 m at 2.5 ha chak.
  - Public hearing for the proposed Project was conducted on 06<sup>th</sup> January 2018 at Gram Panchayat Bhawan, Village Pratappura, Tehsil Harsud, District Khandwa in Madhya Pradesh.
  - The major sources of air pollution are emission from various construction activities and fugitive emission due to material handling and excavation. PP has proposed unpaved roads in the project site are watered frequently, all vehicles carrying muck to loose material be covered with tarpaulin to avoid spillage of construction materials. Regular water sprinkling will be undertaken to avoid fugitive dust emission. High speed diesel (HSD) with low sulphur content to be used for the DG sets.
  - The waste water generated due to improper treatment of sewage from labor camps leads to infiltration into the subsurface soil and finally affects the ground water. Improper disposal of construction debris, used oil, diesel for DG sets etc., may result in ground water contamination and in turn affecting drainage of the area. PP has proposed the sewage generated from the labour camps shall be treated in the Septic Tank and Soak Pits. Construction activities and vehicle washing should not be undertaken at the course of reservoir or any other water body or close to the water body. There will be no open discharge of sewage from labour camps and the labour camps shall be provided with sufficient bathrooms and toilets.
  - No significant carnivorous and herbivorous wild animals are found in the area. Nilgai (*Boselaphus tragocamelus*), common Langurs (*Semnopithecus entellus*), Mongoose (*Herpestes edwards*) and Jungle Cat (*Felis chaus*) are the common mammals seen in the area. No Rare, Endangered or Threatened species are reported in the project area.
  - Total Power Requirement calculated as 3.05 MW sourced from Madhya Pradesh State Electricity Board.
  - PP has proposed during construction & operation, organic waste shall be treated by vermi composting and inert waste shall be disposed as per established law. During construction 12090 cum of muck shall be generated which shall be used in filling of low lying area in consent with the Gram Panchayat. During operation used oils from the pumps & filters shall be generated which will be disposed to authorized agency.







- ix. For leakages, bursting and corrosion in the pipe line PP has proposed the entire system is equipped with the SCADA and facilitated to identify the leakage and anti-theft alert in the control room which is situated at the pumping station No.1. The information shall be delivered immediately to concerned in-charge officer.
- x. Anti Corrosion measures. (Epoxy paint internally and guniting at outside is proposed where the pipeline is underground. Pipeline exposed to the atmosphere will be painted by epoxy paint both inside and outside to prevent the corrosion.
- xi. The entire micro irrigation system has been aligned in such a way, that it doesn't pass through any forest area. Plantation shall be carried out in vacant area near pump house and BPT. A provision of 10 lakh has been earmarked for plantation.
- xii. The estimated project cost is about 113.41 Crore (2 Lakh/ha)
- xiii. **Benefits of the project:** Due to the implementation of the scheme 5648 Ha shall be brought under irrigation. The project improves total farm output and hence raises farm income. Direct employment opportunities for 150 persons during construction phase and 25 persons during operation phase of the project. Further, indirectly labour opportunities will be substantially improved since larger area will be brought under irrigation. Overall population of 39938 belongs to 7970 families in the 19 villages of command area will be benefitted directly under the Scheme.

In view of above, it is decided to accept the recommendations of 309<sup>th</sup> SEAC meeting dtd 23.03.18 with 31 special conditions and accord prior Environmental Clearance to proposed " Harsud Micro Lift Irrination Scheme at Village- Nandgaon, Tehsil- Harsud District- Khandwa (MP) Lifting point Indira Sagar Reservoir at RL 248m Gohlari Cultivable Command Area – 5648 ha, Gross Command Area – 6276 ha by Executive Engineer, N.D. Division No. 25, Narmada Nagar, District Khandwa, MP- 450119 subject to following specific conditions:-

- (i). The inputs given by the participants during Public hearing should be properly redressed. All the promises and assurances made during the public hearing shall be fulfilled completely by the Narmada Valley Development Authority, GoMP.
- (ii). A grievances redressal mechanism is to be devised by NVDA GoMP and put in place so that aggrieved stakeholders may approach the Authority easily for resolution of any dispute/conflict.
- (iii). An Environmental Cell should be setup to monitor the implementation of Environmental Management Plan and submission of six monthly compliance reports. The committee should ensure that the allocated grant for various purposes included in EMP should be utilized for that purpose fully and should not be diverted for any other purpose.
- (iv). Proposed Voluntary Afforestation programme should be taken-up in consultation with State Forest Department. The allocated grant for this purpose should be fully utilized and not to be diverted for any other purpose. For afforestation programme, proper selection of species including trees with canopy, fruit bearing trees and grasses should be planted as proposed in

EMP. Preference should be given to native species. Irrigation facilities should be ensured and proper care should be taken to raise the plantation. The six monthly compliance report should include plantation with number, species and survival rate etc.

- (v). Occurrence of stagnant pools during construction and operation of the project may provide breeding source for vector mosquitoes and other parasites. Even after taking precaution, due to unforeseen situations, breeding of mosquito and resultant malaria or mosquito borne diseases can increase. If such a situation arises, it will be the responsibility of project authorities to take all steps i.e. insecticidal spray in all the project area and surrounding 3 km area keeping the flight range of mosquitoes in consideration. Also medical assistance should be provided to the affected people at the cost of the developer and appropriate health benefits may be initiated with the help of State Health Department.
- (vi). Regular monitoring of water quality (Surface and Ground) including heavy metals shall be undertaken in the project area and in the adjoining project area to ascertain the change, if any, in the water quality due to leaching of contaminants, from the increased use of chemical fertilizers and pesticides.
- (vii). Conjunctive use of surface water shall be planned to check water logging as well as to increase productivity.
- (viii). In the process of excavation for laying large quantities of muck will get accumulated in the entire length of rising, gravity and distribution mains. Appropriate measures for muck management / disposal should be ensured. The excavated materials should be properly used in the construction of patrolling road and could be distributed to the cultivators on their consent.
- (ix). PP must ensure to use solar energy where ever possible.
- (x). To reduce the noise pollution at intake point, special canopy (covering) be devised over the pumps & DG set.
- (xi). A special control room should be set up at an appropriate location for disaster management, water leakage detection, periodical ecological monitoring and for proper management of the entire distribution and pumping systems. Chassis mounted dewatering pumps should be kept ready to deal with any localized drainage congestion.
- (xii). It shall be binding on the part of Project Proponent to ensure the compliance of directions / orders / any other directions issued by Hon'ble High Court / NGT/ any other Court from time to time.

- Mordnization of existing facilities ( facilities dismantle and rebuilt as well as facility to remain intact)
  - Augmentation of capacity to 42600 KL Product & 8000 KL Water
- (4) There is no interstate boundary and no National Park / Sanctuary within the 05 km of the project area hence the general conditions are not attracted.
- (5) The project includes isolated storage & handling of hazardous chemicals and covered under 6 (b) category of the MoEF, GoI EIA Notification, 2006 and its amendments.
- (6) The ToR were issued to PP by SEAC (vide letter no. 182 dated 28/03/17) and EIA was submitted by PP in SEIAA office on 30.11.2017.
- (7) The case was discussed in SEAC meetings 285th dated 26/01/2016, 287th dated 25/02/2017, 289th dated 28/04/2017, 301st dated 21/12/2017 and 309th dated 23/03/2018 and recommended for EC with 43 special conditions.
- (8) As per recommendation of SEAC PP has called for presentation and after deliberation the case was discussed in depth and it is noted that:
- (i). PP has submitted copy of allotment order of land with notification dtd. 24.03.19. As per the land allotment order the land is the name of HPCL. The existing plant is lying in Magalia village and the plan area is about 19.49 acres and upcoming proposed facility coming in same premises. There is no additional land is required for POL Depot.
  - (ii). The transportation of material for storage purpose thru railway siding and also depend on existing pipeline form BPCL terminal. All the pipeline installation inside the premises are protected through corrosion coating and painting procedure.
  - (iii). Presently 12 KLD water requirements for Existing project. No additional water will be required for proposed project. The source of water for the proposed project is meeting through Bore Wells.
  - (iv). There is no industrial waste will be generated by this project. waste water generated from domestic activity will be disposed off through septic tank followed by soak pit.
  - (v). The drainage is totally protected through the stone pitching for reducing the soil erosion. It is noted that there is a nallah passing along with the project boundary for protection of which PP has proposed 'cleaning of nallah, Embankment' of Nallah, Improved Agriculture Practices' in the close vicinity of the nallah, Plantation of suitable species along with the nallah banks.
  - (vi). There is no continuous source of air pollution from the process of existing facilities of Depot. because the entire bottling process is carried out closed circuit through piping from storage area to filling shed. There shall not be any continuous source of air emission from the proposed facilities. For release of emission from the DG sets in case of power failure and operation of fire engine PP has proposed adequate stack height as per CPCB guidlines at the above roof height for proper dispersion and Water sprinkling at regular basis.







- (vii). Pleasantly 10KL oil sludge is generated in once in 5 year from existing facility and it will be increase by 15 KL and it will be recycled by MPPCB authorized /approved vendor.
- (viii). The duration for demolition activity will be over period of 32 months. 1.3 MT /day of demolished waste will be disposed vide authorized vendors after reuse and recycling. 80-90 % of the steel generated -scrap material designed by CPCB and approximately 90 % of the Debris generated from Concrete, soil, brick masonry, aggregate will be reused as land fill for storage tanks, buildings etc.
- (ix). The hazardous wastes generated is petroleum tank bottom sludge, Petroleum tanks are cleaned once in five year .The type and quantities of Hazardous waste generated from various processes are Approx.10 KL and it will be increase up to 15 KL. The tank bottom sludge is sold out at third party to authorized vendor. The proponent is having authorization of 3.0 MT (15.0 MT/Year) in waste stream 3.1 for cleaning of petroleum oil storage tank sludge contacting oil and 0.04 MT (Yearly) in waste stream 5.1 used oil. The Management of Hazardous waste will be done as per Hazardous Waste Management Rules 2008.
- (x). Existing project demand, 500 KVA, but future demand will be 750 KVA. Also for Power backup, HSD is used as a fuel for D.G sets. Existing Dg set of 200 KVA will be used along with proposed DG set of capacity 750 KVA.
- (xi). For fire fighting management fire water storage will be increased from 2,000 KL to 8,000 KL (2 cone roof tanks each 4,000 KL capacity). Fire water pumps, fire hydrants, monitors, sprinklers and foam system will be augmented as per the requirements specified in OISD Standards 117 & 244.The following safety measures are provided in compliance with OISD standard 244:
- Overfill protection for storage tanks: Independent hard-wired level switch for high level alarm and interlock to close remote operated shut off valve (ROSOV) in tank inlet line.
  - Use of flame-proof electrical equipment & fittings in the classified areas
  - Use of certified spark arrestors in the exhaust of all vehicles entering the designated areas in the Terminal
  - Strict implementation of 'No Smoking' rule
- (xii). As per HPCL CSR policy for Social development activities in terms of Skill Development / Empowerment, Education/Literacy Enhancement, Healthcare/ Medical facility, Drinking water/ Sanitation, Community Development etc. HPCL kept at provision of 2.0% (3.0 Crores) of investment cost (150.0 Crores) and it will use in 5 years by the HPCL. PP has got approval for 30 lakhs for CSR project for school ( Manglia higher secondary school ) Boundary wall construction for school.
- (xiii). 6.5 Acres Green belt is already in existing plant. Total area available for Greenbelt is 2.63 ha on which 2630 nos. trees are to be planted and for

**SEAC for grant of prior EC to the project subject to the following specific conditions:**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement
- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- V. PP will plant 3 years old 620 trees saplings of suitable indigenous tree species in 770 m Road side ha barrier zone during first year. Plantation of munga plants on priority shall be ensured by PP

## Minutes of the 478<sup>th</sup> Meeting of SEIAA dated. 11.04.2018

The case was discussed in 310<sup>th</sup> SEAC meeting dated 24.3.18 and is recorded as :

"Earlier this case was registered as Case No. - 5589/2017 M/s Sainik Foods Pvt. Ltd, HIG-5, Deendayal Nagar, Phase-1, Kanth Road, Muradabad, UP (SIA/MP/MIN/70353/17) Prior Environment Clearance for Sand Mine on Ken River in an area of 12.30 Ha. (3,69,000 cum per annum) (Khasra no. 730) at Village- Banjari, Tehsil - Chandla, Dist. Chhatarpur (MP) and was presented by the PP and their consultant in 300<sup>th</sup> SEAC meeting dated 08/12/2017 wherein during the presentation it was observed by the committee that as per the Google image of November, 2016 it was noticed by the committee that the lease area is >60% submerged in water and since the mid stream mining is not allowed PP was asked to submit recent photographs of the lease area clearly showing area available for sand evacuation with statement of mining officer about submergence of area in water and area available for mining. After presentation PP was asked to provide following:

1. Recent photographs of the lease area clearly showing area available for sand evacuation with statement of mining officer about submergence of area in water and area available for mining.
2. Revised operational production plan as per the above information.
3. Evacuation route marked on Google map.
4. CSR cost with bifurcation in capital and recurring cost.




