B. Review of DEIAA Case

Review of DEIAA, Panna Case No. 97/2016 of Shri Ramesh Kumar Gautam for stone quarry in 2.00 ha.in khasra No. 89 of Village Kaoda, Tehsil Pawai, Disrict Panna.

Shri Ramesh Kumar Gautam has submitted representation with all supporting document against DEIAA, Panna vide application dated 10.4.2018 for review as the Case No. 97/2016 has been kept at Serial No. 25 in 5th DEIAA meeting dated 23.12.16 but case has not been resolved. Hon'ble High Court in WP No. 2769/2017 has directed to resolve the issue within a period of 4 months vide its order dated 05.05.2017. Considering the request of applicant, DEIAA, Panna is hereby directed to examine and appraise the case by DEIAA/DEAC and take necessary decision at the earliest possible to resolve the issue. Copy to DEIAA Panna and applicant.

C. Policy Decision regarding Non- Submission of Compliance Report

It has come to the notice of SEIAA that the six monthly compliance reports are not being submitted by many Project Proponents to the concerned regulatory authority i.e. MPSEIAA/Regional Office, MoEF&CC, Gol Bhopal on regular basis as per prior EC Condition on 1st June and 1st December of each calendar year. It should be noted that submission of compliance report is mandatory as per section 10 of EIA Notification, dated 14th September, 2006. Further, non-submission of compliance report is also a violation of General condition of prior EC. A hard and soft copy of all backlog half yearly compliance report should be uploaded online on website or sent through e-mail / CD on regular basis i.e. for the period from January-June and July-December in each calendar year. It may also be noted that non furnishing of information may lead to violation of Section-20 of EP Act 1986 & may attract appropriate action including revocation of EC.

In context of above all Project Proponents are herby informed and directed to submit the compliance report to the concerned regulatory authority i.e. SEIAA/Regional Office, MoEF&CC,Gol Bhopal on regular basis as non furnishing of information is a violation under Section 20 of EP Act, 1986. A serious note in this regard has been taken into consideration and authority decided to issue reminder to all defaulters for submission of backlog compliance report as per condition stipulated in prior EC otherwise necessary action will be initiated against them including revocation of EC under the relevant provision of Environment Protection Act, 1986.
