



In response to 469th SEIAA meeting vide letter dtd. 24.02.18 received in SEIAA office 26.02.18 PP has submitted the information as follows:-


- Gap analysis report to justify the establishment of a new CBWTF in Mandideep industrial area within 75 km radius of other CBWTF including total no. of beds in Bhopal & surrounding districts (Bhopal, Vidisha, Sehore, Raisen, Hoshangabad, Betul, Harda) as per MoEF & CC, Gol Notification dtd. 28.03.2016 "These rules shall apply to all persons who generate, collect, receive, store, transport, treat, dispose, or handle bio medical waste in any form including hospitals, nursing homes, clinics, dispensaries, veterinary institutions, animal houses, pathological laboratories, blood banks, ayush hospitals, clinical establishments, research or educational institutions, health camps, medical or surgical camps, vaccination camps, blood donation camps, first aid rooms of schools, forensic laboratories and research labs."
- NOC from the AKVN dtd. 22.02.18 regarding water supply for the project.
- MoU is being executed by India waste Management Ltd. on the proposal of M/s Ramky Enviro Engineers Ltd. for disposal of hazardous waste.
- Under storm water management, PP has proposed well – designed network of open surface drains which check dams at appropriate distance to improve the infiltration efficiency of the rain water into ground so that all the storm water is efficiently drained off without any water logging. PP has also proposed rain water harvesting with 04 no. of recharging pits to collect rain water.
- Under CSR activities PP has proposed to provide safe drinking water & sanitation facility in nearby villages, waste segregation awareness programme, development of village school, plantation in nearby area, development of park/playground in nearby areas etc. with budgetary provision of Rs. 3.0 Lakh per year.
- Vide letter dtd. 27.02.18 a site visit report along with reply of Hon'ble NGT as per order dated 17.04.2017 received from MPPCB however, report on CTE issued by Board on BMW Rules – 2016 of CPCB considering the present scenario of already existed CBWTF within 75 km radius and bed capacity is still awaited.

In context of above it is decided that:


- A letter to MS, MPPCB to give their opinion regarding CTE issued by Board on BMW Rules – 2016 of CPCB considering the present scenario of already existed CBWTF within 75 km radius and bed capacity.
- A letter to Commissioner, Health Govt. of M.P to provide information regarding no. of beds including hospitals, primary health centre nursing homes, clinics, dispensaries etc exists in Bhopal, Raisen, Hoshangabad, Betul and Harda districts within 150km radius of the project site.

In response to above the reply was received from MPPCB (vide letter dtd. 05.04.18 received in SEIAA office 07.04.18), Directorate of Medical Services Madhya Pradesh (vide letter dtd. 24.04.18) and project proponent also which are as follows:-

- CSO, MPPCB informed that the CTE issued to the project under Water (Prevention & Control) Act, 1974 and Air (Prevention & Control) Act, 1981. The CTE was not issued to the project under BMW Rules, 2016. Further, for the Gap analysis report referred the "Review of coverage areas of CBWTF of MP - 2017.
- The information provided by the Director Health mentioned the district wise private health institutions and also district wise Govt. Health institutions along with the bed status. The list does not include various Govt. Medical Colleges and Private Medical Colleges and various Central Govt and Semi Govt. Institutions etc.

- PP has submitted details of Govt. Medical Colleges and Private Medical Colleges and various Central Govt and Semi Govt. Institutions, various Dental Colleges of Bhopal, Central Govt. & PSU Hospitals, various Gas Hospitals of Bhopal and their Sub Centres, ESIC Hospitals & Dispensaries, Police Hospitals and other Govt. Institutions and Non Bedded Institutions including number of beds. PP has also submitted that As per the report of the Pollution Control Board, Bhopal 2017 at present only 70% of the various healthcare facilities have been registered with them and around 30% need to be registered. The list submitted by the Directorate Health mentioned only the bedded hospitals and has not mentioned non bedded institutions but produces BMW like Clinics, Dental Labs, Blood Banks, Pathology labs, Animal houses, Ayush Clinics, Health camps and Forensic Laboratories.

It is noted that the list submitted by the Directorate Health does not include bed status of various Govt. Medical Colleges and Private Medical Colleges and various Central Govt and Semi Govt. Institutions etc. **It is decided that a letter to Directorate of Medical Education to provide number of hospital including status of beds in Govt. Medical Colleges and Private Medical Colleges and various Central Govt and Semi Govt. Institutions etc. exists in Bhopal, Raisen, Hoshangabad Betul and Harda districts within 150km radius of the project site.**

3. **Case No.5535 /2017** Prior Environmental Clearance for Stone Quarry (Open cast semi mechanized method) in an area of 7.760Ha.. for production capacity of 44657 TPA at Khasra no. 60, 72, 73 at Village- Bangaon (Heti) , Tehsil - Pandhurna, Dist. Chhindwara (MP) by M/s Adityaraj Stone Crusher, Shri Ujjawal Singh (Partner), S/o Shri Dashrath Singh Chouhan, Santoshi Mata Ward, Tehsil- Pandhurna, District - Chhindwara, MP - 480334

This case was recommended in 310th SEAC Meeting dated 24.03.2018 and it was recorded that :-


After deliberation the case was discussed in depth and PP was asked to submit the source & availability of water requirement at mining site for uses.



5. **Case No. 3298/2015**, Prior Environmental Clearance for **Dolomite Mine** (Opencast Mechanized method) in an area of 13.25 ha for production capacity of 4,59,705 TPA (As per SEAC Recommendation) Khasra Nos. Block HK1-1399, 1406, 1440, 1441, 1442, 1443, 1444/1-6, 1445, 1446, 1447, 1448, 1489/1-3, 1491, 1492, 1493, 1494, 1495, 1496, 1497 Block HK3- 1425, 1427, 1449/1, 1430, 1431, 1442, 1455/1-2, 1456, 1457, 1458 at Village- Kakiya, Tehsil - Bichiya, Dist. - Mandla (MP) by M/s. Heera Power & Steel Ltd. Shri O.G. Goyal (Executive Director) Plot no. 557, 563 & 564 Ultra Industrial Complex Raipur (CG) – 492003

Patric Dhanraj R/o 101-c Parwani Complex Civil Line Raipur (CG) – 492001.

7. **Case No. 1287/2013**, Prior Environmental Clearance for Stone/ Boulder Quarry in an area of 01.30 Hectares at Vill.-Dhanwada, Teh.-Khidkiya, Dist.-Harda (M.P.) by Shri Mohan Verma, Subhash ward, Harda, Distt.-Harda (M.P.)-461331.


This is case of Stone/ Boulder Quarry and recommended in 126th SEAC meeting dtd. 10.04.2013. After that Project Proponent (PP) nor his representative was not present or approached in SEIAA office regarding this case. Authority assumed that PP is not interested to continue with the project. But, this is a case of Minor Mineral having lease area less than 5 ha and to be appraised by DEAC & DEIAA as per MoEF notification dtd. 15.01.2016. After deliberation, the case was discussed in depth and it is decided to delist case and meanwhile, letter may be sent to Collector, Harda/ Chairman DEIAA to know the current status whether this case has been appraised by DEIAA or not.


8. **Case No. - 2373/2015** Prior Environment Clearance for Expansion of Jain Mines & Mineral (india) Environment Clearance for approval of proposed Iron Ore Beneficiation Plant (Existing Capacity 90,000 TPA, Proposed Capacity-4,80,000) at Industrial Area, Village-Hargarh, Tehsil-Sihora, District Jabalpur (MP) by Shri Pawan Jain- M.D. 127/1, Sangam Colony, Baldeobagh, Jabalpur (M.P.)-480002

This case was discussed in 478th SEAC meeting dated 11.04.2018 and it was recorded that.....

"Today, this case was placed before Committee as the TOR was approved in the 176th SEAC meeting dated 26/02/2015 and the same was issued to the PP vide letter no. 81 dated 10/04/2015 which was valid for 03 years. The validity of TOR expired on 25/02/2018. The committee observed that PP has neither submitted the EIA report

nor has applied for the extension of TOR's validity period and thus decided that this case may be recommended for delisting to SEIAA as TOR's validity has expired."

As per above recommendation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.

Since TOR validity has been expired hence it is decided to close the case. Copy to PP and all concerned.

9. Review of DEIAA Case


Review of DEIAA, Panna Case No. 78/2016 of M/s Trimbakeshwar Traders Partner Shri Satyendra Pratap Singh for Flag stone quarry in 1.36 ha.in khasra No. 197, 200 of Village Diya, Tehsil Pawai, Disrict Panna.


Shri Satyendra Pratap Singh has submitted representation with all supporting document against the decision of DEIAA, Panna vide application dated 23.4.2018 for review as the Case No. 78/2016 has been rejected by DEIAA vide letter No.170/DEIAA/2017 dated 11.10.17 due to existence of Human Habitation (Basti) at a distance of 308 m from sanctioned lease while this case was recommended by DEAC for prior EC in its 5th meeting dated 23.12.16.

As per the Notification dated 14.09.2006 issued by the MoEF & CC Govt. of India, it is amply clear that DEIAA shall normally accept the recommendation of DEAC. In cases of disagreement, DEIAA shall request DEAC to reconsider their recommendations after giving reasons of disagreement. Thereafter, DEAC shall consider the observation of DEIAA and furnish their views within a stipulated period. It is discretionary on the part of DEIAA to take a final decision after the considering the views of DEAC. From the record it was revealed that DEIAA Panna has not followed this procedure and acted unilaterally in reaching a conclusion.

It is therefore necessary on the part of DEIAA Panna to review and re-assess the procedure according to the Notification of MoEF & CC. DEIAA Panna is advised to review their decision of non issuance of EC on the grounds which are not in consonance with the environmental considerations and as per Section 8 of the Notification dtd. 14.09.2006 reverts to DEAC for reconsideration of their recommendations after conveying the reasons of disagreement. They are free to take a final decision after receiving the views of DEAC. Copy to Chairman DEIAA, Panna and PP
