The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':

- (ii). No in-stream mining shall be allowed.
- (iii). The depth of the pit shall be as per Approved Mining Plan.
- (iv). No in-stream mining shall be allowed. No ramp will be allowed within the river basin to transport sand to the other bank. Transportation will be allowed on the bank side where the mineral is being excavated.
- (v). The entire lease area should be properly fenced and boundary stones marked at the site.
- (vi). PP should ensure implementation of need based CSR activities for the local peoples.
- (vii). Transportation from the dense populated area will be avoided as committed by PP.
- (viii). Plantation shall be raised both side of the approach road with tree guard. Plantation of peepal, neem, drumstic plants on priority shall be ensured by PP
- (ix). Water sprinkling will be done on the approach road on the regular basis.

Hence, Prior Environmental Clearance is granted for Sand Mine (Open cast manual method) in an area of 11.50 Ha. for production capacity of 318600 cum / year at Khasra no. 854 at Village- Baghari , Tehsil - Chandla, Dist. 


