1. **Case No.5394/2016:** Prior EC for Common Biomedical Waste Treatment Facility, at Plot no.- 15 & 17 Village- Maneri, Tehsil-Niwas, District- Mandla, MP, total plot area 4000 sq.m. by AGM, M/s Medicare Environmental Management Pvt Ltd, 403, 4th floor, BPTP park centra, sector-30, NH-8, Gurgaon, Haryana-122001, Mob. No. 09810632693, E-mail: sanjayprakash.garg@ramky.com Consultant- Ramky Enviro Services Pvt. Ltd. Hyderabad.

1. The proposed project is Common Bio-medical Waste Treatment facility of Bio Medical Waste collected from the various health care establishments / unit generating bio medical wastes. Facility includes Incinerator, Autoclave, Shredder, Storage and Effluent Treatment Facility.
2. The proposed treatment facilities at the site are, Bio Medical Waste Segregation, Autoclave, Shredding and Incineration. The project is aimed to cater the needs of the Bio Medical waste generation units in the nearby Health Care Units of Mandla district of the state with an approximation of 20,000 beds@0.16-0.2kg/day/bed equals to 3.2-4 tons per day.







3. The proposed facility will cater to Mandla and the surrounding districts within 150 km radius (Balaghat, Chhindwara, Dindori, Jabalpur, Katni, Narsinghpur, Seoni)
4. The proposed project has been designed to treat up to 5 tons of bio-medical waste per day with following equipments:
 - a. Incinerator- 5 TPD (250 kg/hr)
 - b. Autoclave – 2 TPD (430 litres/batch)
 - c. Shredder- 150 kg/hr
5. The proposed project is for setting up of common bio-medical waste treatment facility and project falls under Category "B" Projects of activity 7 (da) as per EIA Notification dated 14th September, 2006 and its subsequent amendments dated 17th April 2015, under Bio- Medical Waste Treatment Facilities.
6. There is no National park / Sanctuaries, Eco-sensitive areas (DFO letter dtd 28.03.17), critically polluted areas and inter-State boundaries within 10 km of the proposed site; hence general conditions are not attracted as per EIA Notification 2006 its amendments.
7. The case was discussed in 282nd SEAC meeting dated 10/10/2016 and issued ToR vide letter dtd. 30.11.16. The ToR was approved by SEIAA in 380th meeting dtd. 03.11.16.
8. EIA report submitted by PP vide letter dtd. 29.12.17 and accordingly the case was discussed in 286th SEAC meeting dtd. 16.01.2018, 289th SEAC meeting dtd. 28.04.2017, 306th meeting dtd. 27.01.18 and 311st meeting dtd. 16.04.2018 is recommended for grant of prior EC subject to 59 special conditions.
9. The case was discussed in 481st SEIAA meeting dtd. 10.05.18 and PP invited for presentation.
10. After deliberation the case was discussed in depth and recorded that:-
 - i. Regarding land documents, PP has submitted Land registration document (dated 11/08/2016) and as per the land documents the land is the name of M/s Medicare Environmental Management Pvt Ltd.
 - ii. It is noted that a complaint letter received from M/s Elite Engineers 48, Narmada road, Jabalpur-482001, for Issues related to establishment of a New CBWTF at Village - Manera, Teh.- Niwas, Distt. - Mandla, (M.P.) against the Guide line of CPCB. In the said complaint it was mentioned that a new CBWTF is being developed at in Industrial growth Center Maneri, District- Mandla, M.P. which is just at 40 kms distance from the existing CBWTF which is violation of the CPCB Guide lines and the BMW Rules of 2016.
 - iii. The total water requirement for the proposed facility is 32 KLD. The primary source of water will be from M.P. Audyogik Kendra Vikas Nigam (Jabalpur),







Ltd., however alternatively water will be drawn from bore wells within the site if possible or else by external water tankers. PP has submitted commitment letter from AKVN (Jabalpur) Ltd. dtd. 07.02.17 for supply of 50 KLD water.

- iv. The wastewater generation will be 110 KLD and wastewater generated will be treated in in-house ETP of capacity 120 KLD. The treated water shall be reused in APCDs, greenbelt, etc. The facility shall be developed as Zero Liquid Discharge (ZLD) system. No treated wastewater shall be let out of the premises of the proposed CBWTF.
- v. The storm water drains are connected to rain water collection chamber. The rain water thus collected shall be used for greenbelt, vehicle washing etc., after treatment, if necessary. The facility shall be developed as Zero Liquid Discharge (ZLD) system. No treated wastewater shall be let out of the premises of the CBWTF.
- vi. Solid wastes shall be generated in the form of Incineration ash from Incinerator, ETP sludge from ETP process and used oil from the plant utility. For the management of solid waste PP has proposed the following :
 - Incineration ash from incinerator will be temporarily stored at ash storage pit and finally it will be disposed to the nearest authorized TSDF site.
 - Incineration ash and ETP sludge will be sent to authorized TSDF site.
 - Used oil will be properly stored and it will be re-used as lubricants in the machineries within the premises only.
 - Record of solid waste generation and disposal shall be maintained.
 - All necessary precautions shall be taken during handling, loading and unloading of solid waste.
- vii. Incineration ash and ETP sludge is hazardous waste in nature same shall be disposed through nearest authorized TSDF operator. No other hazardous waste handling or treatment shall be done in the proposed facility. If any hazardous waste found mixed with bio-medical waste shall be disposed of in compliance with Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.
- viii. The power required for the facility will be fetched from Madhya Pradesh State Electricity Board (MPSEB). For emergency backup DG is maintained with optimal usage by using a High Speed Diesel with a capacity of 100 KVA. Reduction in usage of traditional light bulbs with Light Emitted Diode (LEDs) means reduction in usage energy consumption. Usage of Solar energy at different locations in the plant like parking light, roadside light etc. will be explored.
- ix. Truck parking shall be provided with an area of 147 sq. m.




- x. The green belt will be developed for the proposed project in an area of 1320 sq. m (33 %) of the total site area. Greenbelt will be developed all along the boundary and along the roads for reducing the noise levels within the project.
- xi. Under CSR activities PP has proposed Health checkups, Installation of Hand pumps, Infrastructure Development of Schools, Construction of Community Toilets, Improving Waste collection/management infrastructure in Hospitals, Income Generation Training programs, Merit Scholarships for students, Veterinary camps and Para-Vet Services, Creation of Community Assets and Encouraging rural sports/events to make budgetary provision of **Rs.33.5 lakhs**.
- xii. Public Hearing for the proposed project was conducted on 06-09-2017 under the Chairmanship of A.D.M, Mandla. Some issues regarding, impact on human health and agriculture, medical check up camps, employment to local villagers were raised during the Public Hearing which were addressed by PP.
- xiii. The proposed project cost is Rs. 10 Crores
- xiv. **Benefits of the project:** The beneficial impact of proposed project on the civic amenities will be substantial after the commencement of project activities. The basic requirement of the community needs will be strengthened by extending healthcare to the community, building/strengthening of existing roads in the area which will help in uplifting the living standards of local communities. The project will create opportunities for employment to the nearby villagers.


In view of above it is decided to ask PP to furnish following information:

- Details of existing and proposed CBWTFs within 75 kms and 150 kms radius of your plant.
- Gap analysis study report to justify the establishment of a new CBWTF in Industrial growth Center Maneri area within 75 km radius of other CBWTF as per CPCB Guidelines and the BMW Rules of 2016 as raised by Elite Engineers.
- A letter to Commissioner, Health Govt. of M.P to provide information regarding no. of beds including hospitals, primary health centre nursing homes, clinics, dispensaries etc exists in Jabalpur, Balaghat, Chhindwara, Dindori, Katni, Narsinghpur and Seoni, districts within 150km radius of the project site.
- A letter to Directorate of Medical Education M.P to provide number of hospital including status of beds Govt. Medical Colleges and Private Medical Colleges and various Central Govt and Semi Govt. Institutions etc. exists in Jabalpur, Balaghat, Chhindwara, Dindori, Katni, Narsinghpur and Seoni, districts within 150km radius of the project site.





District Chhatarpur, MP by M/s Shri Maa Cimentech Pvt. Ltd, Shri Dileep Gupta, 158, 3rd Floor, Zone-II, M.P.Nagar, Bhopal MP – 462011.

- (1) This is a project pertaining to mining of Granite Deposit Mine in MLA of 11.0 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease for 30 years with production capacity of Granite – 33501TPA.
- (2) SEAC in its 313th SEAC meeting dtd. 18.04.2018 has recommended the case with 32 special conditions for issuance of EC.
- (3) The case was then discussed in 481st SEIAA meeting dtd 11.05.2018 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (4) It was noted that as per DFO, Chhatarpur Letter no. 1124 dated. 30.05.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area.
- (5) The proposed plantation programme was examined and it was found that 15640 sapling of tree species covering an area of 7.82 ha shall be planted during the lease period. Along with 600 sapling both side of transport route.
- (6) It was noted that the water requirement is 68.50 KLD (51 KLD for Dust Suppression + 1.5 KLD for Domestic + 10 KLD for Green Belt + 3.0 KLD for Drilling), which shall be met from Tankers.
- (7) **After detailed discussions and perusal of recommendations of 313th SEAC meeting dtd. 18.04.2018, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
 - I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
 - II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
 - III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. The plantation shall be carried out in the greenbelt area in current year with proper watering arrangement. The Chain-link fencing (10 ft.height) all around the mining lease area.
 - IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.





- V. PP should ensure to plant 3 years old 1288 nos of saplings of suitable indigenous tree species in 5000 sqm + 725 m Road side as a barrier zone during first year. Plantation of Drumstick, Neem Peepal, Bargad, Neem plants on priority shall be ensured by PP
- VI. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- VII. PP shall ensure to construct and maintain approach road and maintained the existing pakka road in consultation with District Administration. Plantation will be carried out on both side of approach road.
- VIII. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- IX. No overburden will be dumped outside the mine lease area.
- X. No blasting shall be permitted in the mining lease area.
- XI. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MP PCB.
- XII. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XIII. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XIV. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XV. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XVI. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XVII. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVIII. PP shall ensure proper implementation of plantation, dust suppression, approach road construction, maintenance of existing pakka road and constructed of garland drain with settling tank specially for prevention of pollution in nearby lake as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XIX. PP must ensure implementation of the following activities with separate budget provision should be kept under CSR :
 - a) Promotion of Skill development, Quality Education & Vocational Training for youth & women's.
 - b) Contribution for Infrastructure development – Play Ground, Roads & Drainage System.







Hence, Prior Environmental Clearance is granted for Granite Deposit Mine (Open Cast Other than fully mechanized Method) in an area of 11.0 Ha. for production capacity of 33501 TPA at Khasra no. 63(Part) at Village Barha, Tehsil Gaurihar, District Chhatarpur, MP for the lease period to M/s Shri Maa Cimentech Pvt. Ltd, Shri Dileep Gupta, 158, 3rd Floor, Zone-II, M.P.Nagar, Bhopal MP – 462011.

3. **Case No. - 885/2012 & Case No. 886/2012** Revalidation of Environmental Clearance of Granite mine (Open Cast semi mechanized Method) in lieu of Amalgamation of mining lease area of (21.736ha + 6 ha = 27.736 ha) for production capacity of (40, 000 cum/year + 20, 000 cum/year = 60,000 years) at khasra no 901 (forest compartment no. P- 703) at Village – Katahara, Tehsil – Lovekush Nagar, Distt. – Chhatarpur (M.P.) by Shri Nivedan Bhardwaj, M.D., M/s Fortune Stones Ltd. 11,Bungalow No. – 2, Lokanathpurm, Sagar Road, Distt. - Chhatarpur (M.P.) – 471001.
- (1) This is a case of lease amalgamation of Granite where two granite leases are in operations which are contiguous to each other and having area of 6 ha and 21.736 ha. The environment clearance was issued for both the leases for production capacity of 40,000 cum/annum for 21.736 ha and 20,000 cum/annum for 6 ha. Vide number 3089/EPCO- SEIAA/15 dated 14/01/201 and 3087/EPCOSEIAA/15 dated 14/01/2015.
- (2) Application were made by PP for the amalgamation of both the lease area under rule 16(2) of GCDR 1999 and obtained the order from DGM for single lease of 27.736 ha (21.736 ha + 6 ha) vide order no. F-4-17/2007/12/1 15.02.2016. It is proposed to merge the buffer zone considering the hillock topography of the leases, so that proper shape of mining will be attained and smooth, systematic and scientific operation can be performed. PP submitted that this will also help to remove the blocked/trapped mineral in barrier zone and benches
- (3) SEAC in its 311th SEAC meeting dtd. 16.04.2018 has recommended the case with 33 special conditions for issuance of EC.
- (4) The case was then discussed in 481st SEIAA meeting dtd 11.05.2018 and were decided to call PP/Consultant for presentation. Thereafter, PP/Consultant made a presentation on 17.05.2018 on all aspects of the project and all concerned issues were discussed in detail.
- (5) It was noted that as per Conservator Forest, Chhatarpur endt. Letter no 2140 dtd. 06.06.2014 the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. The mining site is







- (6) The proposed plantation programme was examined and it was found that 12700 sapling of tree species covering an area of 8.5296 ha shall be planted during the lease period.
- (7) It was noted that the water requirement is 159 KLD (126 KLD for Dust Suppression + 8.0 KLD for Domestic + 10 KLD for Green Belt + 5 KLD for Wire saw + 10 KLD for Drilling), which shall be met from Tankers.
- (8) After detailed discussions and perusal of recommendations of 311th SEAC meeting dtd. 16.04.2018, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
- I. Fencing shall be carried out in the periphery of the ML area
 - II. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
 - III. PP shall demarcate a barrier zone of 7.5 m towards the forest boundary as no mining zone and develop a green belt in it. The plantation shall be carried out in the greenbelt area in current year with proper watering arrangement. The Chain-link fencing (7 ft.height) 100 m long shall be also carried out towards the forest area in consultation with Department of Forest.







The project is reported to be at a distance of more than 10 km from National park and sanctuary thus it is not attracted by the general conditions and falls under category 'B-2' (Minor Mineral) by virtue of its location and mining lease area.
