**PP has submitted the information vide letter dtd 03.05.2018 & 31.05.2018., therefore it has been decided to relist the case and decided to call PP for presentation.**




The case was discussed in 454th SEIAA meeting dated 07-11- 2017 and it was recorded that :-



The case was discussed in 479th SEIAA meeting dated 12.04.2018 and it was recorded that :-






