The Ministry has direct to verify the distance of the said units from the interstate boundary and submit factual report at the earliest. On perusal of the complaint it was observed that the said industry has received EC from Impact Assessment Division, MoEF, New Delhi as considered Category "A" project on the basis of applicability of general conditions (located within 5 KM distance of the interstate boundary of Gujarat). The committee after deliberations recommends that the competent authority to verify the distance is district administration. 




