Shri Satyapal Singh Sikarwar, Hon'ble MLA, Sumawali, District Morena has made complaint vide their letter dated 25.09.2018 to cancel Environmental Clearance of Bijakpur Sand Mines of M/s Vedansh Minerals Resources due to irregularities as above khasra is 4.00 ha as per Form- P-II of year 2017-18 instead of 10.00 ha and above khasra is completely in river flow as per Collector letter dated 12.03.2018. After review of the complaint, it is decided to send complaint letter received from Hon'ble MLA, Sumawali alongwith technical file to SEAC for examination and give factual report for necessary decision.

- (1) This is a project pertaining to mining of Manganese Ore Mine in MLA of 4.906 ha. The activity is mentioned at S. No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1" by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of upto 22.03.2029 with production of 10800 TPA.
- (2) The mining lease was previously granted in the favor of Shri Mahesh Mishra for periods of 20 years dated 02.03.2009 vide Govt. of Madhya Pradesh, Mineral Resource Dept. Mantralaya, Bhopal vide order no. F-3-43/07/12/2. Later on, this mining lease was transferred in the name of M/s Metal & Minerals Vide State Government Order No. F-3- 4/11/12/2 dated on 02.04.2011. The Mining Plan has been approved by Regional Controller of Mines IBM, Nagpur and vide letter no. BGT/MN/MPCN-1017/NGP dated 16.03.2015.
- (3) SEAC in its 301st SEAC meeting dtd. 21.12.2017 has recommended the case with 29 special conditions for issuance of EC.
- (4) It was noted that as per DFO, Balaghat vide letter. no. 12351 dtd. 14.12.2015, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (5) It was noted that the water requirement is 20 KLD (10 KLD for Dust Suppression+ 6 KLD for Green Belt + 4 KLD for Domestic), which shall be met from Mine Sump, nearby villagers & Dam.
- (6) It was also noted that the Public Hearing was carried out on 23.02.2017 at Mine Parisar Village Selwa, under the Chairmanship of Collector, Balaghat. The major comments of applicants during public hearing are employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side, regular health check-up of mine workers & water sprinkling to suppress the dust emission.

This case was "discussed in 308th SEAC meeting dated 24.02.18 and is recorded as:

"Committee observed that again Shri Shalendra Jain has made a complaint referring the minutes of SEAC challenging the allotment of lease.

Committee after deliberations recommends that on the basis of the documents submitted by PP and forwarded by SEIAA the case was appraised and recommendations were made. If allotment of lease is challenged, same needs to be rectified by the competent sanctioning authority.

The case has been discussed in detail and observed that complaint from has been received Mr. Shailendra Jain in SEIAA on 15.03.18 regarding land use (Khasra No. 150/1, 150/3, 150/4) of mining lease area as Bhoojal, Prospecting lease area(150/4) is different from sanctioned mining lease area (150/1) and affecting course of Chandan River which is flowing just adjacent to mining lease area. Mr. Shailendra Jain has filed a case (OA-101/2017) in NGT. As per NGT order dated 24.1.18 in above case, MPPCB is directed to inspect the area to see in-stream mining. Scientist, MPPCB has inspected the site and submitted report. Question was also raised in State Assembly regarding this mine and reply was given by hon'ble Minister, Mineral Resource Minister in assembly.

Looking to sensitivity of the case, PP was asked to submit point wise information with supporting documents on issues raised in different forum. PP has submitted the pointwise information vide letter dtd 12.04.2018 in support of the case.

Approx. 18560.24 MT mineral has been excavated from mining lease area during year 2011-12 – 2016-17 which seems violation of prior EC as per EIA notification. However, DGM vide letter dated 14.12.15 has mentioned that leaseholder will be allowed to operate mine till the disposal of prior EC matter whose application has been filed in SEIAA before 31.12.15. Authority decided to seek clarification from Mineral Resources Department in this regard as case is registered in SEIAA on 15.06.16. Besides it is further decided to write Revenue Department, Govt. of M.P to seek clarification/comments regarding change of entry in revenue record of land use as Bhooljal (Jal Mad) for mining purpose whether mining activities can be carried out on the land of Bhoojal mad (head) of revenue record without change of revenue head.

As per above decision, letter was written to Revenue Department and Mineral Resources Department to seek clarification. In response to SEIAA letter, Collector, Balaghat has intimated that land use of proposed mining lease area is recorded as as Bhoojal (Jal mad) as per Revenue record and title has not been changed so far. Besides this, Under Secretary, Mineral Resources Department vide letter No 3915/691/2018/12-2 dated 25.8.18 has informed that DGM letter dated 14.12.15 has been quashed by Hon'ble NGT(PB) vide order dated 4.05.16 in OA 34/2016. Hence, mineral excavation carried out from proposed mining lease area is violation of Prior EC as per EIA notification. Therefore, it is decided to close the case with direction to PP not to do mining activities in said land without obtaining prior EC. Copy to PP and all concerned.

- v. The proposed project is designed as a Zero Liquid Discharge unit. The effluent will be segregated as HCOD/HTDS and LCOD/LTDS effluent. HCOD/HTDS effluent will be neutralized and sent to Stripper followed by MEE and ATFD and then further treated in ETP (Primary, secondary and tertiary treatment) along with the LCOD/LTDS effluent and Domestic effluent followed by R.O system. It is decided to accept the recommendations of 321st meeting dtd. 16.08.2018 with 53 conditions and grant Prior Environment Clearance for API Manufacturing Unit in Plot No. 825, 826,827, Total capacity: 324.437 MT/A. Pitampur Industrial Area, Sector - III, Taluka - Dhar, Dist. Dhar, (M.P.) by M/s Enaltec Labs Pvt. Ltd, Plot No. 825, 826, Pitampur Industrial Area, Sector - III, Taluka - Dhar, Dist. Dhar, subject to the following specific conditions:-

- The demand of fresh water should be met through MPAKVN and no ground water will be extracted for industrial purpose without prior permission of CGWB.
- 2. Waste water Management:
 - (a) PP should maintain zero discharge from the Industry as proposed.
 - (b) Separation of High & Low COD values effluent for better management for process of effluent.
 - (c) RO treated water will be recycle for the process and High COD effluent generation shall be completely evaporated with help of MEE so as to achieve zero discharge.
 - (d) There shall be no industrial effluent discharge from the unit.

3. For Air Pollution:

- (a) PP should ensure air pollution control measures and stack height as proposed in the EIA/ EMP.
- (b) The performance of air pollution control system should be regularly monitored and maintained.
- (c) PP should ensure regular stack monitoring & ambient air quality monitoring and should be carried out as per the guidelines/norms of MPPCB/CPCB.
- (d) In plant control measures for checking fugitive emission from all the vulnerable sources shall be provided. Fugitive emission shall be controlled by providing closed storage, closed handling & conveyance of chemicals/materials, multi cyclone separator/bag filters and water sprinkling system.
- (e) Dust suppression system including water sprinkler system/ foaming arrangement shall be provided at loading and unloading areas to control dust emission.
- (f) Fugitive emission in the work zone environment, product, raw material storage areas etc. shall be regularly monitored.
- (g) Transportation of raw material and finished goods should be carried out in covered trucks.

(h) For control of fugitive emission and VOCs following steps should be followed:-

- Chilled brine circulation system shall be provided and it should be ensured that the solvent recovery efficiency is not less than 98%.
- Reactor and solvent handling pump shall be provided with mechanical seal to prevent leakage.
- Closed handling system should be provided for chemicals.
- System of leak detection and repair of pump/pipeline should be based on preventive maintenance.
- Solvent shall be taken from underground storage tank to reactor through closed pipeline. Storage tank shall be vented through trap receiver and condenser operated on chilled water.

4. Hazardous Waste:

- (a) PP should ensure disposal of hazardous waste regularly and there should be no dumping of these materials in the premises/outside.
- (b) PP should ensure handling, disposal and management of hazardous waste as per the related prescribed rules.
- (c) PP should obtain renewal of authorization regularly from MPPCB for collection storage and disposal of hazardous waste (Management, Handling & Trans Boundary Movement) Rules 2008 and its amendments. Membership of the TSDF should be obtained for hazardous waste disposal.
- (d) Hazardous chemicals should be stored in sealed tanks, drums etc. Flame arrestors shall be provided on tanks. To avoid the spillage from processing unit, Industry shall provide fully mechanized filling and packaging operation unit.
- (e) PP should provide RCC layer and double layered HDPE lining for primary and secondary leachate collection.
- (f) PP should obtain NOC /approval from competent authority for health & safety measure, Onsite & Offsite disaster management, and Risk management plan before commencing the operation of the unit.
- 5. PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures and energy efficient equipments.

6. Green Belt:

- (a) PP should ensure to carry out plantation in 8914 sq mt area of the project by planting 1316 plants of Amaltas, Satparni, Chandkal, Kusum, Mahua, Asan, Neem, Chameli, Baheda, Lasora, Kanak Champa, Chilbil, Bhut Vriksha, Sheeshan, Neem and Dhau and other local indigenous species etc. as committed.
- (b) Pollution control trees should be planted in the green belt area
- (c) Explore the possibility to increase the plantation area and number of trees within the premises, periphery the premises if possible include the additional area for plantation.
- 7. PP should ensure the implementation of CSR activities such as to provide basic amenities to schools in Kheda and Khandwa village and Government Hospitals at Pithampur and organize health check-up camp for the students of Kheda and

- The proposed area is located drainage of Goi River which is the important source of water to downstream Village in paty block.
- 11. The main route is 60-70 meter from the mine site.
- III. Some raw maken are present within 50-60 meter distance.

- It is proposed to build a Barrage on the river.

While this case was not recommended by DEAC for prior EC in its meeting. It is also clarified by Collector, Barwani & Chairman DEIAA Barwani vide L.No. 728/DEIAA/18 dated 30.08.2018 as per the recommendation & after site visit by EE, WRD, Barwani that the lease area will be under submergence of Goi River Barrage and due to adverse impact on the barrage project, it is not recommended for Prior EC.

As the Case No. 47/2017 has been rejected by DEIAA vide letter No. 24/DEIAA/2017 dated 11.12.17 due to allotment of proposed area is located on the downstream of the Hill and there is a resource of natural water storage and also the proposed area is surrounded by the dense plantation which was done on 02.07.2017 as part of Narmada Conservation, while this case was not recommended by DEAC for prior EC in its meeting.

After review of the case, SEIAA is agreed with the decision of DEIAA Barwani and no action is required. Copy to Chairman DEIAA, Barwani and PP.
