This case was discussed in 430th SEIAA meeting dated 15.05.2017 and it was recorded that :-

- (1) *This is a project pertaining to mining of **Limestone & Dolomite Mine** in MLA of 38.84 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. and forest boundary is more than 250 m distance from the ML area. The interstate boundary is not applicable as mining site falls in Vill. Pondi, Teh.- Dheemarkheda, District-Katni (M.P.), thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease for 20 years with production capacity of **Limestone 111275 TPA & Dolomite 111530 TPA***





- (2) It was reported by the PP that the lease area was granted to Shri Shyam Lal Kol R/o village- Kuthla, Post- Kuthla Tehsil- Murwara Dist. - Katni for 20 years 24.07.2002 to 18. 04. 2022. This is a case of new mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM (vide letter No. MP/katni/Limestone/M.Sch.-01/15-16 /3190 Jabalpur dated 09.06.2015).
- (3) SEAC in its 72nd SEAC-II meeting dtd. 11.04.2017 has recommended the case with 22 special conditions for issuance of EC.
- (4) The case was then discussed in 426th SEIAA meeting dtd. 02.05.2017 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) It was noted that the water requirement is 10 KLD (05 KLD for Dust Suppression+ 2.5 KLD for Green Belt + 2.5 KLD for Drinking & Washing), which shall be met from Bore well and Mine sump.
- (6) It was noted that the Public hearing was carried out at the mine site, Village - Pondi, Tehsil - Dheemakheda, District- Katni on dtd. 16.02.2017, under chairmanship of ADM Katni.
- (7) PP has committed that fencing shall be carried out all around the lease area before commencing any mining activity. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP
- (8) The proposed plantation program was examined and it was found that 6500 trees shall be planted in an area of 3.0 ha at the end of lease period.
- (9) PP shall demarcate a barrier zone of 10 m as no mining zone in the periphery of mining lease area and develop a green belt. The three row plantation shall be carried out in the greenbelt area in current year.
- (10) Proper shelter for the labourers having an area of 100 sqm is to be provided with potable drinking water, toilet and first-aid facilities.
- (11) Road coming from Bichhua Village is intersecting lease area, PP will fence the boundary of ML area in such a fashion so that traffic of village will not be disturbed.
- (12) PP has committed to leave 2.5 ha for conserving the natural drain passing through the lease area.
- (13) After deliberation the case was discussed in depth and PP was asked to submit the following information :-
 - i. Transportation plan route with narrating the name of villages with details of type of road (Kachha & Pakka ownership of road so that it may be decided for maintenance of road) approach & connecting road network.
 - ii. Validation of mining lease from District Collector so that it may be decided regarding the ownership in the present scenario.
 - iii. Revised NOC of DFO Katni regarding distance from forest boundary, in the given certificate of DFO the forest boundary is 860 m from the lease boundary but in the google map it seems the forest boundary is adjacent to the mining lease area on the southern side. There is one more forest area on the western side of the lease area.
 - iv. Revised EMP giving budget provision for construction & maintenance of road & settling tanks
 - v. PP has informed that in small segments mineral transportation through service road of canal belonging the department of WRD is being used, so NOC of WRD be submitted.

Again the case was discussed in 463rd SEIAA meeting dated 04.01.2018 and 506th SEIAA meeting dated 17.10.2018.





PP has submitted point wise information on above issues vide letter dated 09.10.2018 which is found satisfactory and presentation made by the PP in SEIAA, it was decided to accept recommendation of 72nd SEAC-II meeting dtd. 11.04.2017 for grant of prior EC to the project subject to the following specific conditions:

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall demarcate a barrier zone of 7.5 m towards the forest boundary as no mining zone and develop a green belt in it. The plantation shall be carried out in the greenbelt area with proper watering arrangement.
- III. PP shall ensure to construct boundary wall in sanctioned lease area towards plantation area and leave 50 m as no mining zone towards forest boundary as per Commissioner Committee report dated 1.09.18.
- IV. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- V. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VI. PP will plant total 3000 plants of local indigenous species during mining. Out of which, PP will plant 3 years old 500 trees samplings of suitable indigenous fast growing tree species (neem, amla, ashok, drumstick etc.) towards the barrier zone/no mining zone along the transportation route during first year.
- VII. PP shall ensure to maintain approach road from the mine site. Plantation will be carried out on both side of the approach road. PP shall also ensure maintenance of existing pakka road (Village Pondi to Bichhua is 3 km) in consultation with competent authority.
- VIII. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- IX. Transportation of minerals will not be allowed through the canal route as committed by PP.
- X. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- XI. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XII. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XIII. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.

- XIV. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XVI. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road constructed of 3 nos. settling tank (6X3X3M), Garland Drains (2m wide and 1m deep at the bottom of the OB Dump) Dump rehabilitation, Soil management, Retaining walls of the periphery of the OB dumps with budget provision of Rs. 7.10 lacs per year as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVIII. PP must ensure implementation of the following activities for that separate budget provision should be kept under CSR.
- a) Health awareness camp in nearby areas.
 - b) Village road construction as per demand area.
 - c) Repairing of School Building in Pondi Village.
 - d) Free distribution of school books for childrens.
 - e) PP shall provide drinking water facility in village Pondi & Bichhua
 - f) Need based works.


All the modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.


- XIX. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA



Minutes of the 508th Meeting of SEIAA dated. 15.11.2018

- (1) This is a project pertaining to mining of Dolomite Mine in MLA of 9.595 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary thus it is not attracted by the general conditions and falls under category 'B-2' (Minor Mineral) by virtue of its location and mining lease area. It was noted that forest boundary falls under < 250m from ML area as per (Divisional Forest Officer South Chhindwara vide letter no. 408 dtd. 18.03.2016). The case was forwarded by SEAC to SEIAA for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine **having valid lease of 20 years** with Expansion in Production capacity from 20000 MTPA to 7,00,000 MTPA.
- (2) PP has submitted the NOC of the Commissioner Committee Jabalpur report regarding mining leaving 60 m. from the forest boundary subject to all conditions given in the report of DFO, Chhindwara mentioned in para-(1).
- (3) PP had submitted before SEAC that the transportation of mineral shall be done through an alternative route approximately 8.5 km. bypassing the existing villages on the route. The cost of WBM road shall be borne by all the miners working in nearby locations. PP has committed to monitor and share the cost of construction of the WBM road.
- (4) PP has ensured to construct garland drain of 1.5 m x 1.5 m. all around the lease area.
- (5) PP has ensured for carrying out scientific mining, PP has proposed height of bench upto 6 m. (6 nos.)
- (6) PP has committed before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP
- (7) PP has committed under CSR activity in addition to the proposed activities following activities should be added.
 - a) Computer education: providing at least 02 computers in nearby school and providing facilities of teacher for computer education and basic education
 - b) Provide financial support to the village school
 - c) Facilitate youths & farmers of selected villages both on on-farm and off-farm activities based on need, interest and market potential. Promotion of advanced agriculture practices and water efficient farming practices.
 - d) For ensuring this awareness generation campaign, wall writing, village level theme camps. Promoting villagers to construct toilets to stop open defecation. Provision of supply of drinking water to the villages.
 - e) Need of the old age home will be assessed and shall be provided on yearly basis or financial assistance shall be provided every year to the old age home at Sausar.
 - f) Solar street light at nearby villages.
- (8) It was reported by the PP that the lease area was granted to Murlidhar Minerals Prop. D. M. Gandhi for 20 years. As per Minerals Resources Department of MP. Order No. 3-80/1980/12-2 dtd. 12.09.2013 (from 10.05.2014 to 09.05.2034) This is a case of existing mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM Nagpur (vide letter No. CNW/DDM/MPLN/333/ NGL dtd. 20.12.2013)
- (9) The case was recommended for prior EC in 65th SEAC-II meeting dtd 17.01.2017 with 12 special conditions.
- (10) The proposed plantation program was examined and it was found that 12250 sapling of tree species covering an area of 5.5 ha. shall be planted during the lease period. If trees found within the mining site which should be conserved as far as possible. PP has also committed to plant tree species mainly neem of three years age and at least three feet high along the 8.5 km. route in consultation with the other miners on a sharing basis.



 - Compliance report of the previous EC granted in this case by SEIAA.





After detail discussion and review, it was decided that PP should submit compliance report of of earlier prior Environmental Clearance certified by MoEF & CC Regional Office at the earliest. So that further action can be taken".

PP has submitted self certified compliance report vide letter 25.10.2018 with a request to consider the case. It is also mentioned that PP has obtained the consent under Air & Water by MPPCB for the period from 01.03.2014 to 28.02.2017 & 01.03.2017 to 28.02.2018. The information submitted by PP is found satisfactory and presentation made by the PP in SEIAA, it was decided to accept the 65th SEAC-II meeting dtd 17.01.2017 recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:

- I. PP should ensure to submit certified compliance report from RO, MoEF & CC or MPPCB within the period of six months in MP-SEIAA.
- II. PP should construct garland drain of 1.5 m x1.5 m. all around the lease area.
- III. PP shall ensure to carry out scientific mining with 6 benches of 6 m. height.
- IV. No transportation shall be permitted within the village. Alternate transportation route should be decided in consultation with the local Gram Panchayat.
- V. PP shall ensure protection and conservation of existing trees falling under mining lease area and in no way these will be permitted to be cut / uprooted
- VI. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- VII. PP shall demarcate a barrier zone of 7.5 m towards the forest boundary as no mining zone and develop a green belt in it. The plantation shall be carried out in the greenbelt area in current year with proper watering arrangement. The Chain-link fencing/Boundary wall of atleast 7ft. height shall be provided/constructed towards forest site before execution of mining operation. PP should carry-out plantation of minimum 2 m. inside the fencing as per Commissoiner Committee Report dated 05.06.2013.
- VIII. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.







- IX. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- X. PP will be rehabilitated by planting 19280 saplings of native species in an area of 9.595 ha at the end of conceptual period.
- XI. PP shall ensure to construction & maintain approach road from the mine site. Plantation will be carried out on both side of the approach road. PP shall also ensure maintenance of existing pakka in consultation with competent authority.
- XII. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- XIII. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- XIV. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XV. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XVI. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XVII. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XVIII. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XIX. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XX. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XXI. PP must ensure implementation of the following activities with separate budget provision should be kept under CSR.
- a) Computer education: providing at least 02 computers in nearby school and providing facilities of teacher for computer education and basic education
 - b) Provide financial support to the village school
 - c) Facilitate youths & farmers of selected villages both on on-farm and off-farm activities based on need, interest and market

potential. Promotion of advanced agriculture practices and water efficient farming practices.

- d) For ensuring this awareness generation campaign, wall writing, village level theme camps. Promoting villagers to construct toilets to stop open defecation. Provision of supply of drinking water to the villages.
- e) Need of the old age home will be assessed and shall be provided on yearly basis or financial assistance shall be provided every year to the old age home at Sausar.
- f) Solar Street-lights at nearby villages.

All the modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.

XXII. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA

Hence, Prior Environmental Clearance is granted for Malegaon Dolomite Mine (Opencast Mechanized Method) in an area of 9.595 ha. for expansion in production capacity from 20000 MTPA to 7,00,000 MTPA at Khasra No. 86 at Village-Malegaon, Tehsil - Sausar, Dist. Chhindwara (MP) for the lease period to M/s Murlidhar Minerals, Prop. Shri D.M. Gandhi R/o 316, Shri Krishna Apartment, Khare Town, Dharampeth, Nagpur (MT) – 440010.




The case was discussed in 289th SEIAA meeting dtd 04.02.2016 and it was recorded that:-


