





1. **Case No.2853/2015** - Prior Environmental Clearance for Bijayan Iron Ore & Manganese Deposit (Open cast other than fully mechanized method) in an area of 27.610 ha. for production capacity of Iron Ore is 1,54,683 TPA and Manganese Ore 5309 TPA. Total proposed production 159992 TPA along with Beneficiation Plant 500000 TPA of low grade Iron ore dust at khasra no 101 at Village-Bijayan, Tehsil-Sihora, District-Jabalpur (MP) by Shri Mukul Khampariya, Mahagawan Road, Khitola, Post-Sihora, District -Jabalpur (MP)-483225.

- (1) This is a project pertaining to mining of Iron Ore & Manganese Deposit in MLA of 27.610 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period of 30 Years (As per MRD, MP Govt. vide L.no. F-3 24/201/12/2 dtd. 26.02.2014) with production capacity of of Iron Ore is 1,54,683 TPA and Manganese Ore 5309 TPA Total proposed production 159992 TPA along with Beneficiation Plant 500000 TPA of low grade Iron ore dust.
- (2) SEAC in its 332nd SEAC meeting dtd 26.10.2018 has recommended the case with 35 special conditions for issuance of EC.
- (3) The case was then discussed in 509th SEIAA meeting dtd 16.11.2018 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (4) It was noted that as per DFO L.No. 1971, Jabalpur dtd. 13.06.2017, the National Park/Sanctuary is not located within 10 Km, radius from the mining site. Hence, the General Conditions are not attracted.




- (5) It was noted that the water requirement is 100 KLD (15 KLD for Dust Suppression + 5 KLD for Green Belt + 5 KLD for Domestic+ 75 KLD for Beneficiation unit), which shall be met from Mine sump, Tubewell.
- (6) The proposed plantation programme was examined and it was found that 9.07 ha area 22500 sapling shall be covered under plantation at the end of conceptual period.
- (7) It was also noted that the Public Hearing was carried out on 12.04.2018 at Mine Parisar Village Bijayan, under the Chairmanship of ADM, Jabalpur. The major comments of applicants during public hearing are water for irrigation, access on approach road, Controlled blasting, employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side , regular health check-up of mine workers & water sprinkling to suppress the dust emission.

After detailed discussions and perusal of recommendations of 332nd SEAC meeting dtd 26.10.2018, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:


- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- IV. PP shall ensure to construct and maintain 3.5 km approach road and maintained the existing pakka road in consultation with District Administration. Plantation will be carried out on both side of approach road.
- V. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VI. PP shall ensure to plant 22500 saplings in 9.07 ha area as committed at the end of conceptual period.
- VII. PP will plant 3 years old 1000 trees samplings of suitable indigenous fast grow tree species (neem, amla, ashok, drumstick etc.) in barrier zone/no mining zone along the transportation route during first year.
- VIII. PP shall ensure to construct and maintain approach road from the mine site. Plantation will be carried out on both side of the approach road. PP shall also ensure maintenance of existing pakka road in consultation with competent authority.





- IX. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- X. No overburden will be dumped outside the mine lease area.
- XI. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- XII. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XIII. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XIV. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XV. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XVI. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XVII. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVIII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XIX. PP must ensure implementation of the following activities with separate budget provision should be kept under CSR.
- a) Education (Renovation of Anganwadi Centre, donation to Anganwadi center and Primary School renovation, donation of toys, furniture, etc.).
 - b) Meritorius student scholarship (Distribution of Laptops, etc.)
 - c) Vocational Training to unemployed youth.
 - d) SHG Support (women SHG).
 - e) Medical Facility (Regular Health Camps).
 - f) Maintenance of village roads.
 - g) Infrastructure development (Construction of hand pumps, installation of treated drinking water supply system, community plantation, etc.)




----- PP has submitted the response of above quarries vide letter dated 24.10.2018 which was placed before the committee and the same found satisfactory. The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':

After detailed discussions and perusal of recommendations of 330th SEAC meeting dated 24.10.2018, presentation made by the PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-

- I. PP shall not start mining activity before execution of lease agreement.
- II. The depth of the pit shall be as per the Approved Mining Plan.
- III. The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary.
- IV. Proper sign boards highlighting the dangers of trespassing by the villagers should be installed at four corners of the lease area.
- V. PP shall ensure to construct approx 20 m. WBM road upto the junction of main pakka road and also construct and maintain 900 m approach road. Plantation shall be carried out on both side of approach road.
- VI. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.

- a. The legal undertaking stating that the project will be handed over to Municipal Corporation, Katni for its operation & maintenance as well as compliance of EC conditions. **PP has not submitted the consent from Municipal Corporation, Katni for the same.**
- b. The storm water management plan depicting the location of RWH and peripheral drainage.
- c. Fire fighting plan along with distance of fire station from the project site.
- d. Energy conservation plan.
- e. Details of proposed parking in the project area.
- f. Environment Management plan along with cost bifurcation (Capital cost & annual recurring cost).
- g. Details of green belt plan.

The submission of PP discussed in detail and it has been observed that **PP has not submitted the consent from Municipal Corporation, Katni regarding operation and maintenance of the all assets to be created under the project and compliance of the environmental conditions to be imposed by SEIAA after completion of the project. PP may be asked to submit the consent from Municipal Corporation, Katni for the same.**


