


## Minutes of the 523<sup>rd</sup> Meeting of SEIAA dated. 15.02.2019




*"----- PP has submitted the response of above quarries vide letter dated 30.01.2019 which was placed before the committee and the same found satisfactory. The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A'"*

PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail. **After detailed discussions and perusal of recommendations of 340<sup>th</sup> SEAC meeting dated 30.1.19, presentation made by the PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-**

- PP shall not start mining activity before execution of lease agreement.
- The depth of the pit shall be as per the Approved Revised Mining Plan.
- The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary.
- PP shall ensure to construct and maintain 0.50 km. approach road. Plantation will be carried out on both side of approach road.
- PP shall ensure the proper water supply arrangements for dust suppression, regular sprinkling, plantation and drinking purposes especially in summer season.

- VI. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- VII. PP shall ensure to conduct following CSR and Labour Welfare activities as committed.
- Sports facility will be provided to one school in a village per year.
  - Provide to Drinking water facility and temporary rest shelter.
  - Provide to separate toilets for male and female.
  - Regular medical check-up of laborers.



4. There is no interstate boundary and no National Park / Sanctuary within the 10 km of the project area (DFO letter dtd. 04.01.14) hence the general conditions are not attracted.
5. The project includes isolated storage & handling of hazardous chemicals and covered under 6 (b) category of the MoEF, GoI EIA Notification, 2006 and its amendments.
6. ToR issued by SEAC vide letter dtd. 21.01.2018 and EIA report submitted by PP on 17.10.18.
7. Public hearing was conducted on 03.08.18 within the premises of the LPG bottling plant at Village - Bhitoni, Bhamki, Tehsil - Shahpur, Dist. Jabalpur (MP) under the Chairmanship of Additional District Magistrate, Jabalpur. Some issues were raised during public hearing which were readdressed by PP.
8. The case was discussed in SEAC meetings 303<sup>rd</sup> dated 23.12.2017, 334<sup>th</sup> dtd. 30.11.18 and 340<sup>th</sup> dtd. 30.01.19 is recommended for grant of prior EC subject to specific conditions.
9. After deliberation the case was discussed in detail and recorded that :-
  - i. The BPCL Plant is located on 69 Acres area of land and is sufficient for its existing and proposed enhancement. The land use of the proposed LPG plant is given below.







- ii. Regarding land document PP has submitted an agreement (dtd. 3rd March 1984) executed between Bharat Petroleum Corporation Limited and Governor of Madhya Pradesh through Collector, Jabalpur under section 41 of the Land Acquisition Act, 1894. PP has also submitted Khasra Panchsal 2015-16, as per the Khasra Panchsal the landownership is the name of Bharat Petroleum Corporation Limited, Jabalpur.
- iii. There is no continuous source of air pollution from the process of existing facilities of Depot. because the entire bottling process is carried out closed circuit through piping from storage area to filling shed. There shall not be any continuous source of air emission from the proposed facilities. For release of emission from the DG sets in case of power failure and operation of fire engine PP has proposed adequate stack height as per CPCB guidelines at the above roof height for proper dispersion and Water sprinkling at regular basis.
- DG sets installed at BPCL Bhitoni (Jabalpur) LPG Bottling plant are operated occasionally in case of power failure and these are not regular source of gaseous emissions. LPG Lorries and trucks have pollution under control (PUC) certificates. Regular maintenance of LPG Lorries and trucks is ensured.
- iv. Total water requirement at the existing LPG bottling plant is 14 KLD, which meet by bore well present at the site. For withdrawal of ground water PP has applied to CGWA (vide app no. 21-4/719/MP/IND/2018).
- v. The plant will require 4 KLD of water for domestic use and it will generate 2.5 KLD sewage which will be left to Soak pit and septic tank. The Plant will require 10 KLD of water for industrial use for cylinder washing purposes which will generate 8.5 KLD of effluent. The effluent generated from cylinder washing will be sent to OWS (oil water separator). The treated 8 KLD approx. of waste water will be used for gardening, floor washing & flushing.
- vi. Municipal wastes (paper plastic, food wastes, etc) generated from LPG plant will be collected and segregated. Recyclable wastes like paper and plastic wastes will be sent for recycling, while biodegradable wastes like food and vegetable wastes will be disposed in compost pit. Non biodegradable and non- recyclable wastes will be sent to common landfill site.
- vii. The hazardous wastes generated at the LPG plant are 30 Litres/ annum (from DG sets), 50 Lit/Annum • oily sludge (from O&W separator), Oily sludge of 1,000 litres approx (in a period of 5 years from all LPG storage tanks). It will be stored in MS drums and sent to MoEF/PCB authorized recyclers.








- viii. The maximum contract demand for the plant is about 450 KVA which is to be obtained from MPEB (Madhya Pradesh Electricity Board). DG Sets of capacity 1 x 400 KVA, 1 x 380 KVA and 1 x 100 KVA capacities having acoustic enclosures have been provided to meet the power requirement during grid power failure & the 1 x 100 KVA capacity DG set will be used in emergency.
- ix. For Fire Fighting PP has proposed as follows:-
- Water storage tank: 3 Nos. (2 x 3000 KI under ground and 1600 KI above ground).
  - Fire water is obtained from Bore well water supply.
  - Fire water pumps: 5 Nos. (capacity 854 KI/hr, centrifugal type)
  - Jockey fire pump: 2 Nos. (capacity 27 KI/hr, Set pressure of 10 kg/cm<sup>2</sup>)
  - Pressurised fire hydrant system Other necessary facilities to support fire fighting during emergency are as given below:
    - Internal communication : page phone, BVHF hand sets, public address system
    - External communication : landline and mobile
    - Warning system for fire: 1 no. electrical siren with 2 km range and 10 nos of hand siren with range 1 km.
- x. It is noted that PP has proposed to cut some existing trees on the site and also obtained NOC (dtd. 07.12.18) from DFO, Tehsil Shahpur, Jabalpur. PP has proposed 38% of land area will be developed for green belt by planting 400 number of trees upto year 2019-21.
- xi. Under CSR activities PP has proposed construction of toilets, community hall, school and hospital building renovation in Bhamki & pondi village. etc with budgetary provision of **Rs. 170 lakh**.
- xii. **Budgets For Implementation of EMP And Monitoring Plan:** The budget for implementation of mitigation measures and environmental management plan to mitigate the potential adverse environmental impacts during operation phase has been estimated as capacity cost Rs 48.5 Lakhs and recurring expenditure as Rs 17.3 Lakhs.
- xiii. Total cost of the project is Rs. 7,845 Lakhs.
- xiv. **Benefit:** The proposed expansion by addition/installation of 03 mounded vessels of 1,450 MT capacity each, at existing LPG bottling plant, will yield benefits that Provide continuity of LPG gas cylinder supply to the consumers. Availability of LPG will discourage deforestation and improve the quality of women engaged in household activity in cooking.







- (1) The project authorities shall comply with the provision made in Manufacture, storage and Import of Hazardous Chemicals Rules 1989, as amended and the Public Liability Insurance Trans – boundary Movement) Rules 2008.
- (2) PP should obtain clear NOC from CGWA for withdrawal of ground water.
- (3) PP shall plan the CSR activities as per local villagers needs and should consult District administration for implementation of the CSR activities.
- (4) Oil and water separator should be installed at appropriate places.
- (5) PP should install solar panels for all external lighting and additional solar panels should also be installed for future expansion. .
- (6) PP shall ensure no leakage on any transfer point.
- (7) PP should conduct educational/awareness programme in coordination with M P Pollution Control Board.
- (8) Provision of clean energy should be made in environmental management plan.
- (9) PP should prepare off-site and on-site emergency plans and carry out mock drills in consultations and coordination with the District Administration and as per safety rules of the Industrial Health and Safety.
- (10) PP should ensure the traffic movement plan, parking facilities and road width.
- (11) PP should obtain NOC for fire fighting from Competent Authority.
- (12) Under green area development PP should ensure : -
  - (a) Plantation in two rows all along the periphery of the project area, and along the roads, subject to 38% of the total area of the project as proposed.
  - (b) Plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karnj, Kachnaar etc.
  - (c) Plantation should be completed within one year.
  - (d) Green area including thick green-belt shall be developed of the plot area to mitigate the effect of fugitive emissions all around the plant in consultation with the forest department as per the guidelines of CPCB.







- (e) PP should compliance the condition lay down by DFO, Jabalpur for cutting the trees in the proposed area and every effort should be made to protect the existing trees on the plot.

4. **Case No. 5815/2019** - Prior Environmental Clearance for Papredi Marble Mine (Opencast Semi- Mechanized Method) in an area of 4.50 Ha, for Production Capacity 10,000 cum per year at Khasra No. 554/1 (Part) at Village- Papredi, Tehsil - Beohari, Dist. Shahdol (MP) by M/s Shree Marble, Plot No. 186, Nalanda College, Mahaveer Nagar, Katni, (MP)

- (1) This is a project pertaining to mining of Marble Mine in MLA of 4.50 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-2' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of 30 years as per Collector Shahdol vide letter No.1664 dt 17.7.2018 (17.7.2018 – 16.07.2048) with production of 10,000 cum/ year. This is a case of existing mine.
- (2) SEAC in its 341<sup>th</sup> SEAC meeting dtd 31.1.2019 has recommended the case with 28 special conditions for issuance of EC.
- (3) It was noted that as per DFO Letter no. 1556 dated. 16.10.2018, the Forest Boundary is more than 250 m. from the mining site.
- (4) PP has submitted information regarding there is no other mines within 500m radius from the mining site duly certified by Mining Division Collector Office, Shahdol.
- (5) It was noted that the water requirement is 12.0 KLD (6.0 KLD for Dust Suppression+ 4.0 KLD for Green Belt + 2.0 KLD for Domestic which shall be obtain from open well/tube well & tankers.
- (6) The proposed plantation program was examined and it was found that total number of 13500 saplings of tree species covering an area of 1.650 ha during the lease period and additional plantation on approach road side shall be planted.
- (7) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (8) After detailed discussions and perusal of recommendations of 341<sup>h</sup> SEAC meeting dtd 31.1.2019, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
  - I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be








made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.

- II. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement
- III. Lease agreement shall be carried out before execution of mining operation.
- IV. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- V. Water quality monitoring should be carried out regularly.
- VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VII. PP will plant 3 years old 2700 trees samplings of suitable indigenous fast grow tree species (neem, amla, ashok, drumstick etc.) in barrier zone/no mining zone along the transportation route during first year.
- VIII. PP shall ensure to construct and maintain approach road upto NH junction and maintained the existing pakka road in consultation with District Administration. Plantation will be carried out on both side of approach road.
- IX. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- X. No overburden will be dumped outside the mine lease area.
- XI. No blasting shall be permitted in the mining lease area.
- XII. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- XIII. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XIV. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
