As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 18.04.2016 in favour of Sarpanch Gram Panchayat, Indurkhi, **Bhind** in the place M/s Prime Vision Industries Pvt. Ltd., Sub Lessee, M.P. State Mining Corporation Ltd. Shri Atul Gondal, 303, 3rd Floor, Vishal Chamber, P-1, Sector-18, Noida, District – Gautambudh Nagar – (U.P) 201301 for **Sand Quarry** (Open cast manual method) in an area of 10.957 ha. for production capacity - 54,785 cum/year at Khasra No. 8/3010, 3011, 3015, 3016, 3018, Village-Indurkhi, Tehsil-Roun, District-Bhind (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned.

- 11. Case No. 272/2009 Prior Environmental Clearance for Deshgaon Basalt metal stone quarry in area of 18.84 ha for production capacity19,800 cum per year at village Deshgaon, tehsil Khandwa, district East Nimar, MP by Shri Rakesh Kumar Bansal, Ram Krishna Road, tehsil & district Khandwa, MP.
 - EC Issued vide L.No. 183 dated 05.05.2012 for the period from 20.06.2008 to 19.06.2018.
 - As per the records in this particular case lease validity has been expired on 19.06.2018. Similarly validity of Prior EC has also been expired on 19.06.2018.
 - After that Hon'ble High Court Jabalpur has dismissed the WP 4774/2017 on 01.10.2018 as withdrawn by PP.
 - 4. A complaint by Sarva Aadiwasi Samaj Vikas & Sudhar Samiti, District Khandwa, Chairman Shri Radheshyam Patel and Cheif Member Shri Laxman Kelde has received in SEIAA on 24.11.2018 regarding submission of falls lease renewal documents in Mining Department for renewal of mining lease.
 - The complaint has been forwarded to Director, Geology & Mining, Bhopal vide L.No. 1820 dated 10.12.2018 regarding appropriate action.

6. Again a complaint received dated 11.01.2019 on similar ground for taking appropriate action by SEIAA.

 - It is also mention that MPPCB, Bhopal has issued directives on dated 13-07-2017 to conduct public hearing by RO, PCB, Rewa. ToR has been issued by SEAC vide L.No. 595/PS-MS/MPPCB/SEAC-II/TOR(003)/2016 dated 15.03.2016.
 - 3. OM dated 29.08.2017 issued by MoEF&CC and regarding clarification of the validity of ToR, it is as mention in OM dated 29.08.2017 as below
 - (iii) The above validity period can be extended by the concerned regulatory authority for a maximum period of one year without referring the proposal to the EAC/SEAC concerned, provide on application is made by the applicant before expiry of the validity period, together with an updated From-1 and proper justification and there is no change in terms and conditions of the ToRs. After the lapse of validity such extension will need EAC/SEAC consideration.
 - (viii)Public consultation shall be conducted during the validity of the ToRs. The public consultation conducted after the expiry of ToRs shall not be accepted by the Regulating Authority.

Since PP has submitted revised Form-1 and PFR as per above OM hence, it is decided to send technical file to SEAC for consideration and appraisal of case. Copy to PP.

This case was discussed in the 317th SEIAA meeting dtd. 12.04.2016. Additional condition for grant of EC subject to necessary wild life clearance from NBWL is hereby imposed as under:-

- SEAC has put a condition for obtaining Wild Life Clearance from NWLB and PP has submitted online application also. No mining activity shall commence till the Wild Life Clearance is given by the National Board for Wild Life. The OM dated 02.12.2009 shall be applicable in this particular case. Mining Officer, Indore shall be responsible for compliance.
- Grant of environmental clearance does not necessarily implies that forestry and wildlife clearance shall be granted to the project and that their proposals for forestry and wildlife clearance will be considered by the respective authorities on their merits and decision taken.

ED, MP State Mining Corporation has submitted a letter No. 121 dtd. 15.02.2017 mentioning that in the Gazette of India published on 14.12.2016, the Eco Sensitive Zone in case of Bandhavgarh Tiger Reserve has been fixed with an extend of 2 km. from the boundary of the Bandhavgarh National Park and desired that the specific condition of Wild Life Clearance from NBWL should be withdrawn. It has been decided to send the file to SEAC-II for examining the Gazette Notification and recommend the withdrawal of the clearance conditions. Copy to PP

Thereafter the after decision of 71st SEAC-II meeting dt. 10.04.2017,

The case was scheduled for the presentation and discussion toady wherein PP remains absent. On perusal of the case file it was observed by the committee that as per the certificate issued vide letter no. 3199 dated 05/08/2015 by the Dy. Director, Bandhavgarh Tiger Reserve, Umaria stating that the lease is at a distance of 5.6 kms (a Notified PA) from core zone and 2.70 kms from the buffer zone of Bandhavgarh Tiger Reserve. However in the gazette of India SO No. 4027 (E) published on 14/12/2016, the Eco-sensitive zone in case of Bandhavgarh Tiger Reserve has been fixed with an extent of 2.00 kms from the boundary of the Bandhavgarh National Park. Since the certificate issued by the Dy. Director, Bandhavgarh Tiger Reserve, Umaria stating that the lease is at a distance of 5.6 kms (a Notified PA) from core zone and 2.70 kms from the buffer zone of Bandhavgarh Tiger Reserve is becomes inconclusive as the distance is desired from the boundary of Bandhavgarh National Park not from the core zone or the buffer zone. Thus committee after deliberations decided that PP may be asked to obtain revised certificate from the competent authority stating the actual distance of the lease form the boundary of the Bandhavgarh National Park in accordance with the gazette of India SO No. 4027 (E) published on 14/12/2016 for further consideration of the representative submitted by them.

Thereafter case was discussed in 297th SEAC meeting dated 08.11.2017. The submission made by PP was found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC.

Prior EC was initially granted by SEIAA in its 456th meeting dtd. 16.11.2017 by accepting the recommendation of 297th SEAC meeting dated 08.11.2017 and revised EC issued was issued vide letter no 1291 dated 07.12.2017 by withdrawing specific conditions given in prior EC point no. 13 &14.

Now MoEF & CC Gol , Regional Office western Region Bhopal has submitted vide letter No. 18-B-37/2018(SEAC) /140 dtd.15.02.2019 received in SEIAA office dt. 20.02.2019 as under :-

We would like to inform that is response to the communication of this office the Project authority have responded the status as non-operative of mine and now the mine is handed over the MPSMC. It is said to be allotted to Gram Panchyat. The MPSMC does not have Ownership of the mine. The EC issued by SEIAA vide letter no 1291 dtd.7.12.2017 is not transferred to any part and mine is not yet started, directed to refer the matter for cancellation of Prior EC.

After detail discussion it is decided to accept the recommendation of Regional Office, Western Region, MoEF&CC, GOI Bhopal and EC issued by SEIAA vide letter no 1291 dtd.7.12.2017 is hereby cancelled. Copy to PP and all concerned.

PP further requested that since the magnitude of the project is considerably reduced hence the impacts on environment issues are also reduced accordingly.
 - (3). PP has assured that ready to abide by all the conditions stipulated in prior EC granted vide letter referred herein above.

The case was discussed in depth and it is noted that the prior EC issued vide letter dated 13.12.16 was for the built-up area of 228098.4 sq.m however vide letter 30.01.19 PP has informed that in new planning the built-up area of the project will be reduced upto 100729.46 sq.m i.e. 1,27,368.94 sq.m. It is decided that the case may be referred to SEAC for appraising the changes, if any, in the environment impacts and prior EC conditions with respect to change in water requirement, waste water discharge, MSW, parking area, green area, road width, etc. due to reduction in the built-up area.
