- B. The proposed project is building & construction Residential Project having total built up area 1,28,158.02 sq.m and total land area is 71,310.0 sq.m. The project comes under 8(a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.m & 1,50,000 sq.m and plot area is less than 50 ha. PP has not submitted approved T & CP layout.
- C. It was observed that the distance of this project site from the Ralamandal Wildlife Sanctuary is <10 km for which PP has applied for NBWL Clearance vide proposal no. FP/MP/Others/3856/2019 dtd. 24/01/2019 and submitted the copy of the online acknowledgement.
- D. The case was discussed in SEAC meetings 339<sup>th</sup> dtd. 29.01.19 and is recommended for grant of prior EC subject to special conditions.
- E. After deliberation the case was discussed in detail and recorded that:-
  - Regarding land documents PP has submitted Collector District Indore order dtd. 01.05.18. As per the order the land area 7.131 ha land has been allotted to Municipal Corporation Indore for implementation of Pradhan Mantri Awash Yojana.
  - ii. The total water water requirement is 955 KLD & fresh water requirement is 636 KLD. The source of water supply is Municipal Corporation, Indore. PP has submitted letter (dtd. 30.07.2018) from Municipal Corporation, Indore for water supply.
  - iii. The waste water generation is 764 KLD and PP has provided 02 numbers of Sewage Treatment Plant capacities of 900KLD (2x450 KLD). The available treated water is 688 KLD. Out of 688 KLD 319 KLD will be used for flushing, 57 KLD gardening, 35 KLD DG set cooling etc. The excess treated water (277 KLD )will be discharged into the municipal sewer line. PP has not submitted NOC from Nagar Nigam Indore for disposal of extra treated waste water.
  - iv. The Municipal Solid Waste 3562 kg/day shall be generated. The generated biodegradable and non biodegradable waste will be collected separately and disposed of at the landfill site of Municipal Corporation. PP has submitted letter (dtd. 01.08.2018) from Municipal Corporation, Indore for disposal of solid waste.
  - PP has proposed to provide fire pump house, external hydrant system, Internal hydrant system, hose reel, hose boxes, fire alarm system and fire extinguishers etc as per NBC 2005.

- (4) The case was then discussed in 523<sup>th</sup> SEIAA meeting dtd. 15.02.2019 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.

- (9) After detailed discussions and perusal of recommendations of 341<sup>st</sup> SEAC meeting dtd. 31.01.2019, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-
  - Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
  - II. Lease agreement shall be carried out before execution of mining operation.
  - III. PP shall demarcate a barrier zone of 7.5 m as "no mining zone" in the periphery of mining lease area and developed a green belt.
  - IV. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
  - V. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.

The generated biodegradable and non biodegradable waste will be collected in twin Bin system at within campus and final disposal through Municipal Corporation Bhopal. The sewage sludge generated from STP (13 kg/d) will be also disposed off with municipal waste. PP has submitted letter (dtd. 06.10.2018) from Municipal Corporation, Bhopal for disposal of waste.
- v. The maximum height of the building is 18 M (S+6) Floors. The project complex is having one traffic entry from 12 m wide road on west, other entry from 24 m wide road on East and one exit from 12 m wide road on south. Internal roads having width of about 9 m ROW is provided within the complex for smooth circulation of the traffic within the complex.
- vi. PP has proposed to provide underground fire water storage tank, Fire pumping system, Yard Hydrant System, Wet Riser System, portable Fire extinguisher, automatic Sprinkler System, automatic fire detection system & Fire Alarm system. etc. as per NBC 2005.
- vii. PP has proposed to provide 304 ECS (171 ECS-open & 133 ECS for multi unit development) and individual car parking for duplex and row houses..
- viii. The total power requirement is 2642 KVA. The source of electricity is Madhya Pradesh Kshetra Vidyut Vitran Company Limited. PP has also provided power back up 1 No. DG set of 125 kVA. For control of energy PP has proposed solar energy for common area (1/3 of area), LED for common area lighting (2/3 of area), CFL for internal lighting, solar heater etc.
- ix. PP has proposed to provide roof top rain water harvesting system with **05** nos. of recharging pits.
- x. PP has proposed an area of 8167.93 sq m to be developed as green area by planting 270 number of tress.

#### 6. After the detail discussion PP was asked to submit the following:-

- a) PP has submitted Khasra Panchsala 2010-11, in which the land is the name of Shri Laxminaryan, Nirmala bai, Radha bai and Rupa bai. PP has also submitted sale deed for the same. PP should submit the latest Khasra Panshsala to clarify the landownership. Further it was also observed by the authority the project is being constructed by the Partnership of M/s Fortune Builders with Mr. Ajay Mohgaonkar and Mr. Sameer Gupta. PP should submit notarized copy of partnership deed / joint venture agreement.
- b) In SEAC 337<sup>th</sup> meeting dated 01.01.2019 "it was recorded that they have obtained a common T&CP for two projects as phase I & II and have obtained TOR for the first project (in violation) and have made separate application for Phase II. PP submitted that earlier there was a clause that for getting T&CP approval some minimum size of land was essential and thus they have obtained common T&CP approval but the PP's are different".

As per recommendation of above, the authority after deliberation decided to know whether the land area and Khasra number of both the project with ownership are same or different. PP should clarify the area for the both the project separately so that authority take the decision whether the project comes under the violation or not.
