
Shri Parmanand Patidar, Project Proponent has submitted an application dated 26.03.2019 to review the environmental clearance granted in favour of PP by DEIAA for period upto 31.03.2019 vide its order No. 629/DEIAA/2016 dated 1.8.2016 while State Govt. has granted mining lease from 1.8.2009 to 31.7.2019. As per procedure, environmental clearance is normally granted for mining lease period and as per MoEF&CC, GoI Office Memorandum No. J-11011/15/2012-IA.-II(M) dated 20.3.2015, the Project Proponent which has valid and subsisting EC for their mining project either under EIA Notification 1994 or 2006 will not be required to obtain fresh EC at the time of renewal of lease.
