Now the distance of river from lease with 50 meters setback will be 100 meters. 


8. **Case No. 5729/2018-** Prior Environmental Clearance for Pyrophyllite & Diaspore Mine (Open cast other than fully mechanized method) in an area of 10.0 Ha. for production capacity of 15,447 TPA at Khasra no. 687 at Village- Paretha, Tehsil - Nowgaon, District. Chattarpur (MP) by Shri Narendra Kumar Mishra S/o Shri Ashok Kumar Mishra, R/o Behind Circuit House Chattarpur, Dist. Chattarpur, MP - 471001.

The case was discussed in 512th SEIAA meeting dated 12.12.18 and it was recorded that

- (1) This is a project pertaining to mining of Pyrophyllite & Diaspore Mine in MLA of 10.0 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-2' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine with production of 15,447 TPA.
- (2) It was reported by the PP that the lease area of 10.00 hectares was originally granted in favour of Shri Narendra Kumar Mishra S/o Shri Ashok Kumar Mishra, This is an Existing mine. The lease period is effective from 24-11-1993 to 23-11-2043 i.e. 50 years as per latest amendment in Mines and Minerals (Development & Regulation) Amendment Ordinance 2015 for 50 years lease period The Mining Plan Approval letter Vide No. 9323/ एम० पी० जी० ३/ न. क. ४६/२०१७, Date: 31.05.2018.
- (3) SEAC in its 332th SEAC meeting dtd 26.10.2018 has recommended the case with 32 special conditions for issuance of EC.
- (4) The case was then discussed in 509th SEIAA meeting dtd 16.11.2018 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) The proposed plantation programme was examined and it was found that 3000 sapling of tree species covering an area of 3.0 ha shall be covered under plantation.
- (6) It was noted that as per Forest Conservator Letter no. 3496 dated. 07.11.2016, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.

- (7) It was noted that the water requirement is 4.3 KLD (2KLD for Dust Suppression + 1.0 KLD for Domestic + 1.0 KLD for Green Belt + 0.3 KLD for Others) which shall be met from tankers.

After deliberation, the case was discussed in depth and it was found that mining is proposed to be carried out on plateau area and human habitation is located on foot hill in close vicinity of project site. PP has proposed controlled blasting for mining of minerals. There is possibility of adverse impact on human habitation due to mining. Hence, it is decided to send the case file to SEAC for site visit to verify the factual status of the site and accordingly re-appraise the case.

As per decision of 512th SEIAA meeting dated 12.12.2018 SEAC members to carryout site visit of this project on 02.02.2019

As decided, a sub- committee of SEAC, Dr. Moh. Akram Khan, Member and Shri Prashant Shrivastava, Member visited the site on 02/02/2019. During inspection, Dr. Abhaya K. Saxena, Sr. Scientific Officer, M.P. Pollution Control Board, Bhopal and Shri Anoop Chaturvedi, Mine Representative, accompanied the SEAC sub-committee.

Salient features of the project:

The mine is for Pyrophyllite & Diaspore production located at Khasra No. 687 of Area: 10.0 Ha, Village: Paretha, Tehsil: Nowgaon, District: Chhatarpur, Madhya Pradesh. Lease area is 10.00 Ha. The proposed project site is about 43.2 km away from Chhatarpur City. Mining area is 8.6 km away from tar Road (State Highway- 42). The lease area falls under village Paretha and the nearest railway station is at Ghutai Railway Station 3.8 Km towards NE from the lease area.

During site visit, it was observed by the committee that the lease is marked by boundary pillars and village is located on the foot hill of the lease on the south-western side. No mining activities were observed during the inspection and also there were no signs of any previous mining activities. The site inspection panchnama was also made in the presence of 02 local villagers Mr. Devendra Tiwari and Mr. Lokesh Malviya which is annexed as Annexure-1. During inspection only mine representative was present and was unable to provide response to the queries of the sub-committee. Thus after detailed discussion sub-committee asked PP to provide following additional information:


1. Distance of nearest houses with their numbers from mining lease area.
2. Details of drilling & blasting proposed.
3. Revised operational plan showing safety wall towards nearby habitation on map.
4. Provision of approach and exit road with water sprinkler systems.


The IR was placed before the committee in 349th SEAC meeting dated 05/03/2019. After perusal of IR and discussion, committee observed that so far PP has not submitted the information desired by the sub-committee for consideration of the project. Committee decided that PP may be given another 30 days time to submit the information for its appraisal as per the observations of SEIAA.


PP vide letter dated 07/03/2019 has submitted the reply which was placed before the committee. After deliberation committee recommends that considering the proximity of lease with village following additional conditions shall be stipulated in the EC:

- A. Drilling & blasting should be so designed and planned to keep minimul round of blasting with due consideration of air blast, ground vibration and fly rock projectile.
 - B. OB dump yard site shall be on the non-mineralized zone.
 - C. The safety retaining wall as proposed by PP on the plan shall be provided with 1.5 meter base and 1.00 meter high with 12" thickness.
 - D. A barrier zone of 50 meters (setback) as non mining area shall be left within the lease as shown on map for safety of villagers on the western side.
- Other conditions shall remain unchanged as recommended in the 332nd SEAC meeting dated 26/10/2018.

After deliberation and site inspection, SEAC recommends additional four specific conditions for prior EC considering the proximity of lease with village habitation and perusal of recommendations of 329th SEAC meeting dtd.







23.10.2018, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- V. Before commencing the mining activity, site demarcation should be done leaving 100 m. from nearby settlement as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Chhatarpur.
- VI. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- VII. PP shall ensure to plant 3000 trees of local evergreen indigenous species in 3.0 ha at the end of conceptual period as committed.
- VIII. No overburden will be dumped outside the mine lease area.
- IX. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- X. PP shall ensure generation of employment opportunities to nearby Village on priority bases.
- XI. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XII. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XIII. PP should also carry out regular sprinkling of water in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XIV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme


- XV. PP shall ensure to construct and maintain Cement Concrete approach road from the mine site. Plantation will be carried out on both sides of the approach road. PP shall also ensure maintenance of existing pakka road in consultation with competent authority.
- XVI. PP shall ensure proper water supply arrangements for plantation especially in summer season.
- XVII. PP shall ensure proper implementation of plantation, dust suppression, construction of CC approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVIII. PP must ensure implementation of the following activities. Separate budget provision of Rs.2.30 lakh under CSR.
- a. Installation of hand pump.
 - b. Solar Street Light.
 - c. Toilets for nearby school.


The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.


- XIX. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,GoI,Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.






