
----- Vide letter dated 01.07.2019, PP has submitted the desired information, which was placed before the committee. After deliberations, the EMP and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':

After detailed discussions and perusal of recommendations of 376th SEAC meeting dated 01.07.2019, presentation made by the PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall not start mining activity before execution of lease agreement.
- III. The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary.
- IV. Before commencing the mining activity, site demarcation should be done leaving 100 m. from natural drain/nalla and 100 m. from nearest settlement /habitation as a "no mining zone". PP shall also ensure to raise dense vegetation towards settlement. The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Tikamgarh.
- V. PP shall ensure that the proper water supply arrangements for dust suppression, regular sprinkling, plantation and drinking purposes especially in summer season.
- VI. PP shall ensure to construct and maintained the approach road. Plantation will be carried out on both side of approach road.
- VII. PP shall ensure to construct appropriate size garland drain & settling tank all around the lease area
- VIII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road & as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.


- IX. Total 8064 saplings shall be planted by PP under plantation programme suitable indigenous tree species Lease boundary, approach road & towards village side. Plantation of Neem, Peepal, Aam, Bans, Satparni, Ashoka,, Drumstick etc. on priority shall be ensured by PP.
- X. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.

- XVII. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture field.
- XVIII. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XIX. PP must ensure implementation of the following activities with separate budget provision of Rs. 4.00 Lakhs as capital and Rs.3.50 Lakhs as recurring cost under CER as committed.



3. **Case No. 5597/2017** - Prior Environmental Clearance for **Manganese Ore Mine** (Open cast other than fully mechanized method) in an area of 4.30 Ha. for production capacity of 4386 MTPA at Khasra no. Reserved Forest Land 468 -B at Village- Ramrama, Tehsil - Waraseoni, Dist. Balaghat (MP) by M/s A.P.Trivedi Sons, Ward no. 20, Main Road, Balaghat, MP - 481001
- (1) This is a project pertaining to mining of Manganese Ore Mine in MLA of 4.30 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period upto 30.06.2032 with production capacity of 4386 MTPA.
 - (2) The Mining Lease was grant to M/s A.P.Trivedi Sons in the year of 2013 for period of 50 years w.e.f. 12.01.2017 to 11.01.2068 over an area of 4.30 Ha. This is a case of new mine .The Mining Plan along with progressive mine closure plan under rule 24(A), MCR, 1960 was approved by IBM Vide Letter No. – BGT/ MN/MPLN - 1138/NGP dated 15.01.2014.
 - (3) SEAC in its 377th SEAC meeting dtd 02.07.2019 has recommended the case with 26 special conditions for issuance of EC.
 - (4) It was noted that as per DFO L.No. 5270 Balaghat, dtd. 13.06.2017, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. DFO letter infirmed that Parcel no. 468 of Waraseoni Forest Zone exists within 250 meter radius of the mining lease area.
 - (5) The lease area comes under Reserved Forest Land Compartment no. 468(B) at Village- Ramrama, Tehsil - Waraseoni, Dist. Balaghat. PP has obtained requisite Forest Clearance Stage - II, this was approved under section 2 (II) of Forest (Consevation) Act, 1980 vide letter 6-MPC/030/2016- BHO / Part – I/376 dated 09.05.2019
 - (6) It was noted that the water requirement is 6.0 KLD (1 KLD for Domestic + 3 KLD for Dust Suppression + 2 KLD for Green Belt which shall be met from mine pit & bore well.
 - (7) The proposed plantation program was examined and it was found that total 8000 sapling in 3.97 ha shall be covered under plantation.
 - (8) It was also noted that the Public Hearing was carried out on 18.01.2019 at Mine Parisar Village Ramrama, under the Chairmanship of Upper Collector, Balaghat.






The major comments of applicants during public hearing are water for irrigation, access on approach road, Controlled blasting, employment of local people, construction & maintenance of existing / approach road connecting the mine & main road, Plantation on road side, regular health check-up of mine workers & water sprinkling to suppress the dust emission.

After detailed discussions and perusal of recommendations of 377th SEAC meeting dtd 02.07.2019, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:

- I. PP shall ensure to preserve thick greenery all around periphery of mining lease area and develop a green belt.
- II. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- V. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VI. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- VII. PP shall ensure to plant total 8000 saplings in an area of 4.30 ha shall be covered under plantation till the end of life of mine
- VIII. PP should ensure to compliance the condition laid down the forest clearance approval issued by MoEF & CC, Gol.

- (1) This is a project pertaining to mining of Manganese Ore Mine in MLA of 2.452 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period upto 30.06.2032 with production capacity of 888 MTPA.
- (2) The Mining Lease was grant to M/s A.P.Trivedi Sons in the year of 2002 for period of 30 years w.e.f. 01.07.2002 to 30.06.2032 over an area of 2.452 Ha. The mine lease has been extended for 50 years as per MM (D&R) Amendment Act 2015 from date of grant of mine lease up to 30.06.2032. This is a case of new mine .The Mining Plan along with progressive mine closure plan under rule 24(A), MCR, 1960 was approved by IBM Vide Letter No. – BGT/ MN/MPLN - 126/NGP dated 07.01.2009.
- (3) PP has produced an order of the Mineral Resources Deptt. GoMP dtd. 03.09.2015 in which after hearing the case the State Govt. has established that action be taken according to the latest circular No. 19-5-2015/12/1 dtd. 12.03.2015, which states that "all mining leases granted before the commencement of the Mines & Minerals (Development & Regulation) Amendment Ordinance 2015 shall be deemed to have been granted for a period of fifty years
- (4) SEAC in its 377th SEAC meeting dtd 02.07.2019 has recommended the case with 26 special conditions for issuance of EC.
- (5) It was noted that as per DFO L.No. 5268 Balaghat, dtd. 13.06.2017, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (6) The lease area comes under Revenue forest area and adjoining to the Forest Compartment no. 468 (R.F) at Village- Ramrama, Tehsil - Waraseoni, Dist. Balaghat.
