


Minutes of the 576th Meeting of SEIAA dated. 21.10.2019




- VI. Before commencing of the mining activity, site demarcation should be done leaving 10 m. from kachha road towards southern-western side of ML area as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Rewa.
- VII. PP shall ensure existing trees should not be cut within the lease area and maintained it.
- VIII. PP shall ensure to construct garland drain with settling tank all around the lease area and regular cleaning & maintenance shall also be carried out by PP.
- IX.
