If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,GoI,Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA..

Hence, Prior Environmental Clearance is granted for Stone Quarry (opencast manual/semi mechanized method) in an area of 1.30 ha. for production capacity of 15087 cum per annum (as per revised mining plan) at Khasra No. 372/2, 381/2, 382/2, 383/3 at Village - Shivpurwa, Tehsil - GopadBanas, Dist. Sidhi (MP) for the lease period to Shri Vinod Singh, Shashtri Nagar, GopadBanas, Dist. Sidhi, MP – 486661.
