


Minutes of the 588th Meeting of SEIAA dated. 12.12.2019



- (1) This is a project pertaining to mining of **Naraura Limestone mine** in MLA of 10.90 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project. It was submitted that this is a proposed mine having valid lease for 50 years with production capacity of Limestone-0.10 Million TPA & Reject Stone-0.11 MillionTPA.
- (2) It was reported by the PP that the lease was granted in favor of M/s Sada Construction on 29.09.2016 for 50 years.
- (3) SEAC in its 406th meeting dtd. 25.11.2019 has recommended the case with 39 special conditions for issuance of EC.
- (4) The case was then discussed in 588th SEIAA meeting dtd. **12.12.2019** and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) The proposed plantation program was examined and it was found that 11000 sapling of tree species covering an area of 2.09 ha shall be planted during the lease period.







- (6) It was noted that the water requirement is 20.0 KLD (8.0 KLD for Dust Suppression+ 9.0 KLD for Plantation + 3.0 KLD for Domestic) will meet from mine quarry as well as from Naraura village Gram Panchayat.
- (7) It was also noted that the Public Hearing was carried out on 31.07.2019 at mine site, Village - Naraura, Tehsil - Maihar, Dist. - Satna (MP) under chairmanship of Additional Collector, Satna.
- (8) Based on the recommendation of 406th SEAC meeting dtd. 25.11.2019, presentation made by the PP in SEIAA & SEAC, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
- I. Before commencing any mining activity, fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
 - II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
 - III. PP shall ensure to leave 57.5 m including barrier zone at southern side and will demarcate it as "no mining zone" in the periphery of mining lease area and develop a thick green belt.
 - IV. PP shall ensure the fencing and plantation at southern side from where natural drain is passing.
 - V. PP shall not start mining activity before execution of lease agreement.
 - VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
 - VII. Plantation shall be carried out as per the plantation programme. Total 11000 plants will be planted including suitable tree species i.e. Neem, Mango, Pipal, Bargad, Karanj, Gulmohar, Kachnar, Mahua, Jamun & Amla along transportation route, BF area & Green Belt area **shall be ensured** by PP on priority.
 - VIII. Haul road shall be compacted on regular interval and transportation road will be made pucca (tar road) and shall be constructed prior to operation of mine.
 - IX. Transportation of minerals shall not be carried out inside the village area.
 - X. No dump shall be stacked outside at the mine site.
 - XI. No intermediate stacking is permitted at the mine site.
 - XII. No dump shall be stacked outside the lease area.
 - XIII. PP shall ensure protection and conservation of existing trees falling under mining lease area and in no way these will be permitted to be cut / uprooted and when tree felling required, permission will be obtained from the competent authority as recommended by SEAC.






- XIV. For dust suppression, over head sprinkler shall be provided while on transport road, tankers shall be provided for dust suppression.
- XV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XVI. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVII. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVIII. PP must ensure the implementation of following activities with separate budget provision of total Rs. 16,25,000/- for 5 years @ 4.25 lakh capital in first year and 3.0 lakh per year in subsequent as recurring in 04 years under CER:

 3. **3rd year: Mantolwa village** – Hand pump, maintenance of school play group, green belt plantation in buffer zone.
Tiloura village: Maintenance of CC road, water supply & traffic rule training.
Naraura village: Water supply & maintenance of road.
 4. **4th year: Umri village** – Hand pump, maintenance of school play group & green belt plantation in buffer zone.
Tiloura village: Maintenance of CC road & water supply.
Naraura village: Water supply & maintenance of road.
Mantolwa village – Traffic rule training.
 5. **5th year: Dhanwahi Kalan village** – Hand pump, maintenance of school play group & green belt plantation in buffer zone.
Tiloura village: Maintenance of road & water supply.
Naraura village: Water supply & maintenance of road.
Mantolwa village – Traffic rule training.
Umri village – Traffic rule training.

3. The project is production of Intermediates and APIs hence covered under 5 (f) Category-B of the Schedule of EIA Notification issued by the Ministry of Environment & Forests vice S.O.1533 (E) dtd.14.09.06 & its amendments.

- ii. The expansion is proposed in the company's existing premises having land of 2061.2 sq mt (existing) + 3456.89 sq mt (proposed) = Total 5518.09 sq mt. The total fixed cost of proposed expansion project will be INR 13.25 Crore.

Fan is meant to ensure a negative pressure throughout the working system.




The State of M.P. may ensure compliance of the judgment of the Hon'ble Supreme Court in Deepak Kumar (Supra) and of this Tribunal in Satendra Pandey (Supra) and permit mining only after Environment Management Plan is approved by the SEIAA."

In compliance of the above order dated 26.07.19 passed by Hon'ble NGT in the matter of OA No. 726/2018, PP has submitted Environment Management Plan in SEIAA vide letter dated 06.12.19 for necessary action. **After discussion, it was decided to send the EMP submitted by PP to SEAC for review and critical examination for considering necessary approval as per direction of Hon'ble NGT.**
