
".....PP has submitted the response of above quarries same date vide letter dated 27.11.2019, which was placed before the committee and the same found satisfactory. The EMP and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A'."


PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail. **After detailed discussions and perusal of recommendations of 408th SEAC meeting dated 27.11.2019, presentation made by the PP in SEIAA, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. PP shall not start mining activity before execution of lease agreement.
- III. The depth of the pit shall be as per the Approved Mining Plan.
- IV. The entire area shall be fenced and three rows of plantation should be done on the periphery of the boundary & towards Kaccha Road (Southern direction).
- V. PP should first carry-out plantation in and around mining lease and submits compliance within six months otherwise EC will be revoked.
- VI. PP shall ensure protection and conservation of existing trees falling under mining lease area and in no way these will be permitted to be cut / uprooted.
- VII. No blasting shall be carried out in mining lease area.
- VIII. PP shall ensure that the proper water supply arrangements for dust suppression, regular sprinkling, plantation and drinking purposes especially in summer season.
- IX. PP shall ensure to construct and maintained the approach road. Plantation will be carried out on both side of approach road.
- X. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road & as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XI. Total 1240 saplings shall be planted by PP in a year under plantation programme suitable indigenous tree species both side approach road, village road, nearby school & Panchayat area. Plantation of Neem, Peepal, Amla, Bargad Jamun etc. will be planted on priority.
- XII. PP must ensure implementation of the following activities with separate budget provision of Rs 0.60 lakh / year under CER
 - (a) Drinking water filter & toilet facility at Bada Khutaja village .
 - (b) Distribution of schools material like benches & sports items at Kiloni Ghati village.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Gram Panchayat

If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,GoI,Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.


This is the case of Flag Stone Quarry. EC granted in 539th SEIAA meeting dated 23.04.2019. A copy of complaint letter dtd. nil received in SEIAA dtd. 31.05.2019 from Shri Om Prakash Pandey, Mohindra, District Panna regarding Lease Cancellation & Violation of environmental conditions given in Environmental Clearance letter issued by SEIAA vide no 544/ SEIAA/19 dtd. 14.05.2019. The complaint was sent to Regional Office, MoEF&CC, GoI vide letter No. 1539/SEIAA/19 dated 04.07.2019. In response to this letter, MoEF&CC has written letter to SEIAA vide No. 18-B-89/2019 (SEAC)/020 dated 03.01.2020 in which it is mentioned that complaint alleges that EC was obtained by the Project Proponent through discrepancy of the factual / background information and by erroneous method. The following are alleged in the complaint:


1. The Flag Staon Quarry is located at Khasra no. 284, 292. Towards the west of khasr no. 284 is forest land at 0 mt distance and towards east of khasra no. 292 is forest land at aprosimately 30 mts distance. However, forest boundary is incorrectly said to be located at 250 mts distance & approval for the same is also not obtained from the Commissioner, Sagar.
2. The Khasra no. 287 is situated in between above said khasra numbers throughwhich National Hihgway is passing. The approved area is adjacent to NH which connects pawai & mohandra. As per environment & mine policy, mine can not be approved within 50 mt to NH. Thus, EC was approved in appropriately by hiding the NH from the map.

After discussion, it is decided to send the complaint alongwith letter dated 03.01.2020 receivef from Righionl Office, MoEF&CC, GoI to Collector Panna to clarify and verify the factual status of the mine at the earliest possible so that necessary decision can be taken by SEIAA.

Hon'ble NGT in its order dated 11.12.18 in OA 520/2016 has suspended the activities of issuing EC by DEIAA /DEAC for minor minerals as per MoEF&CC Notification dated 15.1.2016 till a fresh notification is issued by ministry. Therefore , in compliance of MoEF&CC, GoI OM dated 12.12.2018, all mining cases of minor minerals having 0 to 5 ha area is being appraised by SEIAA for environmental clearance as per OM No.1886/SEIAA/2018 dated 27.12.18. Since, the prior environmental clearance issued by DEIAA is valid hence project proponents having valid prior EC of their projects issued by DEIAA are now requesting to transfer the EC as per EIA notification 2006. **Considering the request of PPs, the authority decided to transfer the EC issued by DEIAA to other project proponent as per EIA notification after getting complete record of the case from concerned DEIAA of the District.**
