25.03.2009. Later on M/s ACC Ltd. has applied in SEIAA on 08.01.2018 for transfer of EC from M/s S.N. Sunderson & Co. to M/s ACC Ltd., Kymore. In response to this, Prior EC was transferred by SEIAA to M/s ACC Ltd., Kymore vide letter No. 1742/SEIAA/2018 dated 23.02.2018.

MOEF&CC, GoI, letter No. 18-B-30/2019(SEAC) 672 dated 14.06.2019 informed that Air & Water Consent was issued in the name of M/s S.N. Sunderson & Co. in the year 2009 and M/s ACC Ltd. have been carrying out mining activities without valid Prior EC from 2009 to 23.02.2018 and even company has failed to submit half yearly compliance report on regular basis. M/s ACC Ltd. has submitted compliance report for period from Dec.2018 to May 2019 only vide letter dated 31.5.19.

In response to public complaint received from Shri Ramesh Sharma vide letter dated 19.09.20, MoEF&CC, GoI vide letter No. 18-B-30/2019(SEAC)/969 dated 02.11.2020 has communicated that Central Govt. vide Gazette Notification No. S.O. 637(E) dated 28.02.2014 has delegated power vested under Section 5 of E(P) Act, 1986 to the SEIAA to issue showcause notice to PP in case of violation of the conditions of the EC issued by the authority to project under the jurisdiction and to issue direction to the said PP for keeping such EC in abeyance or withdrawing them if required.

In view of above, it has been observed that ACC has not submitted six monthly compliance report on regular basis to MoEF&CC,Gol /SEIAA as per EC conditions hence why not your EC is kept in abeyance or withdrawn by authority as per provision under MoEF&CC, Gol Notification dated 28.02.2104 with immediate effect as it is clear cut matter of violation of Prior EC. In light of above, you are hereby directed to clarify the above issues to justify your stand within 15 days from the date of issue of letter and present your case with clarification/justification in upcoming SEIAA meeting otherwise necessary action will be initiated accordingly.  - (1) This is a project pertaining to mining of Bauxite Mine in MLA of 39.31 Ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. it is not attracted by the general conditions and falls under category 'B-1" by virtue of its location and mining lease area. There is no forest boundary in less than 250 m distance from the ML area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project. It was submitted that the mine lease has been executed for 50 years period in accordance with the MM (D&R) Amendment Act 2015.
 - (2) The lease was originally granted to M/s ACC limited for extraction of bauxite in the year of 1970 which is extended for total 50 years upto 2020 as per The Mines and Minerals (Development and Regulation) Amendment Ordinance, 2015 and transferred to M/s Laxmidas Ramji in the year 1989. However it is to

mention that the above mining lease of M/s Laxmidas Ramji was renewed by Mineral Resources Department, Govt. of M.P. for 20 years vide letter No. 3-31/2001/12/2 dated 16.01.2003 and accordingly lease agreement executed on 4.4.2003 for lease period upto 20.12.2020.

- (3) The PP has been carrying out the mining operations as per orders and directions of the respected controlling authorities under the MMDR (Mines and Minerals Regulation Development Act), the Rules framed there under as well as per MPPCB consent letters.
- (4) The M.P. Pollution Control Board has issued consent of the Air Pollution Act and Water Pollution Act. The aforesaid were renewed from time to time and finally they have applied for consent renewal in August 2016 and the renewal is granted for the period of 01.03.2017 to 28.02.2020 by the M.P. Pollution Board, Bhopal.
- (5) For old operative mines as the applicant case, as per EIA notification dated 14.09.2006 the environmental clearance is required if mine management will enhance production or increase lease hold area for any modernization in the working of the mine. It is also pertinent to point out that if the consent has been granted under the aforesaid Air and Water Pollution Act by the Pollution Board in that event Environmental Clearance is not required unless the Mine Management will enhance production or increase lease hold area of any modernization in the working of mine which is evident from the consent letter dated 05.11.2013 and valid upto 28.02.2015
- (6) The applicant did not enhance the production nor made any change in the lease hold area nor affected any modernization in their working and thus lessee did not apply for environmental clearance, since the applicant was under the bonafide belief that it has already been granted consent letters to operate the mine hence there was no necessity of Environmental Clearance. PP has submitted production details submitted by Collector Office, Katni to MPPCB in this support that there is no enhancement of production.
- (7) The PP very clearly stated that no environmental clearance was granted to it. And even after the aforesaid clarification made in the application form the applicant was granted consent letters to operate the mine by M.P. Pollution Control Board Bhopal. Under the circumstances the applicant had no doubt and firmly believed that when the consent letters have been issued from time to time under the Air and Water Pollution Act, environmental clearance is not required as per MoEF&CC notification S.O. 2601(E) dated 07th October 2014.
- (8) PP is regularly submitting annual compliance to the board & quarterly testing/monitoring report certified by MPPCB Regional office till September 2018 which clearly shows that there is no pollution above the prescribed limit in the area.
- (9) The Government of M.P. Ministry of Mining vide letter dated 04.09.2018 informed the applicant that it has a right to carry out mining after obtaining the permission from Indian Bureau of Mines and in accordance therewith to obtain EC or CTO (Consent letter). Believing on the same the applicant took permission from IBM and consent letters from MPPCB and continued mining.

- (15) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (16) It was noted that the water requirement is 10.0 KLD for dust suppression, plantation and drinking. Drinking Water will be sourced from nearby village. Besides this, rainwater will be collected in the working pit which will be used for dust suppression and plantation purpose.
- (17) The proposed plantation programme was examined and it was found that 22794 saplings shall be covered under plantation program.
- (18) It was also noted that the Public Hearing was carried out on 28.08.2019 at Mine Parisar at Village - Tikuri, Tehsil - Murwara, Dist. - Katni (MP) under the Chairmanship of District Collector, Katni.
- (19) The case was delisted in 615th SEIAA meeting dated 08-06-20. DGM has communicated vide letter No.12122-26/DGM/Steno/2020 dated 27.10.20 that mining lease period is valid till 29.12.20 as per MMRD Amendment Ordinance 2015. PP has represented the case vide letter dated 9.11.20 for considering the prior EC. The case has been relisted and PP called for clarification.
- (20) Hon'ble Supreme Court of India in WP No. 114 of 2014 Common Cause Vs Union of India and Others and WP No. 194 of 2014- Prafulla Samantra and Anr. Vs Union of India and Others has clarified in the conclusion on the issues of Mining without an EC or FC or both in its direction on 2nd August 2017 to avoid any misunderstanding, confusion or ambiguity, we make the following very clear:-

A mining project that has commenced prior to 27th January 1994 and has obtained a No Objection Certificate from the SPCB prior to that date is permitted to continue its mining operations without obtaining an EC from the

Impact Assessment Agency. However, this is subject to any expansion (including an increase in the lease area) or modernization activity after 27th January, 1994 which would result in an increase in the pollution load. In that event, a prior EC is required. However, if the pollution load is not expected to increase despite the proposed expansion (including an increase in the lease area) or modernization activity, a certificate to this effect is absolutely necessary from the SPCB, which would be reviewed by the Impact Assessment Agency.

The renewal of a mining lease after 27th January 1994 will require an EC even if there is no expansion or modernization activity or any increase in the pollution load.

- (21) Legal opinion from Mrs. Parul Bhadoria, Advocate has been taken in this matter as per above judgement of Supreme Court for considering prior EC. As per her legal opinion on co-joint reading of the representation dated 09.11.2020 filed by the Project Proponent, Judgment passed by Hon'ble Supreme Court in related matter and other documents provided to me, the following points are important to be noted:
 - i. Hon'ble Supreme Court of India in WP No. 114 of 2014 Common Cause Vs Union of India and Others has categorically held in para 186(ii) that: "The renewal of a mining lease after 27th January 1994 will require an EC even if there is no expansion or modernization activity or any increase in the pollution load"
 - ii. The above decision of the Hon'ble Supreme Court is directly related to the issue in hand and shall be considered while deciding the EC application filed by the project proponent.

In view of the above mentioned judgment, Advocate has considered opinion that the representation filed by the project proponent with the prayer that there is no requirement to obtain EC till the date of lease period i.e. 20.12.2020, cannot be accepted. Since, the lease in question has been renewed, the project proponent is required to obtain Environmental Clearance and SEIAA may consider the application filed by the project proponent for obtaining Environmental Clearance.

After detailed discussions of the matter on above legal opinion and perusal of recommendations of 412th meeting dated 09.12.2019, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-
