- (1) The case was recommended for EC in 502nd SEAC meeting dated. 06.07.2021.
- (2) PP/Consultant made a presentation of the project and all concerned issues were discussed in details.
- (3) This is a project pertaining to mining of **Stone Quarry** in mining lease area of 4.50 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be located at a distance of more than 10 km from National Park /Sanctuary etc. Therefore it is not attracted by the general conditions by virtue of its location and mining lease area. There is no forest boundary within 250 m distance from the ML area as per DFO Bhopal vide letter no. 5826 dated 19.12.2018. It was noted that as per office of the Collector (Mining Division), Bhopal vide letter No. 292 dated 28-01-2021 the lease validity for the said mine is 10 years. The

office of the Collector (Mining Division), Bhopal vide letter no. 5090 dated: 12/11/2020 has reported that there are 06 more mines operating or proposed within 500 meters around the said mine with total area of 18.37 ha., including this mine. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project.


- (4) The mining lease was granted to M/s Shri Balaji Infra Buildcon, Partner, Shri Akshay Bansal, House No. A-1, Panchwati Colony, Dist. Bhopal for 10 years. The Mining Plan with progressive mine closure plan has been approved by Director, Geology & Mining, Bhopal vide Letter No. – 4094-95/Mining Plan Cell-6/न.क्र- 120/2018 Bhopal dated 07.03.2019.
- (5) It was noted that the water requirement is 5 KLD (1.0 KLD for Domestic use/ Drinking + 2.5 KLD for Dust suppression + 1.5 KLD for Green Belt). The water requirement will be met from hired tankers.
- (6) Public Hearing was held on 15.04.2021 at mine site at Village - Barkheda Bondar, Tehsil - Huzur, Dist. - Bhopal (MP) under the Chairmanship of Additional Collector, Bhopal.

After detailed discussions and perusal of recommendations of 502nd SEAC meeting dtd. 06.07.2021, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:-


- I. Before commencing mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of cautionary signage at 4 corners of lease area to avoid any untoward incident involving public and animals.
- II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- III. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three rows plantation shall be carried out in the greenbelt area in the current year with proper watering arrangement.
- IV. PP shall plant 5500 saplings of at least three years old, for the next five years of suitable tree species like Sisham, Neem, Pipal, Sissoo, Bargad, Aonla, Mango, Kathal, Khamer, Katang Bamboo, Imili, Bel, Kaitha, Amla, Harra, Bahera, Nimbu etc. along the barrier zone, approach road, non mining area of lease area, Govt. Primary school of Barkheda Bondar village under "Ankur scheme" of Govt. of M.P. in consultation with appropriate authority.






- V. The mining operation shall be restricted to above ground water table. In case of working below the ground water table, approval of the Central Ground Water Board shall be obtained.
- VI. PP shall ensure installation of cautionary signages on transportation routes for avoidance of accidents.
- VII. PP shall ensure minimum three rows dense plantation towards the police academy and towards prominent wind direction.
- VIII. Proper landscape planning should be done along with its sincere implementation.
- IX. PP shall ensure to get the details incorporated as per sanctioned lease/EC in the DSR approved by the Directorate of Geology & Mining, Govt. of MP, failing which this EC shall be revoked.
- X. The overburden and waste will be stacked within the mining lease area and should be simultaneously backfilled in the mined out area for plantation.
- XI. No overburden will be dumped outside the mining lease area.
- XII. PP shall ensure the generation of employment opportunities in nearby Village on priority basis.
- XIII. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XIV. Mining shall be limited to the area as shown in surface plan and as per the approved mining plan.
- XV. PP shall ensure proper watering arrangements for plantations especially in the summer season.
- XVI. PP shall ensure proper implementation of plantation, dust suppression, construction of approach roads and maintenance of existing pakka road as per approved Environmental Management Plan. Adequate budget provision shall be made as part of EMP.
- XVII. PP must ensure the implementation and compliance of the commitment made in Public Hearing in addition to following activities with separate budget provisions under CER :
 - ❖ To provide 2000L overhead tank with proper water channelization system.



- ❖ Construction of boundary wall (35m x 2m height) of Govt. Primary School at village Barkheda Bondar.
- ❖ Distribution of Mask & Hand Sanitizer for villagers of Gram Panchayat, Barkheda Bondar
- ❖ Development of grazing land



The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Gram Panchayat.

- XVIII. PP should ensure to submit half yearly compliance report, Plantation and CER activity report along with photographs of all activities in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per SEIAA Office Memorandum No. 930/SEIAA/2019 dated 30.05.2019.

- i. Revised detailed plantation plan in consultation with Forest Department along with implementation programme.
 - ii. Revised detailed CSR activities identifying the local need of village in consultation with Gram Panchayat.
8. **Case No. – 7797/2020** Prior Environment Clearance for Stone Quarry in an area of 1.50 ha. for production capacity of 31920 cum per annum at Khasra No. 8/11, 8/12 at Village - Harraha, Tehsil - Mauganj, Dist. Rewa, (MP) by M/s Adaypur Supplier and Contractor, Prop., Shri Deependra Singh, R/o Adaypur, Tehsil - Churhat, Dist. Sidhi, MP.

The case was discussed in 502nd SEAC meeting dtd. 06.07.2021 it was recorded that

The case file was placed for discussion wherein it was observed that this case was already recommended for grant of EC in the SEAC 463rd meeting dated 01.10.2020.

Later on this case was scheduled in 643rd, 646th and 647th SEIAA meeting where PP remains absent and hence the case was delisted by SEAA. During scrutiny, it was observed that SEAC has already recommended this case and it appears that by mistake file is sent back to SEAC by SEIAA. Hence this case file may be sent to SEIAA for onward necessary action.

As per the recommendation of SEAC 463rd meeting PP has presented the case in SEIAA Meeting dtd 03.08.2021. During presentation PP has submitted a letter No 5248/ Mine/ 2020 dtd 17.11.2020 by the office of Collector (Mining) Division, Distt. Rewa regarding other sanctioned & operating mines exists within the 500 m periphery of the proposed mine, which is different from the earlier letter of Collector (Mining) Division, Distt. Rewa letter No 3397/ Mine/2020 dtd 18.09.2020.


In context of above, it is decided to send a letter to Collector, Rewa to constitute a team of Mining Officer & Revenue Officer for site inspection to assess the present clustering status of the mine site in view of the above discrepancy and appraisal of status of cluster of other sanctioned & operating mines within the 500 m periphery of the proposed mine and submit a report to MPSEIAA within 15 days. Copy to PP.

9. **Case No 8557/2021** Prior Environmental Clearance for Quartz Deposit in an area of 6.605 ha. for production capacity of 81,741 Tonne per annum at Khasra No. 4 - Part, 94 - Part, 95 – Part at Village - Umaria, Tehsil - Dheemarkheda, Dist. Katni (MP) by Shri Uma Shankar Mishra, 765, Napier Town, Anand Cinema Road, Dist. Jabalpur, MP – 482001.



Minutes of the 680th Meeting of SEIAA dated 03.08.2021

10. Case No. 79/2008 Prior Environment Clearance for Badari lime stonemine 5.82 ha. village- Badari Vijayraghgarh, Distt. Katni (MP) by M/S ACC Limited, Kymore Cement Works, Kymore District –Katni (MP).

The case was discussed in 653rd SEIAA meeting dated 08.01.2021 and it was recorded that

This case was discussed in 645 SEIAA meeting dated 28.11.2020 and it was recorded that.....

The agreement of lease transfer has been executed on 23.12.2008 to M/s ACC Limited while Prior EC was accorded by SEIAA to M/s S.N. Sunderson & Co. for above Badari Lime Stone Mine of 5.82 ha. vide letter No. 372/EPCO-SEIAA/09 dated 25.03.2009. Later on M/s ACC Ltd. has applied in SEIAA on 08.01.2018 for transfer of EC from M/s S.N. Sunderson & Co. to M/s ACC Ltd., Kymore. In response to this, Prior EC was transferred by SEIAA to M/s ACC Ltd., Kymore vide letter No. 1742/SEIAA/2018 dated 23.02.2018.


MOEF&CC, Gol, letter No. 18-B-30/2019(SEAC) 672 dated 14.06.2019 informed that Air & Water Consent was issued in the name of M/s S.N. Sunderson & Co. in the year 2009 and M/s ACC Ltd. have been carrying out mining activities without valid Prior EC from 2009 to 23.02.2018 and even company has failed to submit half yearly compliance report on regular basis. M/s ACC Ltd. has submitted compliance report for period from Dec.2018 to May 2019 only vide letter dated 31.5.19.


In response to public complaint received from Shri Ramesh Sharma vide letter dated 19.09.20, MoEF&CC, Gol vide letter No. 18-B-30/2019(SEAC)/969 dated 02.11.2020 has communicated that Central Govt. vide Gazette Notification No. S.O. 637(E) dated 28.02.2014 has delegated power vested under Section 5 of E(P) Act, 1986 to the SEIAA to issue showcause notice to PP in case of violation of the conditions of the EC issued by the authority to project under the jurisdiction and to issue direction to the said PP for keeping such EC in abeyance or withdrawing them if required.


In view of above, it has been observed that ACC has not submitted six monthly compliance report on regular basis to MoEF&CC, Gol /SEIAA as per EC conditions hence why not your EC is kept in abeyance or withdrawn by authority as per provision under MoEF&CC, Gol Notification dated 28.02.2014 with immediate effect as it is clear cut matter of violation of Prior EC. In light of above, you are hereby directed to clarify the above issues to justify your stand within 15 days from the date of issue of letter and present your case with clarification/justification in upcoming SEIAA meeting otherwise necessary action will be initiated accordingly. Copy to Project Proponent and MoEF&CC, Gol.

In response to above query, PP has submitted reply vide letter No. KY/ENV/MPPCB/Bhopal dated 24.12.2020. After discussion, it was decided to call PP for presentation and clarification.

- PP vide letter no. KY/ENV/MPPCB/Bhopal/331 dated 05.03.2021 requested to present the case before SEIAA.
- After that, the case was presented by PP and clarified the issues related to grant and transfer of EC, submission of Compliance report, execution of mining operation without EC obtaining from SEIAA. During the presentation it

is observed that they have total lease area of more than 1000 ha and they have purchased the land of 5.82 ha. from M/s S.N. Sunderson & Co. since it was between the land of the company.


- It is noted that the lease area 5.82 ha of the subject Badari mine was reduced to 5.76 ha after Bandobast.
- It is noted that the ACC Limited approached to MPPCB for change of ownership in EC and Air & Water consents vide letter dated 29.08.2011 and 19.10.2011.
- In this case the Prior EC was issued to M/s S.N. Sunderson & Co. on 25.03.2009 and EC was transferred in the name of M/s ACC Limited on 23.02.2018. The half yearly compliance reports from 25.03.2009 to 23.02.2018 not submitted by PP and it is clear cut violation of EIA Notification 2006.

After detailed discussion, it appears that this is a case of EC violation. It is decided that, the EC issued to the PP is immediately kept in abeyance and action should be taken as per the provisions provided in EIA Notification regarding violation of EC. The PP should be informed accordingly and suitable reference also be made to Regional Officer, MoEF&CC.


