The case was considered in 740 SEIAA meeting dtd. 30.07.2022 and recorded that:-

“PP should deposit the bank guarantee (BG) with three years validity of Rs. 268.29 Lakhs (equivalent to amount proposed for Remediation Plan /Restoration Plan) with the MP Pollution control Board, Penalty of Rs. 32.133 lakh @ 1% of the total project cost incurred upto the date of filing of application i.e. as per clause 12 a(i) of MoEF&CC Notification dated 08/03/2018 and OM dated 07/07/21 and proof of credible action initiated by MPPCB under section 15 read with section 19 of the Environmental (Protection) Act, 1986 as per clause 11, step 2 of MoEF&CC OM dated 07/07/21.

EC letter may be issued by SEIAA after submission of Bank Guarantee, penalty amount and proof of the credible action received from the MPPCB.”
