
*"This case was discussed in 462<sup>nd</sup> SEAC meeting dated 30.09.2020 and it was recorded that....."*

In view of above decision, the case is hereby relisted and the above cases alongwith the technical file is being sent for appraisal and you are requested to take the considered view on it.


