**Sub:- Prior Environmental Clearance for Lime stone mine 10.56 ha. capacity 15000 MTPA at Village- Bhatoora, Teh- Maihar, Sata M.P. Case no. 253/2008**

This has reference to your application dated 14/12/08 seeking prior environmental clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of the provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., Form 1 and misc. papers pertaining to permission of mining plan furnished to the State Expert Appraisal Committee.

It is interalia, noted that the project involves mining of Lime stone, area 10.56 ha. capacity 15000 MTPA at Village- Bhatoora, Teh- Maihar, Sata M.P.

The Expert Committee after due consideration of the relevant documents submitted by the project proponent has recommended your case for environmental clearance, as per the provisions of Environmental Impact Assessment Notification, 2006 and its subsequent amendments. SEIAA considered your case in the 30<sup>th</sup> meeting held on 9<sup>th</sup> March, 2010 and took the following decision:-

“The above case was recommended by SEAC for prior environmental clearance. SEIAA while scrutinizing the documents submitted by the project proponent observed that the Forest Deptt. NOC submitted by the project proponent specifies that the mining area is located at a distance of 190 m from the forest boundary. The proponent has not submitting a fresh Forest Deptt. NOC issued by the competent Authority in such type of case. Hence the Authority decided to reject your case”.

Therefore your proposal has been rejected.
