

Minutes of the 26th SEIAA Meeting held on 16th December, 2009

The 26th meeting of the State Level Environment Impact Assessment Authority was convened on 16th December, 2009 at 11.30 A M at the Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji, Chairman SEIAA.

(A) Cases received from the District Collector after his opinion regarding public hearing

1. M/s Seonitola Dolomite & Soap stone mine, Ram Kishen Asawa, B/61, Ratan nagar, Jabalpur M.P., Mining lease area 8.094 ha. Distt. Jabalpur - M.P. **Case no.30/2008.**

This case was recommended by SEAC for grant of prior environmental clearance. But it was decided by SEIAA to send it to the District Collector for his opinion and for the comments of the project proponent on the objections raised during public hearing. Same have been received.

Meanwhile a complaint was received by the Authority from Shri Sushil Choubey stating that the proposed mining lease area now comes under orange area and no mining activity can be permitted by the Forest Deptt.

Hence it is decided that the matter be referred to DFO for verification of the current status of the mining lease area. The decision is deferred.

2. Shri Harinarayan Lalchand Somani, 241, Pratapganj Road, Alirajpur- P O, Jhabua M.P., Panwani Dolomite mine 8.093 hact., Village-Panwani, Teh-Alirajpur, Distt.Jhabua M.P, **Case no. 123/2008.**

This case was recommended by SEAC for prior environmental clearance. But it was decided in 20th SEIAA meeting to send it to the District Collector for his opinion and for the comments of the project proponent on the objections raised during public hearing.

Same have now been received and the office of Collector (Mining Branch) has also recommended that the prior environmental clearance be issued. Hence it was decided in the meeting to accord prior environmental clearance to the above project.

3. Shri R S Gupta, 97, Chandrashekar Azad marg, Alirajpur- P O, Jhabua M.P. Dolomite mine 8.069 ha. at village Kund Teh- Alirajpur – P O, Distt-Jhabua M.P. **Case no. 216/2008.**

4. Shri Shashikant Joshi, B-28, Mahatma Gandhi marg, Alirajpur- P O, Jhabua M.P., Dolomite mine 9.61 ha.2500 TPA at Vill-Bari, Teh-Alirajpur, Distt-Jhabua M.P. **Case no. 135/2008.**

This case was recommended by SEAC for prior environmental clearance. But it was decided in 20th SEIAA meeting to send it to the District Collector for his opinion and for the comments of the project proponent on the objections raised during public hearing.

Same have now been received and the office of Collector (Mining Branch) has also recommended that the prior environmental clearance be issued. Hence it was decided in the meeting to accord prior environmental clearance to the above project.

5. M/s Sawaliya minerals industries, Shri Om Prakash Gupta,110, Alirajpur, Jhabua M.P., Dolomite mine 5.0 ha. 8500 TPA at Kharkhari Teh- Alirajpur, Distt-Jhabua M.P, **Case no. 177/2008.**

This case was recommended by SEAC for prior environmental clearance. But it was decided in 20th SEIAA meeting to send it to the District Collector for his opinion and for the comments of the project proponent on the objections raised during public hearing.

Same have now been received and the office of Collector (Mining Branch) has also recommended that the prior environmental clearance be issued. Hence it was decided in the meeting to accord prior environmental clearance to the above project.

(B) Hospital project to be considered after the meeting with Director General, Health Services, New Delhi

1. Rajmate Vijaya Raje Sindhiya, AIIMS at Bhopal, (Construction) **Case no.110/2008**

The above case was recommended by SEAC and SEIAA also accorded in principle clearance to the projects in its 12th meeting. It was decided that environmental clearance will be issued only after getting a building permission from Bhopal Municipal Corporation and study the various directives issued for the safe disposal of the bio medical waste. It was decided in the 25th meeting of the SEIAA that the Director General Health Services will be approached for the same.

Accordingly a meeting was held on 11th December'09 with Dr. R.K. Shrivastava, Director General health Services, Govt. of India, New Delhi. He informed the Authority that the disposal of the bio-medical waste should be carried out as per the Bio-medical Waste (Management and Handling) Rules 1988 and its subsequent amendments of 2003 issued by Ministry of Environment and Forest, Govt.of India. He also informed that the proposed AIIMS project at Bhopal authorities have made provisions for all required equipments for the safe disposal of bio-medical waste to be generated during its operation phase.

Shri Pankaj Singh, Project Engineer, AIIMS. During the 26th SEIAA meeting apprised the Authority about the various provisions envisaged in the project for the safe disposal of the bio-medical waste. He explained various green building aspects incorporated in the project design. Further, a presentation on "Bio-medical waste management for environmental clearance of proposed AIIMS, hospital at Bhopal, Madhya Pradesh" was also given to the Authority.

Authority took a final view on the project during the meeting and decided to issue prior environmental clearance to the above project.

2. M/s H K Kalchuri Education Trust 31, Shamla Hills, Bhopal-M.P. , Construction of Hospital complex at Kolar Road, Bhopal-M.P. **Case no. 217/2008**

The project was recommended by SEAC for prior environmental clearance. But it was deferred for want of the various directives issued for the safe disposal of bio-medical waste.

After the clarification from Director General Health Services referred to in the case above (**Case no.110/2008**) it was decided by the Authority to accept the recommendations of SEAC and decided to accord prior environmental clearance.
