

Minutes of the 28th SEIAA Meeting held on 14th January, 2010

The 28th meeting of the State Level Environment Impact Assessment Authority was convened on 14th January, 2010 at 11.30 A. M. at the Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji, Chairman SEIAA.

(A) Cases recommended by SEAC for Environmental Clearance

1. Shankar Lal Vishwakarma, Jalpadevi ward, Gautam Mohalla, Katni M.P., Bauxite laterite & Fire Clay mines in 27.02 ha. (17.33 + 9.69 new) at village Tikariya, Teh. Murwara Distt. Katni - M.P. **Case No.38/2008**

The above case was recommended for prior environmental clearance by SEAC.

The Authority while scrutinizing the documents found that the NOC submitted by the Forest Deptt. are not issued by the competent Authority for the complete mining lease area.

Hence it was decided to send the case back to SEAC for reconsideration. Project proponent should be asked to furnish a fresh NOC indicating distance of mining lease areas from forest boundary and from protected area notified under the Wild Life (Protection) Act 1972.

2. Anand mining corporation, Pathak ward, Katni- M.P., Pratappur Iron ore mine 11.578 ha. at Village Pratappur Talluka- Sihora, Jabalpur-M.P. **Case No.105/2008**
3. M/s Jai Bhawani Minerals, Shi Ashwani Gautam, B-6, New ACC Colony, Katni M.P., Tihari Laterite & fireclay deposit mine 7.37 ha. Teh-Bahoriband, Distt-Katni M.P **Case No.125/2008**
4. Shri Sharda Prasad Jaiswal C/o Kawsji ward, Vivekanand chowk, Katni M.P. Bauxite, Laterite & fireclay mine 5.901 Hact. Village- Mohla Teh- Sihora, Distt-Jabalpur-M.P. **Case No.190/2008**

5. S N Sunderson Co., 1-Deshbandhu Gupta Road, Post Box No5713 New Delhi. Badari limestone & Dolomite 5.04 hect. at village –Badari Teh-Vijayraghgarh Distt-Katni- M.P. **Case No.196/2008.**
6. Smt Vandana Modi, W/o Shri Abhay Modi, Bara Bazar, Shahgarh, Teh-Banda-Sagar M.P., Iron ore & dolomite mines 11.82 ha. At Tigoda, Banda Sagar M.P. **Case No.236/2008.**
7. Shri Jagdish Dhaneria, 119/1 Kumawatpura, Juni-Indore M.P., Bauxite laterite ochre & clay deposit, 9.71 hect. at village Chitti, Jagir, Teh-Sirmour, Distt-Rewa-M.P. **Case No.255/2009**

In all the above cases mentioned at Sr.no. 2 to 7 recommended by SEAC for prior environmental clearance, the Forest Deptt. NOCs submitted are either quite old or do not contain the Khasra nos. along with their partition and also do not specify the distance of mining lease area from the protected area notified under the Wild Life (Protection) Act of 1972.

Hence it was decided that in all the above six cases the Authority will write to the concerned DFO for the fresh NOC specifying the above details. Till then the decision in these case shall be deferred.

8. Bhanu Prakash Power Projects Pvt Ltd, Hyderabad 10 mw Biomass based power plant 15 H, village Majhguan, Teh- Garhakota, Sagar- M.P. **Case No 35/2008**

The above case was recommended by SEAC for the prior environmental clearance.

AS per the latest amendment issued vide S.O 3067 (E) dt 1/12/2009 the Power Plants up to 15 MW based on biomass and using auxiliary fuel such as coal/lignite/petroleum products upto 15% are exempted.

It was decided in the meeting that the project proponent should be asked to furnish a declaration regarding the type and quantum of auxiliary fuel proposed to be used in the above project before arriving at a final decision.
